

1. STRUCTURE AND FUNCTIONS OF BALLINA SHIRE COUNCIL

Ballina Shire Council is a duly constituted body under the Australian Constitution Act 1902, the Local Government Act 1993 and associated acts. This legislation provides the legal framework for an effective, efficient, environmentally responsible and open system of local government.

Our Council Representatives

The Ballina Shire Local Government Area is divided into three Wards, represented by ten elected councillors, being three from each Ward plus a popularly elected Mayor. The elected Council is responsible for the direction and control of Council's affairs in accordance with the NSW Local Government Act and associated legislation.

Councillors represent the interests of our residents and ratepayers. They serve the community by listening to people and then representing those views on Council. They work together to make decisions about what the Council will do to meet community needs and how money should be spent in the best interests of the community as a whole. They provide leadership and guidance to the community; and facilitate communication between the community while maintaining the broader vision, needs and aspirations of the whole Ballina Shire community. Councillors do not get involved in the day to day running of the Council. This is the role of the General Manager.

Role of a Councillor

The role of a Councillor is, as an elected person:

- a. to be an active and contributing member of the governing body of Council
- b. to make considered and well informed decisions as a member of the governing body
- c. to participate in the development of the integrated planning and reporting framework
- d. to represent the collective interests of residents, ratepayers and the local community
- e. to facilitate communication between the local community and the governing body
- to uphold and represent accurately the policies and decisions of the governing body
- g. to make all reasonable efforts to acquire and maintain the skills necessary to perform the role of a Councillor.

Role of the Mayor

The role of the Mayor is as follows:

- a. to be the leader of Council and a leader in the local community
- b. to advance community cohesion and promote civic awareness
- c. to be the principal member and spokesperson of the governing body, including representing the views of Council as to its local priorities
- d. to exercise, in cases of necessity, the policymaking functions of the governing body of Council between meetings of Council

- e. to preside at meetings of Council
- to ensure that meetings of Council are conducted efficiently, effectively and in accordance with this Act
- g. to ensure the timely development and adoption of the strategic plans, programs and policies of Council
- h. to promote the effective and consistent implementation of the strategic plans, programs and policies of Council
- i. to promote partnerships between Council and key stakeholders
- to advise, consult with and provide strategic direction to the General Manager in relation to the implementation of the strategic plans and policies of Council
- in conjunction with the General Manager, to ensure adequate opportunities and mechanisms for engagement between Council and the local community
- to carry out the civic and ceremonial functions of the mayoral office
- m. to represent Council on regional organisations and at inter-governmental forums at regional, State and Commonwealth level in consultation with the councillors, to lead performance appraisals of the General Manager
- n. to exercise any other functions of Council that determines.





Role of the General Manager

The Principal Officer of the Council is the General Manager. The General Manager attending to the following functions:-

- a. to conduct the day-to-day management of Council in accordance with the strategic plans, programs, strategies and policies of Council
- b. to implement, without undue delay, lawful decisions of Council
- c. to advise the Mayor and the governing body on the development and implementation of the strategic plans, programs, strategies and policies of Council
- d. to advise the Mayor and the governing body on the appropriate form of community consultation on the strategic plans, programs, strategies and policies of Council and other matters related to Council
- e. to prepare, in consultation with the Mayor and the governing body, Council's integrated planning and reporting documents
- f. to ensure that the Mayor and other councillors are given timely information and advice and the administrative and professional support necessary to effectively discharge their functions
- g. to exercise any of the functions of Council that are delegated by Council to the General Manager
- h. to appoint staff in accordance with the organisation structure determined under this Chapter and the resources approved by Council
- i. to direct and dismiss staff
- j. to implement Council's workforce management strategy
- k. any other functions that are conferred or imposed on the General Manager by or under the Local Government Act 1993 or any other Act.

2. IMPACT OF COUNCIL FUNCTIONS ON THE PUBLIC

As a service organisation, the majority of the activities of Ballina Shire Council have an impact on the public. The following is an outline of how the broad functions of Council affect the public.

2.1 Service Functions

Service functions affect the public as Council provides services and facilities to the public. These include provision of human services such libraries, airport, art gallery, community halls and centres, surf clubs, swimming pools, recreation facilities, sporting fields, parks and gardens, infrastructure and the removal of garbage.



2.2 Regulatory Functions

Regulatory functions involve application of controls and requirements on developments, buildings and activities to ensure that they meet certain outcomes. These requirements relate to a range of matters including amenity, safety and public interest. Members of the public must be aware of, and comply with, applicable requirements and regulations.



2.3 Ancillary Functions

Ancillary functions affect only some members of the public. These functions include, for example, the resumption of land or the power for Council to enter onto a person's land. In these circumstances, only the owner of the property would be affected.



2.4 Revenue Functions

Revenue functions affect the public directly in that revenue from rates and other charges paid by the public is used to fund services and facilities provided to the community.



2.5 Administrative Functions

Administrative functions do not necessarily affect the public directly but have an indirect impact on the community through the efficiency and effectiveness of the service provided.

2.6 Enforcement Functions

Enforcement functions only affect those members of the public who are in breach of certain legislation relating to purposes such as:

- building and planning
- public health
- · swimming pool compliance
- onsite sewage management
- trade waste
- Newlog heavy truck loads on the road network
- non-payment of rates and charges.

Specifically Council's Rangers patrol public land and facilities to monitor and regulate:

- illegal camping
- beach use
- littering and illegal waste dumping
- public signage enforcement
- parking
- movement of people from prohibited areas
- companion animals.

2.7 Community Planning and Development Functions

Community planning and development functions affect areas such as cultural development, social planning and community profile and involves:

- Advocating and planning for the needs of our community.
 This includes seeking or initiating partnerships; participating on regional, State or Commonwealth working parties; and preparation and implementation of the Community Strategic Plan.
- Providing donations to local community groups through the Community Donations and Capital Assistance for Sporting Groups programs.
- Facilitating opportunities for people to participate in the life
 of the community through the support of community events
 through Festivals and Events Sponsorship Program. The
 delivery of community events such as the Australia Day
 Ceremony, NAIDOC Week, Volunteers Week as well as
 promoting community events.

COUNCIL MEETINGS

Council's Ordinary meeting is held in Council's Customer Service Centre, situated at 40 Cherry Street, Ballina on the fourth Thursday of each month (February to November) and the second Thursday in December commencing at 9.00 am. There is no January Ordinary meeting. Committee meetings are held on an as-required basis.

You have the opportunity to participate in the Council Meetings by:

- view council meetings via the livestream on Council's website.
- making a deputation on an agenda item. Deputations are allocated five minutes to address Council and are limited to one speaker in the affirmative and one in the negative for each agenda item. Deputations can also be made online. Deputation requests must be

- lodged with the General Manager by noon on the day preceding the meeting. Deputations are held at 9am.
- asking questions during Public Question Time. This
 session is conducted at 12.45pm on the day of
 Council's Ordinary meetings. This is a 15-minute
 session for members of the public to ask a question
 on any topic.



PUBLIC PARTICIPATION (CONT)

There are also avenues for members of the public to personally participate in the policy development and the functions of the Council. Several reference groups and committees comprise or include members of the public.

Standing Committees

Council has three Standing Committees, as follows:

Commercial Services Committee

Introduces, evaluates and reviews the commercial dealings and operations of Council with the aim of any commercial activity being the provision of supplementary revenue streams that assist Council in the delivery of services to the community.

Finance and Facilities Committee

Considers financial matters of a strategic nature including Council's annual budget deliberations and to provide strategic input into the facilitation and construction of major community facilities.

Environmental and Sustainability Committee

Considers matters of a strategic planning nature, such as local environmental plan.

The Committees listed above have no delegated authority and minutes are submitted to Council for confirmation.

Other Groups

Council also has a range of Advisory Committees that include members of our community to assist in providing feedback to Council:

Australia Day Committee

Determines award recipients for Australia Day.

Donations Working Party

Considers applications for donations and makes recommendations to Council.

Economic Activiation Group

This group shares and promotes ideas and strategies that support long term economic sustainability, increased diversity of activities, and actions that increase activities that optimise the benefits from the infrastructure and businesses located in the Ballina Shire.

Public Art Advisory Panel

Provides guidance on the implementation of Council's Public Art Policy.

Local Traffic Committee

This Committee is a requirement of Council's statutory obligations as delegated by the Transport for NSW in respect to the Roads Act 1993. The role of the Committee is to consider the technical aspects of any proposal and make a recommendation to the Council. The public perspective is the responsibility of the Council and thus residents' views should be considered by Council rather than the Local Traffic Committee.

Waterways Advisory Group (formerly Port Ballina Taskforce)

Consists of the Mayor and two councillors, two community representatives, and representatives from Transport for NSW – Maritime, Department of Planning, Industry and Environment – Fisheries, Department of Planning, Industry and Environment – Crown Lands, Ballina Fishermen's Co-operative, Ozfish Unlimited and Ballina Environment Society. The primary objective is to pursue the restoration of the waterways within the Ballina Shire to a healthy state, while supporting social and economic benefits that a healthy and diverse waterway system can bring to our community.

Audit, Risk and Improvement Committee

The Committee consists of two councillors (non-voting) and four independent members, one of which is Chair of the Committee. The Committee provides information to Council for the purpose of improving the Council's performance of its functions. The Committee aims to keep under review Council operations, such as compliance, risk management, fraud control, financial management and governance. The Committee also reviews the implementation of the strategic plan, delivery program and strategies including service reviews, collection of performance measurement data by council and any other matters prescribed by the regulations.

Reference Group

Access Reference Group

This group identifies the major access needs of different disability groups in the Ballina Shire and makes recommendations to Council to resolve identified issues in priority order.

A, B and C Ward Committees

Council's area is divided into three Wards. Each Ward is represented by its own Ward Committee. The Ward Committees are designed to provide Council with feedback and policy advice on matters referred by Council and/or raised by members on behalf of their community. They are made up of one representative each from not for profit community organisations and councillors from the particular Ward. The Ward

Committees have no delegated authority and minutes are distributed to members for confirmation at the next meeting.

Council reviews the membership of Ward Committees after each Local Government Election. At the January 2022 Ordinary meeting, Council resolved to retain the existing structure and membership of the three Ward Committees with expressions of interest called for any additional membership. When Council receives further applications, these are reported to Council for determination.

Where a formal application under the GIPA Act is made, application, processing and advanced deposit charges as specified in the Act will apply. Formal applications require an application fee of \$30, and \$30 per hour processing fees. Processing fees may be waived or discounted in certain circumstances.

COMMUNITY PRIORITIES AND SATISFACTION SURVEYS

In 2018 Council engaged a research company (Micromex Research) to undertake a satisfaction survey which involved a sample of approximately 300 applicants who had submitted a planning application to Council in recent years.
