6.1 HMAS Labuan Ballina Port Visit and Freedom of Entry March

Introduction

Council has received a request to hold a Freedom of Entry March down River Street Ballina for the HMAS Labuan Ballina Port visit.

Information

HMAS *Labuan* is scheduled to visit Ballina, her adoptive town, from Friday 1 August to Wednesday 6 August 2014. It is 41 years since commissioning of *Labuan* and six years since her last visit to Ballina. This will be the last opportunity for *Labuan* to connect with the Ballina community before finally paying-off in November 2014.

Council would like to facilitate a Freedom of Entry march through Ballina on Saturday 2 August 2014.

The crew will parade in their dress uniforms, bearing arms and drawn swords, to be stopped and challenged by the Mayor. There will be an exchange of speeches and gifts, and an opportunity for the sailors to mix with the community.

The scheduled date for the march is Saturday 2 August 2014. The proposed traffic control plan is attached to this report.

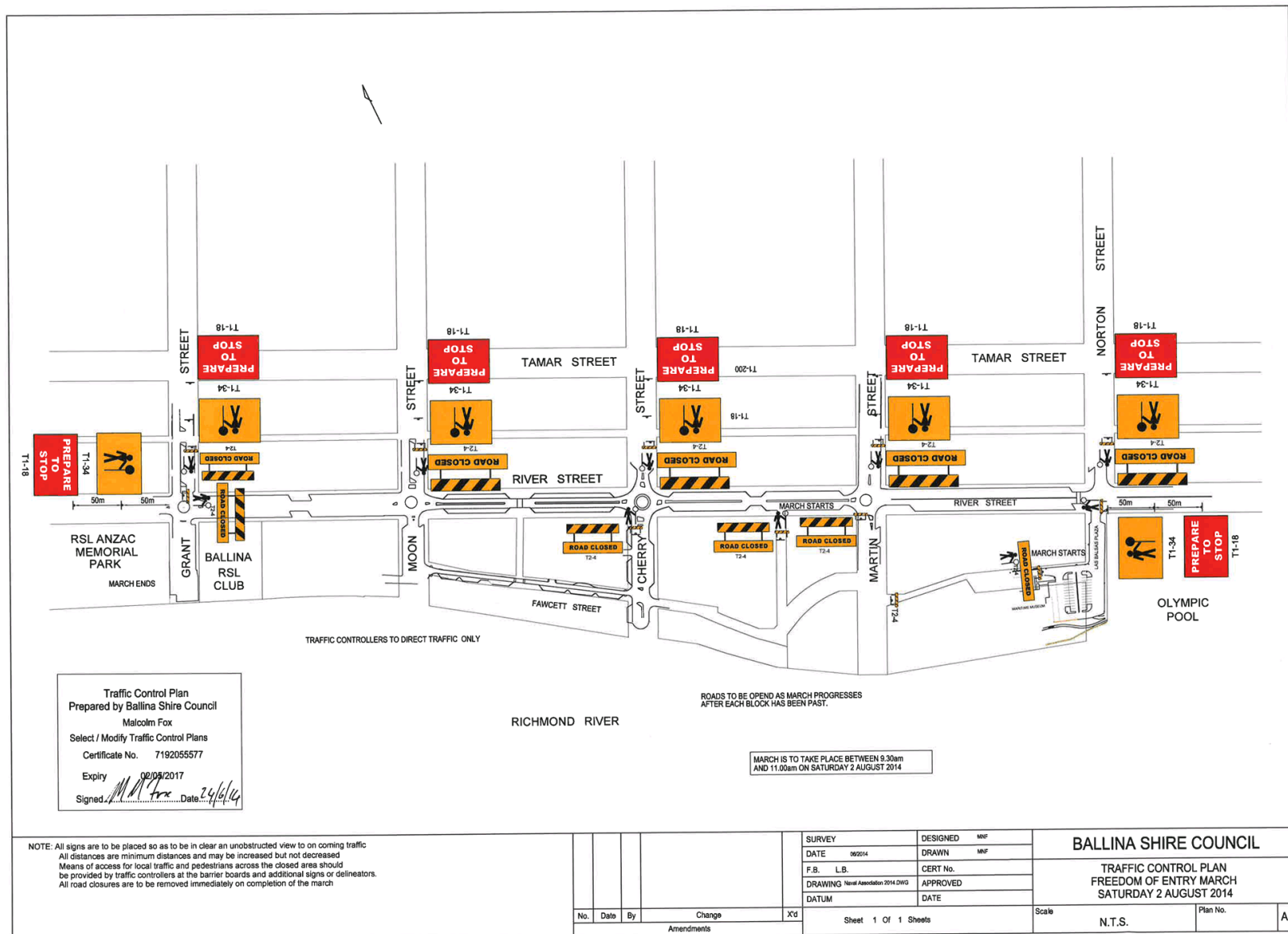
RECOMMENDATIONS
