**4.1 Cumalum Precinct A Development Control Plan Provisions and Developer Contributions Plan**

**RECOMMENDATION**

1. That the draft development control plan amendment for “Cumalum Views” (DCP Amendment No.4) be placed on public exhibition, in accordance with the requirements of the *Environmental Planning and Assessment Act 1979*.
2. That the draft developer contributions plan for “Cumalum Views”, amended to delete land acquisition for local parks and land acquisition and construction of certain roads as outlined in the Council report, be placed on public exhibition, in accordance with the requirements of the *Environmental Planning and Assessment Act 1979*.
3. That Council receive a further report addressing the exhibition and submissions received following the conclusion of the public exhibition period.
4. That the development control plan be amended, prior to public exhibition, to require the future developer of the land to provide a site for a child care facility. The site is to comprise a minimum area of 2,500 m<sup>2</sup> and be located within 200 metres of the central district park.
