## (a) Malcolm Johnson – Coastal Recreational Pathway at Flat Rock


Malcolm Johnson spoke to the proposed alternative location of the coastal recreational pathway at Flat Rock Tent Park as per Cr Worth's motion submitted to the August 2014 Ordinary meeting of Council. Mr Johnson presented a document to outline his position on the alternative alignment. A copy of the document is attached.

Following invitation from the Chair, Andrew Smith provided clarification of the approved alignment and that the Council resolution at its last Ordinary meeting was to investigate the alternate alignment. No approval has been sought for the alternate alignment.

Cr Worth outlined his rationale for putting forward the alternate path alignment.

Cr Smith outlined that a process of investigation of the suitability of the alternate alignment is to occur. After this investigation, then the Council will consider its options.

# (b) Lois Wright – Alstonville Community Preschool Development Application

Cr Wright advised of the need to obtain a 'warrant' and to show a demonstrated need.

Cr Smith advised that a request is to be made to the Local Traffic Committee.

### (d) Pat Carney - Blackwall Bugle

Pat Carney enquired as to why it is so expensive (\$30,000) to produce the Blackwall Bugle (now only available on line). He advised a local company can produce it more cheaply.

Crs Worth and Smith explained why and asked what would be the minimum number of hard copies to be printed for those local residents who have difficulty viewing on line?

Pat Carney suggested maybe 100.

Cr Smith mentioned that a small number of copies to be printed may be able to be funded.
