I am writing regarding applications under the *Public Holidays Act 2010* (the Act) for the declaration of local public holidays and local event days for 2015.

The Act permits the Minister for Industrial Relations to declare a local public holiday, or a local event day for the whole or part of the Council's local government area. This may be limited to a particular location in the Council's area, such as the boundaries of a particular town or a police district in an area nominated by the Council.

The application may request the declaration of a part day local public holiday or local event day to accommodate the holding of an afternoon event. In recent years a number of councils have made applications nominating the times during which a local public holiday is to apply to facilitate the holding of such events.

In determining whether to apply for a local public holiday, or a local event day, it is important that the Council takes into account the costs to businesses and local communities of declaring a local public holiday within the designated area. It is expected that the Council will undertake a public consultation process on the matter, including consultation with relevant stakeholders, such as the local chambers of commerce; local banks; major employers and local schools located within the designated area.

Where it is proposed to request a half-day local public holiday, consideration should be given to the effect which a half-day holiday will have on local schools and on the transport of school students who attend school on the day. In this regard, it is expected that the consultation process with local schools will take account of the transportation arrangements for students on the half-day.

I have attached for the Council's information, guidelines for the making of applications to the Minister for Industrial Relations for the declaration of local public holidays and local event days.

Consistent with past practice, it is proposed to have the Ministerial Orders declaring the 2015 local public holidays and local event days published by the end of December 2014, or by the middle of January 2015.

Should the Council wish to apply for the declaration of a local public holiday or local event day, it will be necessary for the application to be forwarded to me by Friday, 7 November 2014 to enable sufficient time for the application to be processed.

Guidelines for Local Public Holiday and Local Event Day applications

The following guidelines are provided to assist in the making of applications to the Minister for Industrial Relations for the declaration of local public holidays and local event days under the *Public Holidays Act 2010* (NSW).

Under the *Public Holidays Act 2010* all local public holidays (including half-days) must be declared by Order of the Minister and published on the NSW legislation website.

In determining whether to apply for a local public holiday or local event day, it is important that the Council be aware of the potential impact the application will have upon businesses and communities located within designated public holiday areas.

Declaration of a Local Public Holiday

In circumstances where a local public holiday is declared by the Minister, a bank located in the designated holiday area will be required to close unless it holds an approval to open on the day under Part 3A of the *Retail Trading Act 2008*. Shops located within the designated holiday area are free to open without restriction.

Implications for Employers

The public holiday provisions contained in the National Employment Standards of the Fair Work Act 2009 (Cth) apply to local public holidays declared under the Public Holidays Act 2010. This means that all employees irrespective of their former entitlements and whose place of work is within a local public holiday area will be entitled to be absent from work on the day or half-day that is the local public holiday or half holiday. In addition, employees who work on the day or part day may then have an entitlement to penalty rates under a relevant award or enterprise agreement where previously that entitlement may not have existed.

In considering an application to the Minister for a local public holiday or half-day, it is expected that the Council will consult with the affected community and other relevant stakeholders as to the impact of a local public holiday or half-holiday on businesses located in the local government area. As part of that consultation, Council may consider the option of a local event day declaration instead of a public holiday or half holiday.

Declaration of a Local Event Day

The capacity for the Minister to declare a local event day or half-day at the request of a local council is also available under the *Public Holidays Act 2010*. The Minister must be satisfied that the day or part-day is, and will be observed as, a day of special significance to the community in the area concerned.

The declaration of a local event day or half-day does not preclude banks or shops located within the designated holiday area from opening or trading on the day.

Implications for Employers

A declared local event day does not automatically mean that employers in the particular locality are compelled to treat the day as a public holiday. Entitlements to paid leave or penalty rates on a local event day will only arise where agreed to at the workplace level, usually in the form of an enterprise agreement or by contract. This goes some way to

restoring the industrial arrangements that existed prior to changes in the Commonwealth workplace laws.

The application process

An application for a local public holiday or local event day (including a half-day holiday or local event day) should be made in writing to the Executive Director, NSW Industrial Relations, and lodged on or before 7 November 2014.

It would assist us in the processing of the Council's application if the following information and documents were provided:

- details relating to the specific date, the designated area and, if relevant, the applicable hours during which the public holiday or local event day is to be observed;
- supporting information provided to the Council and a copy of the Council's resolution authorising the making of the application;
- details of alternatives considered by the Council including the declaration a local event day;
- 4. the extent of community consultation undertaken in respect of the proposal;
- copies of advertisements seeking public comment and a summary of the public's responses; and
- copies of correspondence to, and responses from, relevant stakeholders, including bank managers; school principals; and chambers of commerce regarding the Council's proposal.

Copies of sections 5 and 8 of the *Public Holidays Act 2010* relating to the declaration of local public holidays and local event days have been provided for the information of the Council.

Sections 5 and 8 of the Retail Trading Act 2008

5 Additional public holidays

- (1) The Minister may by order published on the NSW legislation website declare a specified day or part-day in a particular year to be a public holiday. The order must be published at least 7 days before the public holiday.
- (2) The order can declare a public holiday for the whole State or for a specified part of the State.
- (3) The Minister may by order published on the NSW legislation website cancel a public holiday declared under this section. The order must be published at least 7 days before the public holiday.

8 Local event days

- (1) The Minister may by order made at the request of the council of a local government area declare a specified day or part-day to be a local event day in the local government area or in a specified part of the local government area.
- 2) The Minister is not to declare a local event day unless satisfied that the day or part-day is, and will be observed as, a day of special significance to the community in the area concerned.
- (3) The order declaring a local event day must be published on the NSW legislation website at least 7 days before the local event day.
- (4) The declaration of a local event day does not make the local event day a public holiday.

Dear Cr David Wright, Cr Robyn Hordern, Cr Ken Johnston, Cr Susan Meehan, Cr Sharon Cadwallader, Cr Jeff Johnson, Cr Keith Williams, Cr Keith Johnson, Cr Ben Smith and Cr Paul Worth

Firstly thank you all for taking time out of your schedules to read the following information. The Ballina Cup celebrated a centenary this year and we are very hopeful that the tradition continues beyond that 100 year mark. Our past is extremely important to us and I would encourage you all to visit Crawford House in Alstonville to look at the research undertaken by Marguerite Fuller relating to the history of the Ballina Jockey Club. What you would discover is that many of the residents who have helped to create and shape this region into what it is today, have also been heavily involved in the blood, sweat and tears that has help build the Ballina Jockey Club, showing just how important racing can and has been to the social fabric of our local society. We at the Ballina Jockey Club aim to continue the work undertaken here before our time, by ensuring the longevity and viability of this great community organisation well into the future. It is now that I therefore should state our position on this subject matter and that is, that The Ballina Jockey Club has written to Mr Paul Hickey as the General Manager of the Ballina Shire Council to formalise our application for a part day public holiday for the Ballina Cup on Thursday September 10th 2015. As a result I am now writing to the Councillors of Ballina in order to gather your support of our application to retain Council's endorsement for a part day public holiday.

Before you read on please let me provide you with some basic information about the Ballina Jockey Club.

- We are a non profit organisation.
- We are a Community Club run by members.
- We operate on Crown Land for the purpose of Horse Racing and other related business.
- The Club has been in existence in one form or another for 115 years.
- We are a member of the Northern Rivers Racing Association (NRRA) within that group Councils from Coffs Harbour, Grafton and Lismore all receive a gazetted part day Public Holiday.
- The Ballina Jockey Club is just one of over 130 Race Clubs in NSW.
- Horse Racing is a Multi-Billion Dollar Industry which provides considerable revenue for the NSW State Government.

 The Racing Industry also provides considerable GST revenue to the Federal Government, for example our own annual contribution is approximately \$170,000

The Ballina Jockey Club spent approximately \$250,000 on the 2014 Version of the Ballina Cup, this includes over 80 staff and a payroll in excess of \$30,000. Our spend goes to various local operators including the proverbial Butcher, Baker & in our case The Trophy Maker. It is not just the cost of Wages, Marketing and the Cost of Goods Sold that make up how we spend our money. For example we contribute \$25,000 a year at Ambulance NSW and we spend \$40,000 a year at the Ballina Shire Council. Our annual spend is extremely versatile and many local people and local businesses benefit from our operation. Our Council spend alone will increase dramatically post our redevelopment as we will require substantially more Reclaimed water. I am sure that you are all aware that Reclaimed Water is an extremely important resource for the future as our population grows and traditional water supplies dwindle. So we are not just having a positive impact on the economic growth of the region, but we are also helping to provide commercialisation to an Industry like Reclaimed Water which will have a positive impact on the environment.

Ballina is a great town and we are on the verge on what should be a huge boost to our economic growth, with proposed developments, discussions and upgrades around the following.

- > The Ballina/Byron Gateway Airport.
- > The Pacific Highway North
- > The Pacific Highway South
- A Proposed Marina
- Racing NSW has recognised the strategic investment into this region and the positives that will come from the improved access routes, as well as the potential for population and economic growth and as a result the Ballina Jockey Club has been promised a multi million redevelopment.

An interesting case study can be seen via The Albury Racing Club, which as I am sure you're all aware is located in the Southern Districts of NSW. The Albury Racing Club hold annually one of the biggest and most successful Country Race Events in NSW. They too enjoy like Grafton, Lismore, Coffs Harbour etc. A Part Day Public Holiday. However most importantly the Albury Racing Club and the Albury Council work closely with one another and have done so in collaboration to ensure that they have combined success. They receive substantial support from Destination NSW due to their location being close to the Victorian boarder. Destination NSW sees that as an opportunity to draw tourist into NSW from Victoria and therefore boosting spend in NSW. Ballina being so close to the Gold Coast and a huge population in South East Qld would make an excellent candidate for something similar. To achieve this we should also be working with one another for a common goal. Collectively we could be helping the town create jobs, especially for our youth who are always vulnerable and often feel the need to travel abroad in the search of employment.

Please note that we are requesting in the short term to go back to a Thursday in 2015. Anecdotal evidence would seem to indicate that this part of the reason for the drop in crowds. Our on-course turnover which has more science behind it then the general consensus that a Thursday is a better day would also support this idea, as turnover on-course has dropped with the move from Thursday to Friday which therefore indicates a smaller crowd. We would not only be asking Council to support this adjustment for 2015, but we would ask that you join with us in helping to promote the event as a tourism opportunity for the town. For example we would be seeking your collaboration in approaching Destination NSW for both economic and strategic support for this idea and we would anticipate by helping one another we can make the Ballina Cup into a substantial economic and social event for this town.

Please note that we understand that there are other factors involved with this decision then added labour costs to business or a day off for employees. We also note that School closures form a major part of the issue relating to the day, plus bus timetables and closing down service providers like banks etc. We would like consultation relating to these issues and a harmonic solution to such problems. We seek collaboration and investigation for the best plan for the future of the Ballina Cup. Please note however that significant change in the short term would be extremely detrimental to the viability of our event and we would hope that a course of action for any such change would require consultation, dialog, planning and above all a manageable timeframe.

Please take note of the following material and statistics around the Ballina Jockey Club.

Refer to attachment 1. Essentially the Ballina Brand is beamed into over 50 different countries World Wide, as well as every part of Australia giving us an audience of millions.

Refer to attachment 2. Essentially this is an extrapolation of the economic imprint of our business locally. Refer to attachment 3. Essentially this is a snapshot of our future, with growth relating to our income and expenditure post a multi-million dollar capital investment into the local economy.

As you will see from the attachments 2 and 3. The Ballina Cup and the Ballina Jockey Club is an essential part of the economic footprint within Ballina already. Post our Re-Development (which could be a capital works injection of approx \$10m itself) our economic imprint will grow by an estimated 50% making our macro enterprise valuation around the \$30,000,000.00 mark for the region.

Attachment 1 however just shows how big the Racing Industry is and how much potential is available for us as a region should we be co-operating with one another. The National and World Wide Audience that is available to the Ballina brand can be measured in the tens of millions including the access to over 50 different countries. The synergy between Racing and Tourism is therefore obvious and Destination NSW is already a substantial partner within the Racing Industry. It is worth noting that Tourism is a \$100 billion industry in this country and Ballina is tourist destination located very closely to the Gold Coast and Byron Bay being two of Australia's leading Tourist destinations. Why doesn't the Ballina Council use this reach to promote tourism into a World Wide audience?

All in all I would implore all Councillors to pick up the phone and give me a call to discuss this matter before your November meeting which I am told will have this matter as an agenda item. I will be happy to meet with all of you individually or collectively at any opportunity. In fact I will be seeking to meet with you all personally so please expect a phone call in the very near future.

RE: PART-DAY PUBLIC HOLIDAY - BALLINA CUP RACE DAY

I am writing on behalf of our members in the Ballina Shire Council LGA regarding the abovementioned part-day public holiday.

The Association supports the local significance of the Ballina Cup Race Day and the positive benefit the event provides to the local community and, in particular, the local economy, and understands the purpose of the public holiday is to allow the local community to attend the event.

However, as indicated in correspondence last year, our members have expressed ongoing concern regarding the impact of the local public holiday in increasingly tight economic conditions. The primary concern of our members is that hospitality businesses in the Ballina Shire Council LGA will once again be required to pay employees penalties up to 275% of the base rate of pay if the event is declared a local public holiday.

The Association again submits that for 2015, consideration be given to seeking the gazettal of local event day for the Ballina Cup Race Day in lieu of a local public holiday.

Alternatively, as occurred this year, the Association submits that for 2015, consideration be given to seeking the gazettal of a part-day public holiday which is sufficient for the purposes of the event, but does not unnecessarily impact upon hospitality businesses in the Ballina Shire Council LGA through the application of public holiday penalty rates up to midnight.

In this respect, the Association submits that the 2014 arrangements, being a part-day public holiday applying from 12:00pm to 6:00pm is appropriate.

As previously noted, the Association is mindful and ever supportive of the local significance of the event however we consider it is also important to seek to balance this in an equitable manner against the significant financial impost on many small businesses in the area.

The management committee of Ballina Fox Street Preschool wishes to submit its objection to the proposed scheduling of a part day public holiday for the Ballina Cup race day in 2015. This submission reiterates this committee's position previously conveyed to the Council in consultation undertaken in previous years.

As has been reported to and considered by the Council in previous years, the part day public holiday presents a significant disruption to school services in the shire and results in complications from schools having to close at midday. These complications not only relate to the lack of school bus services, but also the major impacts on parents and carers of children who may or may not be working for the full day. Ballina Fox Street Preschool experiences a high level of absenteeism for the first half of the declared race day due to this inconvenience, as also indicated by other educational establishments. Notwithstanding these inconveniences and disruptions to educational programs in schools across the shire, the Council has in the past continued to still support the proposed half day holiday.

It is the position of this committee that the declaration of a part day holiday for the benefit of the Ballina Jockey Club is unnecessarily disruptive to those institutions in the shire providing education services to children. These disruptions come at the expense of wider community for an exclusive event that has appeal to a small cross section of the community. This committee considers it unfair and unnecessary that a relatively small, local event that caters to a minority is afforded the luxury of a part day holiday at the expense of the wider community.

This committee shares the sentiments raised by representatives of other educational organisations in the shire where it has been stated in the past that the declaration of a part day holiday for horse racing at the expense of the education of children sends the message that gambling and associated drinking environment are more important than learning. All other sporting, social and cultural events in the shire are

scheduled at times more suitable to the community such as at weekends, evenings or on other gazetted full-day public holidays. Organisers of other events do not place the expectation on Council to declare a part day public holiday in favour of their event. Supporting the declaration of a part day holiday for a horse race at the expense of other sectors of the community is outdated, inconsiderate and not family friendly.

This committee further believes that Ballina Shire Council supporting the part day holiday while also being aware of the disruptions this causes to the community is inconsistent with a number of the items in the council's charter as contained in section 8 of the *Local Government Act* 1993, such as:

- to provide directly or on behalf of other levels of government, after due consultation, adequate, equitable and appropriate services and facilities for the community and to ensure that those services and facilities are managed efficiently and effectively.
- to promote and to provide and plan for the needs of children.
- to have regard to the long term and cumulative effects of its decisions.
- to exercise its functions in a manner that is consistent with and promotes social justice principles of equity, access, participation and rights.

In addition to the above, we also feel that supporting the proposed holiday is also inconsistent with the principles contained in the Council's Community Strategic Plan (Our Community: Our Future) which has been adopted by the Council to guide and inform the Council's decision making. It is our view that a decision to support the part day holiday which causes the disruptions outlined above is inconsistent with the Community Strategic Plan and does not reflect an engaged leadership that is connected to the community and aware of the impacts of the decisions it makes.

Based on the reasons above, it is requested that the Council consider the impacts supporting the part day holiday has on the wider community in making its decision. In particular having regard to supporting an event that caters to a small sector of the community at the expense of the needs of the wider community.

Thank you for your email requesting feedback in the possibility of a half day public holiday for Ballina in 2015.

As the relieving principal of Ballina High School I have listened to feedback from the school community (both parents, students and staff) over this year's half day public holiday for the Ballina Cup.

To be very blunt I have not listened to one positive comment, all have been negative. The main issues being the disruption to the day, Yr12 students losing a half day prior to their Higher School Certificate, the total lack of transport due to the non-variance in times for buses, the event is very restrictive and is non inclusive of adolescents.

The student attendance at Ballina High School on the day was 56%, with parents being very upset that there was no consideration in transporting their child home for an event that they would not be supporting due their own work commitments and lifestyle choices. A number of parents commented as to why the school was supporting the half day as the focus was on gambling and associated drinking of alcohol.

I am hoping and have encouraged all people who have spoken to me contact yourself and the council over this matter. Personally, as an educator of secondary students I do not support a public half day holiday for a restrictive community event that is based upon gambling. It was commented to me why half day public holidays were not given to other local sporting events such as grand finals, as far more students are involved at junior levels and these sports promoted active, healthier lifestyles.

Community events are important and are to be supported and recognised but not at the detriment to education. From all feedback that I have received, the Ballina High School Community does not support a public full or half day holiday for the Ballina Cup in 2015.

Please pass on my thoughts regarding the half-day public holiday to Mr Hickey and council...

The granting of the half-day public holidays fro the Ballina Cup over the last two years has had a major impact on my schools (both Ballina PS and Southern Cross K-12). This has included...

- a reduction in much-needed class teaching time.
- a marked increase in student absences for the whole of the day. Parents obviously chose not to send their children to school at all.
- an increased workload for admin staff communicating advice as to school arrangements for the half-day holiday.
- with buses not being available at 12 noon when the schools closed, there were major difficulties with ensuring the safety of children as they left the school. Many children were not collected by parents, and some were leaving the school not via their regular method. This caused a level of anxiety for both students and staff.
- school admin and teaching staff being abused by parents for having the half-day public holiday.
- interestingly, many of my teachers remained at school anyway, prefering to use the time for admin and preparation purposes, rather than going home early and certainly rather than attending the races!

In my opinion, our schools would much prefer for the day to be called a local event day, so that they can run as usual.

Rainbow Childrens Centre is unconcerned what type of arrangement is made for Ballina Cup Day next year.

We find most families do require long day care for 0-5 year olds or after school care for 5-12 year olds on Ballina Cup Day. Rainbow Childrens Centre has operated each year on the afternoon of Ballina Cup Day regardless of the day's declared status. We find that most families utilising long day care still require care on that day. With our three after school care services at Lennox, Southern Cross and Ballina Public, we also operated a full half day service from 12 noon and had good numbers at each school. While some families who usually use after school care picked up their children from school at noon and did not use our service, other families who may not normally use after school care on that day did use our services as they were required to work at least up to normal school finish at 3pm.

Our staff work under an Enterprise Agreement and those who work on the afternoon of Ballina Cup Day are paid normal wages and in addition accrue time in lieu which can be taken later at a mutually agreeable time. While there is some additional costs for our service of providing that time in lieu it is manageable.
