SUBMISSION TO RATE INCREASE FOR SWIMMING POOLS

The only thing Ballina Shire lacks is a Town Crier with a big bell and an even bigger voice yelling out "Oyez! Oyez! Rate rise imminent! Open your wallets to upgrade pools!"

Eva Ramsey is right. It is going to happen. It's all about "Jobs for the Boys", not about improving the Swimming Culture. There is even a Tender on the Council's website which closes 30th October and says: "Tender 781. Provision for Swimming Pool Redevelopment Advisory Services. Consultancy - Public Swimming Pools." This is a classic case of putting the cart before the horse.

Let me take you back to a conversation I had with the Ballina Council General Manager in his office some years ago. He and I were having a discussion about property development when I was a Councillor. At that time, the GM said he would love to be a property developer. A couple of Council Meetings later there was an agenda item to hire another Manager and set up the Commercial Services Department, and away it went from there. The property development balloon was rising! Afterall, if the General Manager can prove his credentials with ratepayers money, then he would have more worth in private enterprise in property development than as a lowly Council manager.

However, this property development agenda may suit the General Manager, but does it suit you and me, the Shire's ratepayers? My rates (without water and sewage) are already \$3,900 per year, and quite frankly I have had enough of rate rises.. With Mayor Wright proclaiming we are in for an 11% rate hike (and he isn't even a ratepayer, so it doesn't directly affect him). this means my rates will increase by \$429 per annum.

This 2.5% rate rise over 2 years for the swimming pools is really only a rort to keep the Commercial Services Manager in a job and satisfy the General Manager's lust for property development. The swimming pools upgrade can easily be achieved by savings on other things.

What about the proposed new road to the airport which passes Mr Gerry Harvey's shopping precinct? Why does the Council need to spend \$5 million on a new road when the existing road is quite adequate? If Mr Harvey wants a new road beside his shops to attract more customers, let him sell one of his racehorses to fund it. Why do ratepayers have to be financially squeezed to pay for the new road when we can't afford it and we could use the \$5 million better elsewhere?

2.5% a year for 2 years doesn't look much, but remember what the carbon tax did to your petrol and electricity bills? Mine went through the roof. And what about the old age pensioners and young couples who pay rent, not rates? You can bet their landlords will use the rate rise as an excuse to put the rent up.

So I say NO, NO, NO to any more rate rises. We don't need them. If only 55% of residents in Ballina have got internet, you can be assured they don't use the swimming pools either.

It is time to get rid of all this development. If the pools have to be upgraded, then do it by culling staff, not by rate rises.

Dear Cr Wright Re: BALLINA'S PROPOSED RATE RISES FOR POOLS

May I suggest an alternative method of paying for future shire residential swimming pools, which works well in San Jose (Silicon Valley) California, which is claimed to lead such planning world-wide.

My son, Bruce Peters, a Global Controller of Finances (a super accountant) and his wife Nancy Peters, and their two young children live in the San Jose suburb of Los Altos.

Before buying into that suburb of about 80 blocks, owners are required to realise they contribute an annual amount towards upkeep of their large, attractive, communal swimming pool, which includes indoor and outdoor entertaining and conference areas, outdoor showers and indoor bathing, changing facilities etc, and a block of tennis courts, all served by plentiful parking. This complex is situated far enough away from homes to prevent noise pollution.

This planning avoids:

- Wasting water from many small backyard swimming pools
- The liklihood of children drowning, or other accidents, because the communal pool is monitored by a lifesaver.

My son voluntarily appoints lifesavers and does other tasks, to help keep costs down, and other residents willingly contribute skills. The pool is used by all age groups. Other San Jose suburbs have similar sporting complexes, I was told. Also schools rent out facilities after hours, as happens in some Japanese centres.

Los Altos has single storey residences. Blocks are wide enough to avoid noise pollution, which is a problem on narrow, 55metre wide blocks at Lennox Head. Some Los Altos libraries, museums and some other communal facilities are multi-storey. Well designed business and commercial areas are close. The main San Jose CBD was renovated in the 1980s, retaining Spanish and Mexican influences. Sky-scrapers are not permitted near historic buildings, such as slab huts and Victoriana showpieces. A large central 'island' is retained in the main street for festivities.

Between Los Altos and the next suburb is a large preserve (in Australia called a reserve), which thousands of people use daily. It includes a working farm, with a variety of animals and poultry and large garden, crops, barn and outhouses, where children can watch cows and goats being milked and animals fed. Fresh eggs, fruit and vegetables are for sale. A small mountain, for climbers, long stretches of walking, cycling and horse-riding trails are permitted, but no motor vehicles except those used by maintenance staff, who are paid by the equivalent of Australia's Parks and Reserves authorities and the local council.

RATE RISE-2

So residential areas have handy access to a large country area, left largely in a natural state. Visitors are warned to beware mountain 'lions' which aren't lions. Ground and other bird life and natural trees and other locally indigenous vegetation are plentiful.

The preserve was set aside in the early 20th Century, when planners could see San Jose was on the verge of rapid expansion, rather like Ballina Shire is now. It could be the time, while farmland is relatively cheap, for such an area to be set aside on Ballina Shire hinterland.

Roads feed carefully into an eight lane highway connecting San Francisco with Los Angeles. Silicon Valley is about an hour south of San Francisco by road. Los Altos is considered middle class. Billionaires have large estates nearer the mountain range.

Silicon Valley has been written up as a world leader in residential planing, an example of US can-do-ism. San Jose is the 12th largest city in the US, I have read.

This letter is written without references. My son, or daughter in law, although extremely busy, could provide more details. Nancy Peters was IT manager for Channel 9 when they lived in Sydney.

PUBLIC REACTION TO BALLINA'S PROPOSED RATE RISES...

I have yet to meet any Lennox residents who approve of paying such higher, permanent rates. The consensus is that the 'user pays principle' be applied. Residents who already pay high rates to live near Seven Mile Beach and Lake Ainsworth believe tourists and other visitors should contribute more to Ballina and Alstonville pools upkeep.

(When I lived in Lismore and was a journalist/sub-editor on The Northern Star there was a similar outcry about upkeep/improvements to Lismore Memorial Swimming Pool.)

Personally, I swim in Lake Ainsworth and surf at Seven Mile Beach. I don't find the roofed paid-entry pool along Ross Lane pleasant. My son. as a boy, occasionally used Ballina pool. I realise such pools must be kept up to standard, but would like to see improvements and maintenance incorporated in the Council's annual budget, without high rate increases.

Campaigns are underway for an indoor Ballina sporting facility. Again I agree with others who cite the 'user-pays principle'.

Lennox Head was deprived of vital community recreation land as laid out in the 1922 Lennox Head Estate plan, along the south-east shore of Lake Ainsworth. The zoning was altered so that it was sold off to the NSW Government for \$1.3 million, to extend Lake Ainsworth Holiday Park, ignoring strong community objections.

Now there is talk of two storey buildings on that former vacant land, which was such an asset for public recreation. Planners commented that Lennox people had the beach for recreation. That is shared with visitors. It is difficult for children to play hockey etc on the beach. Most Lennox units don't have normal backyard play space. Therefore more Lennox children now play on roads. <u>Does Ballina Coucil consider that desirable?</u>

I oppose the 5.5% rate increase to 2015/16 & 2016/17 when the council take it upon themselves to remove functioning playground equipment and erect just two swings at a cost of \$15,000 each to two parks in my estate at Angels Beach, one being Jabiru Park. Then after a signed petition by many local residents and exposure in the local Advocate newspaper, the council decided to replace the climbing equipment at the cost of another \$30,000 to each park. This has not happened yet, as promised by end of September 2014. I don't understand why Ballina Shire Council waste rate payers money doing stupid unnecessary things like this. To whom it may concern I provide some comments about the proposed swimming pool improvements.

As a rate payer I <u>don't</u> support the proposal for rate increases to fund the upgrade as the proposal currently stands. This could change if some changes are made to the method of raising the required funds and details about how the facilities will be operated.

I provide the following additional comments

- 1. There is a significant proportion of people living in the shire that are not rate payers that should also be contributing to any upgrades.
- 2. It is inappropriate for non-rate paying residents to participate in feedback on a rate increase to fund the proposed upgrades.
- 3. If a rate increase is to be imposed, after the two years of increases the rates should be reduced equivalent to the extra two 2.5% increases and operational costs come from patronage.
- 4. Detailed costing and operational budgets need to be provided to show how these facilities will remain financially viable and not require further money from rate payers.
- 5. The hours of operation of the Ballina facility is not suitable for people to use after work. Many people commute and pool closes at 6pm in summer unless you join a swim club that costs more money on top of season passes. With patrols on beaches closed at 5pm this is very inconvenient particularly in summer and daylight saving when people want to swim.
- 6. The entry fees for water slides are excessive and there are no benefits for season pass holders or locals like offered by water theme parks on the Gold Coast.
- 7. How about attaching a gym or putting in some outdoor gym equipment.

My mother and I owe a house and a unit in Ballina. Our rates for the two properties this year are \$4,354.00. We also own two properties in Lismore where the rates by comparison are \$3,717.00.

We are opposed to any application by Ballina Shire Council to the State Government to obtain an increase in rates to finance improvements to swimming pools.

The Council should have for years been putting aside moneys in anticipation of the costs of improvements to these pools. It appears that for the forty years that the pools have been operating the Council has failed to have any plan to fund the required refurbishment of these pools. Now it appears in the face of that gross neglect the Council wants to just seek approval for the rate payers (not the pool users or tourists or renters or visitors to Ballina) to pay for the upgrade.

Recently there was a letter in the local paper which stated that the council had invested in an office block, a steel factory and a number of cafes and bars. Council needs to get its priorities right. There is no point buying more assets if the council has not got the money to maintain its existing assets.

Strata schemes are required by law to have 10 year plans in respect of anticipated repairs, maintenance and improvements to common property. Perhaps there should be legislation that requires councils to have similar plans over longer time frames for repairs, maintenance and improvements to council assets.

As well as rates, rate payers are being charged a waste operations charge, a domestic waste collection charge, a stormwater charge, a water access charge and wastewater charge. It has always concerned me that it appears that the Council can bill all unit owners in a strata scheme the water access charge when there are no separate meters to units. Common sense suggests that if there is one water meter at a strata scheme that the Owners Corporation of the strata scheme should be billed the water access charge. But no, Council wants to get the money out of the rate payer not the Owners Corporation and accordingly bills each owner.

Council should also have regard to endeavour to obtain funding from the other people who use community facilities in Ballina such as the facility users themselves, visitors to Ballina, tourists and people who live in Ballina but do not own property. In response to your recent correspondence regarding proposed pool improvements and funding required we would like to record our objection to the proposal, on the grounds that there are a number of ratepayers in the Ballina region, ourselves included, who still do not enjoy even the most basic of modern facilities; ie a tar-sealed road.

Rishworths Lane, Brooklet contains some of the larger agricultural businesses in the district and is regularly used by cars and trucks on a daily basis and semi-trailers on a regular basis. Non-residents vehicles regularly use the lane to access employment, farm gate sales, farm maintenance and road side stalls. Despite annual grading and maintenance, because of it's heavy use the lane soon returns to a pot-holed condition. A cloud of dust with each vehicular movement exacerbates asthmatic conditions and permeates homes and motor vehicles.

Brooklet has several untarred lanes but Rishworths Lane is arguably the longer and most heavily used. If tarring of Rishworths Lane is not already on Council's agenda then we request that Council include this 'basic 21st century necessity' on it's forward infrastructure planning agenda.
