Dear Paul,

We thank Council staff for the responses to our questions regarding the pool upgrades. We are unclear as to how Council will arrive at its decision. This may have been spelt out at the public meetings but we were unable to attend.

If Council is to base its decision on community feedback, we would like to register our opposition to such a large loan. It appears that Council's capacity to repay such a loan, given principal and interest, may well require more than the 2 year additional rate increase and there is likelihood of an impact on future services.

Work that we would support: Improved access -  $$90\,000$ , heating / improved heating -  $$180\,000$ , coping and relining -  $$900\,000$ , replacement and upgrading -  $$550\,000$ . (as per Council's table of costings). The total would be roughly half that proposed.


David,

Thank you for your letter dated 22<sup>nd</sup> September 2014 in which Ballina Shire Council (BSC) outlines its plans for financing proposed pool refurbishments in Ballina and Alstonville.

I appreciate that the pools are nearing 50 years old and would require some refurbishment at some time. The pools are great community assets as they provide affordable entertainment, relaxing and exercise facilities to the local community.

However, I question if a rate increase is the appropriate mechanism to finance the proposed refurbishments. Although the proposed rate increases would be applied for two consecutive years only, you will appreciate that their effect is felt forever. In the figure below I have modelled rate growth scenarios as follows:

- 1. Rate growth at 3% per annum (blue)
- 2. Council proposed rate growth curve based on 3% base rate increase (red)
- 3. Proposed adjusted rate growth curve to compensate after 2016/17 (green)



If rates are to be used to finance these refurbishments, I propose that a no rate growth is applied during the financial year of 2017/18 and a 1.12% rate increase in 2018/19. This would bring the overall rate growth back to its original curve. Otherwise long-term rates will be 5% higher than they would have been without the two proposed special rates variations.

The current proposal does not provide enough information to be able to positively respond to Council's proposal, in particular with respect to Council's proposal to use special rate variations as the financing mechanism. Depreciation of the pools should have been included in every Council budget since pool construction. Has the depreciation of the pools been included and if so, can you please clarify why the sum of depreciation over the last 40-odd years would not be sufficient to finance the proposed refurbishments?

Lastly, I would request that Council reconsiders the need for a water park at the Alstonville pool. There is an existing water park at the House With No Steps, admission to which is free.

Based on the above, I look forward to receiving Council's amended proposal which would put me in a better position to support it.

INFO: Input into Alstonville pool future

Good afternoon,

I couldn't make it to last week's meetings, so sorry about the late input.

As a regular pool user in a number of cities and towns across the State and others, I'd like to make the following comments.

Although the current pool season is reasonably long compared to some, I'd love it to be open all year round. During the last closure I had to add 15 minutes each way to my day, to drive to SCU Lismore's pool as those that are slightly closer at Goonellebah are shorter and overheated for lap swimmers.

I would prefer a heated outdoor pool even all year round (rather than an indoor pool) as it's a healthier environment - UV helps sanitise the pool and lower levels of chemicals are required. I find with a lot of pools, particularly indoor ones, the level of chemicals, particularly chlorine often make me come up in an itchy rash, so it appears I may have developed sensitivity over time. I'm aware there are alternatives to high chlorine content - e.g. salt-based, or even perhaps something mentioned on a TV ad recently for home pools that avoids or lowers chlorine. I also enjoy being outdoors hearing the birds, seeing the trees and the sky, feeling the breeze and smelling the spring flowers, when much of my day is inside.

Whilst I understand the cost of heating is high, perhaps solar can be employed to lower the long term cost, although there will be up front costs. The current temperature at the pool is great.

A 50 metre pool length is great if you want to keep the distance up to participate in longer ocean swims such as the Bay Classic or others, to minimise the number of turns and therefore mini-breaks.

At present during the water polo season there is conflict between lap swimmers and water polo training from 7-8 am a couple of times a week. There are a number of users impacted by this, so it would be great to be able to run water polo and lap swimming concurrently. I generally get to the pool around 7.30 am and spend an hour or so swimming, before going directly to work, so it's really annoying to have to rejig my mornings to work around it. As things stand at the moment it's also a pain for Greg to have to remove and replace lap lanes.

In peak times there are sometimes more people wanting a hot shower than hot showers available, so it would be good to have more than one. It may be worth considering a small number of lockers for safe keeping of valuables in busy holiday times and it's important to retain fixed shade and semi-shade areas.

It's also important for some of the elderly or injured users to be able to get easy access to swim or do water running for rehabilitation and fitness. The current pool only has ladder style steps which are difficult for me when my back is bag, with the only alternative being an operator assisted lift chair. Much better for people to be able to be self-sufficient.

I'd also like to comment that Kelly and Greg run a great facility very efficiently and have done for a long time (I lived here about 15 years ago before having to move away for a while) - it's one of the best pools I've been to and I hope to stay in town into my old age and use it for a very long time. The pool also has a friendly, community feel and it needs to stay that way.
