1.4 APPROVED ROADS AND AREAS OF TRAVEL

- 1.4.1 This permit is issued in respect of the roads in New South Wales specified in paragraph 1.4.2 for which [INSERT COUNCIL] is the Road Manager as provided for in the Heavy Vehicle (Adoption of National Law) Act 2013 (NSW). 3.2.1 The vehicle is exempted from the mass limits in Schedules 1 and 2 of the Heavy Vehicle (Mass, Dimension and Loading) National Regulation when loaded with sugar cane.

- (c) The sum of the manufacturer's mass limits for the prime mover (Gross Vehicle Mass (GVM)) and the trailer Aggregate Trailer Mass (ATM) it is towing; or
- (d) 44.63 tonnes; or
- (e) 45.13 tonnes if the heavy vehicle complies with the requirements of Schedule 3 of the Heavy Vehicle (Mass, Dimension and Loading) National Regulation (NSW).

Statement of Reason: The total mass of the combination has been aligned with the policy providing access under the New South Wales Class 3 GHMS Mass Exemption (Notice) 2014 (No. 1). This permit provides the operator with access to increased mass limits in line with a 5 percent increase above General Mass Limits on specified routes.

PART 4 TRAVEL CONDITIONS

4.1. A heavy vehicle operating under this permit may not be operated where prohibited by a load mass or dimension limit specified for a road, bridge or causeway by a sign.

Statement of Reason: This permit does not provide an exemption from any sign-posted load mass or dimension limit restrictions.

PART 6 VEHICLE CONDITIONS

- 6.1.1 The permit holder must ensure that each prime mover recorded above in Clause 1.3 is fitted with an approved weighing device that can accurately measure and record vehicle weight on each axle group and in combination.
- 6.1.2 The permit holder must ensure that each vehicle is equipped with road friendly suspension (RFS) and GPS tracking.

Statement of Reason: The vehicles covered by this permit are provided a mass concession on the basis that they have vehicles with the above technology. This provides assurance to [INSERT COUNCIL] as the road manager that the infrastructure impact of the mass concession is somewhat mitigated.
