Terry Prendergast - he has had an ongoing problem for twelve months with vandalism on his property which has resulted in an excess water bill.

Why does the Council purchase water for \$1.67 per kilolitre from Rous Water and sell it at a rate of \$2.02 per kilolitre for the first 350 kilolitres, then have an increase of 50% to currently \$3.13 per kilolitre?
