11. Civil Services Group Reports

11.9 Operating Lease - Tuckombil and Stokers Quarries

Delivery Program Operations Support

Objective To report on an agreement in regards to the lease of

Council's quarries.

Urgency

Clause 241 (3) of the Local Government (General) Regulation 2005 states that a council must not transact business at a meeting of the council unless adequate notice of the business has been given except where:

- a) a motion is passed to have the business transacted at the meeting, and
- b) the business proposed to be brought forward is ruled by the chairperson to be of great urgency

At this matter relates to commercial negotiations regarding Lismore City Council's (LCC) lease for the operation of the Tuckombil and Stokers Quarries, with an urgent decision needed by Council as outlined in the confidential report, the recommendation is that Council deals with the following report and the confidential report related to this lease at the June Ordinary meeting.

Recommendation

That Council consider the open and confidential reports on the Operating Lease – Tuckombil and Stokers Quarries as a matter of urgency as a Council resolution is required to finalise the commercial negotiations currently taking place.

Background

LCC has proposed for some time to terminate the lease for the operation of the Tuckombil and Stokers Quarries. In response to the position of LCC, at the December 2015 meeting the Council resolved the following:

- 1. The General Manager is authorised to accept the proposal from Lismore City Council, as per attachment one to this report, to terminate the lease for the operation of the Tuckombil and Stokers Quarries subject to the minimum royalty period being a maximum period of twelve months, or less if another operator is installed within that period.
- 2. That Council hold a briefing early in 2016 to assess the preferred management option being lessee or operating the quarry ourselves.

This position was communicated in writing to Lismore City Council and their response was to reject our proposal.

Following further discussions and a recent meeting this matter has now been negotiated and the terms of a proposed agreement are reported confidentially to Council.
