d) Lennox Head Vegetation Management Plan (Coastal) 2016 Consultation

Ballina Shire Council, along with the Lennox Head Landcare Group has prepared a draft vegetation management plan (VMP) covering the area identified on the attached map. The VMP covers the coastal public land areas from the north of the shire along Seven Mile Beach and extending south to Sharps Creek at Sharps Beach. The VMP is an upgrade of five existing vegetation management plans into the one single plan. The current plans are older now and have been very helpful in guiding extensive restoration efforts for the Lennox Head Landcare, community and contractors over the years. Some plans have been well implemented whilst others have not been adequately resourced. Vegetation community changes and improvements have occurred due to ongoing extensive restoration efforts with the Bitou Bush Threat Abatement Plan and numerous other grants over recent years.

The VMP has incorporated, updated and supersedes all the following plans:

- Lennox Point Vegetation Management Plan 2006
- Lake Ainsworth Vegetation Management Plan 2007
- Seven Mile Beach (Precinct 2) Beachfront Management Plan 2005
- Seven Mile Beach (Central) Vegetation Management Plan 2007
- Sharps Creek to Shag Rock Vegetation Management Plan 2004.

The VMP has:

- Conducted an ecological survey for vegetation community boundaries and species, determined VMP zonings and restoration actions to guide both contractors and volunteers.
- Addressed fauna habitat considerations for ongoing restoration efforts
- Addressed all weed species and control measures
- Addressed vegetation management and related issues
- Addressed all related legislation
- Addressed Aboriginal cultural heritage management
- Addressed infrastructure management and visitor facilities
- Addressed track management
- Addressed monitoring and record keeping
- Considered all existing master plans, coastal zone management plans etc.
- Considered all public events and other anthropological uses of the land
- Considered all existing commercial licensed operations at various areas
- Formed the basis for Council planning approval prior to implementation.

A key component of the VMP is for consultation with the Aboriginal community through this Committee. Some consultation has already occurred to assist and propose the Aboriginal cultural heritage management considerations for the VMP area.

Consultation has also been conducted with the Lennox Head Landcare Group, Lennox Head Residents Association (Coastcare), broader Lennox Head community and Ballina Shire Council as a part of the plan's preparation.

The Committee is invited to consider the draft plan, and to provide feedback. Council's Natural Resource Officer, James Brideson will be in attendance at the meeting to discuss this matter.



2. Appointment of Chairperson for the Meeting

The Committee has previously agreed to operate with a rotating Chairperson. On this occasion, Lenkunyar Hickling was nominated to chair the meeting and she duly accepted the role.

3. Declarations of Interest

4. Confirmation of Minutes of Last Meeting

6. Deputations

There were no deputations to the meeting.

7. General Business

a) Ballina Shire Koala Management Strategy Suzanne Acret provided an overview of the processes undertaken by Council and its consultants in the preparation of the Ballina Shire Koala Management Strategy, which was adopted by the Council on 24 March 2016.

Ms Acret presented information concerning key threats to the shire's declining koala numbers and the actions contained in the Strategy which aim to maintain a viable population.

Committee members expressed their appreciation for the presentation.

b) Coastal Recreational Pathway Project
 Paul Busmanis and Ian Fox provided an update in relation to this project.

A contractor (B&S Landscaping and Earthworks) has been awarded construction of part of the CRP Section 1, Angels Beach to Sharpes Beach comprising:

- path section from Flat Rock carpark to Sharpes Beach carpark including small footbridge across Sharpes Creek
- boardwalk section along Angels Beach from the overpass to south of Flat Rock Tent Park.

The contractor commenced early March 2016 on the section from Flat Rock carpark to Sharpes Beach carpark. The contractor's staff completed a Cultural Heritage Induction session, and site monitoring was also undertaken during initial ground disturbance between Flat Rock carpark and Sharpes Creek. Two of the three Registered Aboriginal Parties responded to the site monitoring request.

It was also clarified that the CRP work has proceeded as a result of completing a Cultural Heritage Assessment (CHA) for CRP Section 1, and then obtaining an Aboriginal Heritage Impact Permit (AHIP) from the Office of Environment and Heritage (OEH). All three Registered Aboriginal Parties endorsed the CHA at the time, and have subsequently received copies of the AHIP.

A Part 5 approval has now also been received for dealing with the additional boardwalk viewing platform and entry node associated with the Cultural Ways project. The associated AHIP variation has also been received.

It was noted that information dealing with the CRP project and the CHA and the AHIP was available for the Registered Aboriginal Parties to discuss further with other family and parties if needed.

BSCACC Minutes of Meeting 14 April 2016 With completion of contract works it is proposed for Council to complete the path connection from the Angels Beach underpass to the overpass including the Cultural Ways 'entry' and carpark.

A demonstration was also made of the development of the iPhone/iPad link which provides more Aboriginal Cultural Heritage information along the CRP, including audio recordings.

c) Angel Beach Drive

Paul Busmanis and Ian Fox provided an update in relation to maintenance and upgrading work along Angels Beach Drive, East Ballina.

The project involves raising the levels of the existing road curves at Prospect Bridge and at the sewage pumping station adjacent Chickiba Lake, applying a new asphalt overlay on the road and constructing a new roundabout at the Angels Beach Drive and Links Avenue intersection.

Part 5 approval has been received for the project and requires an AHIP for the Links Ave roundabout worksite due to the adjacent midden site. An AHIP application was submitted to OEH at the end of March 2016, which included the project's Cultural Heritage Assessment (CHA) report. Suggestions from the Committee about improving cultural heritage recognition at the Links Avenue midden site have been incorporated into the CHA.

The project commenced last week on the road section east of Links Avenue and will then proceed to the section west of Links Avenue, and then continue to the roundabout. Significant advertising has occurred due to the associated road closures. The roundabout construction would start following the receipt of the AHIP. It was noted that creek bank rehabilitation would occur near the new roundabout, and it is proposed for carbon dating to be done for information gathering as part of the project work.

d) Cabbage Tree Island Bridge Repairs

Paul Busmanis provided an update regarding a recent site inspection by Roads and Maritime Services regarding the grant offered by the NSW State Government for the Cabbage Tree Island bridge assessment and upgrade.

It was accepted by RMS that work associated with approach roads, drainage and gravel roads would be able to be undertaken as part of the grant. Council will liaise further with Jali LALC about scoping this work in conjunction with the bridge investigation.

a) NAIDOC Week 2016

The Chair, Lenkunyar Hickling enquired about planning for this year's NAIDOC Week activities.

Steve Barnier responded by advising that Council staff will soon be liaising with representatives of Aboriginal service organisations to arrange a program of activities. This approach is the same as in past years.

No objections were raised to this arrangement.

b) Local Government Aboriginal Network Conference

Steve Barnier distributed to members of the Committee notification regarding the proposed 2016 Local Government Aboriginal Network Conference, which this year is to be hosted by Tweed Shire Council on 24 to 26 August.

The conference is not limited to elected members or staff of councils, and may be attended by any individual who has an interest in developing and enhancing Aboriginal lifestyle, culture and employment opportunities.

Committee members were encouraged to distribute information concerning the conference within community.

c) Committee Membership

The Committee was informed that Council staff have been unable to contact Ms Kim Vincent, an appointed member of this Committee.

In the absence of any other notification, it is now assumed that Ms Vincent has resigned from her position of Committee member.

9. Next Meeting

The next meeting of the Committee is scheduled to be held at 5.00pm on Thursday 9 June 2016.
