5. <u>Business Arising from Minutes – 9 March 2017</u>

(a) Bulwinkel Park

Cr Smith raised this matter at the 27 April 2017 Ordinary meeting when it was resolved as follows:

That Council approves the exhibition of the draft Delivery Program and Operational Plan document, as attached to this report, inclusive of any changes arising from this meeting, as follows:

- Elizabeth Ann Brown Park, Alstonville consideration of implementation of the masterplan with the focus on the plinth.
- Consideration of installation of BBQs at Missingham Beach/Shaws Bay and any other appropriate sites.
- Bulwinkle Park, Alstonville that Council arrange a meeting with relevant stakeholders in relation to proposed improvements and if a plan of management is required, that consideration be given at the June meeting to the preparation and implementation of such a plan.

(b) Tuckombil Quarry & Asphalt Plant – Tyrone McGillick

Tyrone McGillick submitted written questions about Boral Quarry. The questions were taken on notice and were referred to technical staff for response.

A response will be provided at the meeting.

(c) Johnsons Road Water Treatment Plant

The Committee asked about the current duck kill at the Johnsons Road Water Treatment Plant. The Committee asks what Council's procedures are for such occurrences and what mitigation actions it takes.

Council can confirm that a number of wild ducks had died on the site and that previous testing had indicated the cause to be Botulism.

Though Council doesn't have a direct procedure for the management of wild ducks on its Treatment Plant sites, the advised mitigation measures for Botulism in Ducks aligns closely with best practise guidelines for the management of the treatment facilities:

- ensuring good water quality
- keeping sites free of litter and food scraps
- minimising the presence of rotting vegetation
- controlling fly and pest populations, and
- promptly removing carcasses.

(d) Community Halls

Staff advise that building inspections have been completed in relation to Council owned community halls including the Wollongbar Hall. Council staff are currently reviewing the reporting information and it is envisaged that further information will be available following the completion of the review.

(e) Rous Mill Road

Steve Miller asked if the Council could revisit the flood repair work carried out some time ago to the road verge about 500m west from the Rous Mill Hall on the banks of Youngmans Creek.

The work has left the verge unsuitable for passing traffic due to it being very rough. The Committee would like to see it evened out / graded.

A response will be provided at the meeting.

(f) Management Plans Tosha Falls – Project Update

In response to the deputation by Mr Prendergast, Council staff advise as follows:

Council resolved in July 2016 to prepare management plans for Tosha Falls and Killen Falls to establish a framework for long term planning for the areas. MikeSvikis Planning has been engaged to prepare plans for both sites, which will consider potential opportunities for facilities, access and infrastructure relevant to the areas.

Council has written directly to immediate neighbours of Tosha Falls. Verbal and written feedback has been received from neighbouring landholders.

There are two landholders that directly adjoin the Tosha Falls land owned by Council. Council's project consultant met individually with both of these owners in January and their property was inspected (over approximately 2 hours each). Direct contact was also made with a land owner in Kim Court that has previously made representations to Council concerning access to Tosha Falls. All of these residents have made written submissions, which are being considered in preparing the management plan. Key issues raised to date include trespass and privacy, Johnstons Road and other access options, tracks and other infrastructure, environmental restoration, water quality, toilets and rubbish, cliff jumping, safety and risk.

As well as contacting neighbouring landholders, a community and user group survey was conducted online and a visitor count was undertaken on a weekend in January (school holidays). Survey responses have been collated and are being considered in drafting the plans.

Council is currently in the second stage of the process being to prepare draft management plans. It is expected that draft plans will be presented to the Council in May or June.

6. <u>Council Documents on Exhibition</u>

The Ballina community has for many years expressed an interest in a greater range of marine infrastructure in Ballina. Council is now developing a Ballina Marina Master Plan to encourage and guide redevelopment of the area commonly known as the **Trawler Harbour site in West Ballina**.

Since early 2016, Council has been investigating the establishment of a marina and potential land uses such as, residential redevelopment, a public esplanade, dry storage for boats, commercial areas and open recreational spaces.

The aim of the project is to encourage Government and private interest to consider the site for investment and redevelopment.

The current project plans have drawn on previous plans, detailed site assessments and feedback from the community and stakeholders.

Council has now published a draft master plan that outlines a proposed approach to land redevelopment and an associated economic feasibility assessment.

Preparation of the master plan has been supported by funding from Transport for NSW under the Better Boating Program.

• Draft Alstonville Planning and Environmental Study and Draft Strategic Plan 2017 - 2037, closing date 12 May 2017.

Council has used the feedback and information the Alstonville community has provided and prepared a draft Alstonville Planning and Environmental Study and draft Strategic Plan 2017 – 2037.

The Alstonville community is encouraged to review the exhibition documents and the suggestions and ideas that they contain. Council looks forward to receiving comments and additional ideas.


