Council's Support of North Coast Academy of Sport

Dear Paul,

I write to seek Ballina Shire Council's financial support of the Academy for financial year 2017-18, and hope that you could include this submission within your upcoming budget papers.

North Coast Academy of Sport (NCAS) is a **non-government** and **not-for-profit** organisation dedicated to helping talented sporting youth on the NSW North Coast, covering 12 local government areas from Hastings to Tweed Heads.

We provide a service that no other organisation offers in that we specifically focus on **alleviating disadvantages** that **talented junior sub-elite regional athletes** experience in terms of access to quality coaching, competition and sports science.

Being a **community-based** and non-government organisation, the Academy relies greatly on its local communities for support. While the Academy receives financial assistance from Communities NSW Sport and Recreation and Southern Cross University, this equates to around 45% of total income, with the remainder of funds raised from local government contributions, sponsorships, fundraising, donations, memberships and athlete levies.

We are pleased to report that all 12 local government authorities serviced by NCAS provide annual financial assistance to it.

To continue our expanding charter, the Academy hopes to maintain an equitable and consistent level of support from the local councils that we service. NCAS kindly requests that your council accept a rate of **12 cents per capita in support of the Academies programs**. Based on recent population figures, we estimate Ballina Shire Council's contribution to be \$5,000.00, and respectively request this amount.

Ballina Shire Council's contribution will be used to help fund the Academy's service to sport in our region and in particular – Ballina Shire Councils athletes and coaches.

With the inclusion of our new Lone Star Program, NCAS now delivers 12 programs in AWD, basketball, cycling, golf, golf development, lone star, netball, para-sports, rowing, surf lifesaving, tennis and

triathlon.

By the end of 2017, we expect to have around 300 athletes and 75 voluntary coaches, managers and committee members involved with NCAS sport programs.

As well as support for our region's talented junior athletes, the Academy also assists in the development of coaches. In 2017, we will be again conducting the *North Coast Coaching Conference*, at Lake Ainsworth which is open to all coaches across all sports in our region.

Finally, in support of our request for a donation, and to provide your council members with an update on NCAS activities and to showcase NCAS athletes from your shire, NCAS hopes that we could be again invited to make a presentation at one of your council meetings over the next twelve months. 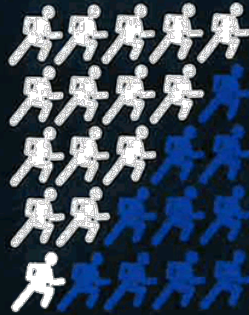

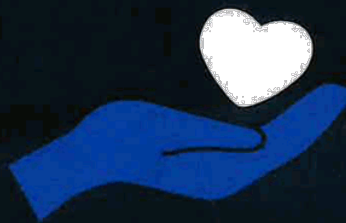

Dear Mr Hickey

As you are aware, the Ballina Tennis Club is about to commence a building project with funds provided by the Commonwealth Government Building Better Regions Fund, Ballina Shire Council and the club's own reserves.

Despite these generous grants, the project budget is tight and the committee feels that some of the fees imposed by Council are not relevant to our situation.

We are required to pay, prior to the issue of a construction certificate, \$5,138 Developer Charges towards the provision of bulk water supply, water reticulation and sewage infrastructure. We submit that these services are already provided to the tennis clubhouse and as it is on Crown Land administered by the Ballina Council, we request that the Council reimburse the Tennis Club for this expense.

I have included a copy of the Developer Charges with this letter.
