4. <u>Deputations</u>

Members of the West Ballina Quays Advisory Group, Rod Faye and Paul Parry made a deputation to the Committee and noted their interest in the Council's canal dredging program and Council's Healthy Waterways project.

5. <u>Confirmation of the Minutes of the Previous Meeting</u>

6. Business Arising from Previous Minutes

Cr Meehan updated the Committee on the following matters:

- Ferry Concession Tickets Council has resolved to discount pensioner and concession card holders season tickets by 50% in the next financial year.
- Federal Funding \$1.1million had been made available to Council for road renewal projects. Council has allocated \$450,000 to River Drive in South Ballina.
- Floodgates at South Ballina advised that a councillor workshop had been held showing them new technology for floodgates. These new floodgates will be trialled at Burns Point Ferry Road
 - John Truman to provide the committee with an update on the progress to install the new floodgates.
- Swimming Pools the electrical substations had been installed. An opening date is yet to be announced, however the pools will be open for a 10 month season.

Porter Park - Toilets

The information in the staff report was noted. George Young asked why these facilities had never been upgraded.

Cr Wright responded that only one facility per year is upgraded.

Ross Pickering advised that since the playground was installed lots of children used the park. Cr Wright suggested that members make a submission to the draft delivery plan that was currently on public exhibition.

8. <u>Council Documents on Exhibition</u>

The list of previously advertised documents was noted by the Committee.

9. Business Without Notice

i) <u>Launch of Ignite Studio</u>

Cr Wright reported on the success of the opening of the Ignite Studio in the old firehouse and advised that an after school program for children was commencing soon.

ii) Pedestrian Crossing at West Ballina

George Young asked when a crossing would be installed.

Cr Wright advised that the response had not changed from previous advice provided by John Truman. The crossing does not meet the warrants required and alternative solutions are proposed in the PAMP.

iii) <u>Congratulations</u>

Andrew Playford congratulated Council on the new road and parking area within the East Ballina cemetery, the foreshore area around the marine tower, and the opening of the new art studio.

iv) East Ballina Lions Club

Andrew Playford thanked Council for the portaloos provided after the loss of their shed from fire.

v) Ballina High School Historical Society

Andrew Playford advised that the Ballina High School had established a historical society for the school and they were seeking donations.

It was suggested that the Society apply for a donation under Council's donation policy, however it is noted as the Society is part of the education system with potential access to Government funds, the application may not be viewed as a high priority.

vi) Tuckean Swamp

In response to a question, John Truman reported an environmental project for the Tuckean was being coordinated by Oz Fish. Council has recently undertaken a research project in collaboration with SCU which examined blackwater land management issues.

vii) Garbage Collections

Margaret Hain asked if the current decision by China would affect Ballina's garbage collections.

John Truman advised that at this stage the costs relating to the changes would be absorbed without fee impacts for Ballina residents. Ballina's recyclables are sent to Lismore and it is likely the materials that can be economically recycled will change. John advised that we have received a grant for a Waste Education Officer and this will assist us to communicate about regulation changes and waste management issues. One of the issues for Council to manage is to reduce the contamination levels of our recycling as contamination results in extra costs and landfilling.

viii) Update from Ballina Bears

Stephen Wills advised that he is in daily contact with the Hon Ben Franklin with regard to a grant for the fence.

Stephen also advised that the flooding in West Ballina was the worst he had seen in years.

Stephen advised that they have not been able to achieve a new lease for Fripp Oval because of issues with the Crown Lands Act not being upgraded prior to their lease expiring. The current lease has been rolled over until next year.

The workers compensation claim relating to the plastic chairs had been finalised and he reiterated previous advice to other members to check on any chairs that they used.

ix) <u>Ballina Lighthouse & Lismore Surf Lifesaving Club</u>

Andrew Doherty advised that the lifesaving season will finish on 29 April 2018. Mr Doherty also congratulated Council on the works done at Lighthouse Beach and Shaws Bay.

Andrew also advised that the storage facility at the surf club is a project that will be completed prior to the next season and that the trial of drones has been very successful. Discussion on the issues surrounding disability access and the future availability of beach wheelchairs, and also the works that could be done on the ocean side were ongoing.

John Truman discussed the presentation held by the DPI regarding the conclusion of the Shark Net Trial and the opening of a community survey. xi) Overgrown Vegetation – Martin Street

It was advised that a customer request had been sent to staff to inspect this intersection.

xiii) Sunken Culvert in South Ballina

Cr Meehan reported the Council was funding the repairs to this culvert.

xiv) Start/Stop Lights near 848 River Drive

Chris Mulder advised that the association was not happy with the outcome relating to the lights and wanted to make a deputation to the Local Traffic Committee (LTC) so that the Police understood the issues.

John Truman advised that the LTC was not the body responsible for this decision and that the lights would stay in that location until the works were done. John offered to send correspondence to the Police asking them to undertake an enforcement program at this location.
