## **Bulk LED upgrade for Category P lighting**

I am pleased to confirm that Light Emitting Diode (LED) luminaires are now available for Category P public lighting, and that Essential Energy is now able to progress bulk LED installation in your Local Government Area in conjunction with our bulk lamp replacement program and scheduled streetlight lamp replacements.

We estimate that over a full twelve months the bulk LED installation throughout Ballina Shire Council area will achieve energy savings of around 202,000 kWh; representing some 20% reduction in total energy use for streetlighting.

Four LED luminaire options are available for Council's consideration. A summary of costs estimated for delivery of each option is provided below, and more detailed costings are attached.

We plan to complete installation work in conjunction with the normal lamp replacement cycle, which is currently scheduled for November 2018 subject to Council's acceptance of the proposal and agreement to proceed. There may be an opportunity to advance these works in the works program. Our estimated delivery timeframe for externally contracted works is three weeks.

Any additional work (minor works) that cannot be undertaken by Essential Energy's contractors for safety or technical reasons will be referred to Essential Energy work crews for completion and will be separately invoiced after these works have been completed.

Essential Energy will provide an interim report and invoice at practical completion of contracted works, and a final report and invoice when all sundry works have been completed.
