Agency Comment:- Ballina Local Environment Plan 2012 Planning Proposal Lot 6 DP 1225206 Skennars head Urban Expansion Area

I refer to your letter dated 8 August 2018 seeking advice for the above Planning Proposal in accordance with the 'Environmental Planning and Assessment Act 1979'.

The NSW Rural Fire Service (NSW RFS) understands the planning proposal will amend Ballina LEP 2012 in the following manner:

- Apply a neighbourhood commercial zoning (Bi Neighbourhood zone) to an area of approximately 13,200m2;
- Apply a medium density zoning (R3 Medium Density zone) to an area of approximately 29,250m2;
- Apply a floor space ratio of 0.8:1 to the area subject to the neighbourhood commercial zoning; and
- Include a site specific local development control provision that would limit the total area of commercial floor space permissible on the site to a floor space ratio of 0.4:1.

The NSW RFS notes that part of the subject land is mapped bush fire prone by Ballina Shire Council.

The NSW RFS has no objection to the planning proposal proceeding and provides the following comment:

Planning Proposal 17/0101 - Skennars Head Planning Proposal

I refer to your email of 13 August 2018 requesting comment from Roads and Maritime Services in relation to the abovementioned planning proposal.

Roles and Responsibilities

The key interests for Roads and Maritime are the safety and efficiency of the road network, traffic management, the integrity of infrastructure and the integration of land use and transport.

The Coast Road is a classified (Regional) road (MR 545). Ballina Shire Council (Council) is the roads authority for all public roads (other than freeways or Crown roads) in the local government area pursuant to Section 7 of the *Roads Act 1993* (Roads Act). Roads and Maritime is the roads authority for freeways and can exercise roads authority functions for classified roads in accordance with the Roads Act. Council is responsible for setting standards, determining priorities and carrying out works on Local and Regional roads however Roads and Maritime's concurrence is required prior to Council's approval of works on classified (Regional) roads under Section 138 of the *Roads Act 1993*.

Roads and Maritime Response

Roads and Maritime has reviewed the referred information. In the absence of traffic information provided within the planning proposal, the Traffic Engineering Report submitted with DA No. 2017/244 has also been reviewed. The following comments are provided to assist the local plan making authority in making a determination;

- Council should note that the calculations within Traffic Engineering Report (submitted with DA No. 2017/244) do not take into account the proposed increase in maximum Gross Floor Area.
- The previous comments provided by the Roads and Maritime in relation to DA No. 2017/244 are generally relevant to this planning proposal.
