I am a property owner on the newly created Seaswell Cres. As I'm sure you are well aware there is a 10m 'Littoral Rain Forest Zone' at the rear of our properties. This LRZ shares a boundary with the parcel of land in question. If this land is divided up and sold, which by the way I also have no objection to, and the new owner wishes to construct a fence on our common boundary, then I will be responsible for half of the cost. Under normal circumstances this would be fair but as these are not normal circumstance I think it would be unreasonable.
