


1. At the close of the survey on 2 November 2018 a total of 298 surveys had been completed.

2. On 11 April 2019 information was obtained that 184 surveys were likely to have been completed using the same device. For the purpose of this analysis the data contained within these multiple surveys has been deleted.


3. A technical issue with the survey instrument arose which meant that people that responded to Question 10 were initially limited to selecting only one response type in each column. This issue was not evident when the survey was tested and appears to have affected approximately 20 responses between survey responses 10 and 31. The issue was corrected as soon as the Planning Department was notified of it and no further issues arose with respect to Question 10.


Question 2- Your Age Category





Question 10c- Retain existing business zoned areas within Wollongbar Village







Question 10e - Consider the easterly expansion of the Russellton Industrial Estate to provide an additional 23ha of industrial zoned land (Strategic Action 9)
