1. I think investigation of expanding Duck Creek into the neighbouring quarry would be more appropriate than spending \$150k on water and toilets.. Water and possibly toilets would already exist on the quarry site. We would be better spending \$150k on setting this up instead of putting toilets and water in the current car park. Long term the site needs to get bigger and have more parking and this expansion has always the local clubs dream. A few years back we met with the GM and he was open to the idea of the quarry rehab plan having an emphasis on mtb and supporting the expansion into the quarry. Perhaps the plan could say something along these lines?

Done properly they could be in keeping with the local environment and reduce tension between mtb and walkers on the new and exisiting paths.

Re: Response to the Ballina Shire Sport and Recreation Facilities Plan

Our organisation provided a community submission to the recent survey sent to Sports Clubs under the title "Ballina Shire Sport and Recreation Facilities Plan" (see copy attached). Our organisation provides classes that involve intellectual, physical and social benefits. Volunteer Tutors provide 35 to 40 classes annually over 4 terms. Over 2,500 contact hours are provided to Ballina Seniors through these classes and social events.

We are disappointed that we were not included in the Council notification to Sports Clubs that the draft plan was available. We are also disappointed that the plan is aimed at Sports only and does not address "Recreation". We believe that this is an opportunity lost. Where "recreation" is referred to it addresses only "active recreation".

Whilst the report refers to the Council's Community Strategic Plan and Community Active Aging Strategic Plan, there does not seem to be any thought to synergies that can occur between these documents. The Council Active Ageing Plan is being fully and comprehensively offered in practice by U3A to its 575 members, without a permanent home or outside funding.

The capacity of some sports facilities in the report is misleading in that it refers to the use by Sports Clubs only. Many of these facilities are left idle during working hours (Monday to Friday) and could be better used for "passive recreation" by the wider community. This is an opportunity lost for a wide spectrum of volunteer community groups who need more permanent venues. If used by other groups when not in use by the sports club, benefits flow to the broader community and Council in the areas economic, security and social wellbeing benefits. With community facilities in short supply this management model needs to be addressed.

Bringing together the Community Aging Plan together and the Sport and Recreation Plan would mean a better use of council facilities across the shire. A perfect example of this is the Situation at Fripp Oval where U3A has been a 'casual' renter for over 20 years and where facilities are shared with the Cricket Club. U3A only uses the premises during each school term, Monday to Friday during business hours, this means there is no clash with usage by any of the sports clubs. Members of the sports club and U3A can support each other with administrative tasks and in financial requirements. However, whilst tenure of sporting facilities is only in effect given to Sporting Clubs the opportunities for active and passive recreation are lost through a lack of facilities and cohesion with other organisations. Bringing the elements discussed in this submission together addresses the lack of facilities available to non-sporting groups and, elements of both the Community Strategic and Active Aging Plans.

Whilst U3A has no age limits for membership, in practice our people are 55+ years of age. The age demographic in Ballina Shire has a >65 age component of 25%, much higher than the state average of 15%. U3A provides important volunteer services to this community and has a huge positive impact on this demographic.

The experience of U3A working cohesively With Fripp Oval Sports Club for 20 years has been of mutual benefit and offered the opportunities to for older members of our community to add positive experiences to their lives. This model expanded across the Shire would help achieve many of the goals mentioned in the Council policies discussed above.

### RE: Ballina Shire Council Sport and Rec Facilities plan for 2019.

### Background:

The Alstonville Tennis Club (ATC) has a total of ten tennis courts, two clubhouses and 226 financial members as at 30 November 2019. The ATC is an efficiently run and financially secure club that is well supported in the community.

The ATC has in the past achieved the following:

- fully funded and built the tennis facility at the Russellton Industrial site that has now been sold.;
- funded all the court resurfacing over the past twenty years on both sites;
- replaced the court fencing at the Lumley park site for \$35k at the clubs expense two years ago.

We pride ourselves in being self sufficient and having minimal financial impact on Ballina Shire Council. The courts are used frequently with competition, social groups and junior competitions.

### Issues:

The biggest issue we have as a club is that we have two facilities that effectively divide the club. Juniors and older members play at Alstonville and the remainder of the club plays at Wollongbar. This issue has been a major factor limiting the existing/ future operations of the club.

The clubhouse located at Lumley Park needs structural work and the two courts on the western side of the clubhouse need resurfacing (Estimated cost \$150k plus). As the clubhouse is built over public toilets and the courts are on Crown Land and leased through council, any work to be undertaken takes years to achieve any change.

### Proposed Rationalisation of Lumley Park/ Wollongbar:

The Alstonville Tennis Club Committee has discussed and supports the idea of rationalising tennis from Lumley Park to the Wollongbar Sports Facility. Rather than spend the money on resurfacing two courts at Lumley Park, the ATC would rather invest the funds into the construction of two additional hard courts at Wollongbar where the existing netball courts are (there is no netball club in Alstonville, un-utilised site at Wollongbar)

The ATC have specified two new hard courts for the following reasons:

- support juniors and coaching needing hard court use for tournaments (all existing courts in the Ballina Shire are artificial grass);

- support the growing population of Wollongbar/ Alstonville; and

- have available courts to use while coaching and competitions are occurring at the same time.

As part of the rationalisation of the ATC the committee would like to extend the clubhouse at Wollongbar to provide an outdoor undercover area for BBQ facilities and provide undercover spectator seating to view courts to the east and west.

The ATC also supports the idea of leaving two courts at Lumley Park for community use. Further discussion on this suggestion is required as storage of equipment is needed for court maintenance. A court booking system would need to be discussed to allow for future court replacement.

### Summary:

The ATC is a community operated and financial secure club in the Ballina Shire. The ATC has a vision to get more people playing tennis and to connect more people to tennis in the Ballina Shire. To do this we must have a tennis facility to allow our vision to be realised. In regards to the Ballina Shire Council Sport and Rec Facilities plan for 2019, the ATC is seeking Councils approval to support the clubs vision in the following order of priority:

1. Rationalise tennis from Lumley Park to Wollongbar;

2. Approve the construction of two tennis hard courts at Wollongbar (funded by ATC/ NSW Tennis);

3. Retain two courts for community use at Lumley Park;

4. Extension of the Wollongbar clubhouse for undercover outdoor area (funded by ATC, Grant, Council);

5. Installation of an online booking system integrated with the lights.

1 Members of Ballina Croquet unanimously support the option of relocation to Cawarra Park (page 49) and endorses this action be given a high priority (page 106) as recommended in the Plan. 2 Ballina Croquet supports that the development of the master plan for Cawarra Park is given high priority (page 108). Ballina Croquet requests that the master plan assigns

a lease/license over an area of land (approximately 1.2 hectares), sufficient for the establishment of a regional croquet centre. Ballina Croquet is a community not for profit incorporated sporting organisation that has the necessary insurance coverage (\$20million) with demonstrated, relevant and appropriate governance to oversee management now and in the future. (page 105)

3 Ballina Croquet requests its relocation and establishment at Cawarra Park of courts and clubhouse be given regional designation, for the Ballina Croquet Centre. The Plan lists the current 'facility hierarchy' as district (page 46). A regional facility has "the capacity, due to its large size, unique function to support activities and events that draw people from across the region and is not replicated across the region." (page 104) The croquet facility will be a centre for events involving Northern Rivers Croquet Association, Croquet NSW and cross border. All communications with BSC (Attachment 1), Ross Planning (Attachment 2), BSC Councillors, Croquet Community (Attachment 3) including CNSW and local clubs and community advocate this planning proposal. Croquet NSW (CNSW) is actively promoting that more state and national competitions be hosted by regional (as opposed to city) venues.

4 Ballina Croquet acknowledges boating as a complementary user of Cawarra Park both in placement, expansion needs and facility requirements such as parking, toilets/change rooms and storage and looks forward to working with other users and Council staff on the masterplan for Cawarra Park (Action No. 6.2, page 108).

5 The adopted plan to give due weight to the unique role croquet plays. Being a tier one sport and recreation activity – more traditional activity, based on the provision of courts and a clubhouse" (page 28) - Ballina Croquet requests that the Plan's infrastructure accommodates current and future demand, physical activity, social engagement, mental health and welfare for all.

6 Ballina Croquet supports the Plan (page 10) and requests BSC ensure its (current and growing) elderly membership - 49, mainly female (page 104) are accommodated by the relocation. Male membership is increasing. Croquet is the only sport included in the Plan that accommodates the elderly, aligns with BSC 'active aging' strategy (BSC

website), BSC 'major regional strategy' 2015-2023 and Draft Delivery Programs (2018-19/2019-2023).

Croquet caters for people with reduced mobility ("disability access") and facilities need to be available for longer periods than is the case with traditional sport involvement (all day, 7 days per week). Statistics and trends that evidence the need for improved sporting facilities for older residents include:

a. "the 65 years plus age group, will increase from 25% to 28.2% of the population in 2036. 45-65 29%"

b. "An ageing population will have different sport, fitness and recreation needs, behaviours and preferences than young adults and families. With many retirees moving to the Shire for the climate and quality of life."

c. "By 2036 an additional 7,781 people will be residing in Ballina."

d. "Demographics moving to the Shire will be mostly retirees, reflecting the trend of the Shire moving towards an older population."

7. In reference to the Plan's comment "Based on the outcomes of the cost benefit analysis undertake a basic master plan for the relocation of the Ballina Croquet Club to Cawarra Park" (pages 49, 108). Ballina Croquet submits (Attachment 4), there is no need to "undertake a cost-benefit analysis of establishing and maintaining 2 croquet facilities within the Shire prior to finalizing options for the relocation of Ballina Croquet Club, and the expansion of the Alstonville Croquet Club." (pages 49, Action No. 2.3, 2.6 page 107) Alstonville Croquet provided a support letter for Ballina Croquet. (Attachment 5)

Ballina Croquet has provided documents, 2017-2019 to demonstrate the case for relocation and sustainability of the new fit-for purpose facility; expansion validated by current demand and projected increased demand, support letter CNSW (Attachment 6) for and viability of the regional centre (BSC Major Regional Centre Strategy 2015-2035, pages 24- key drivers of change, 28 - A2.1, A2.3, 37 character, culture and amenity C1-5) and we submit that a cost-benefit analysis is therefore superfluous. The proposed cost benefit analysis will delay progress of subsequent recommended actions. (Actions 2.3, 2.6 page 107)

8. The Plan recommends re-location to an alternative site. Multiple agencies, BSC, Cherry Street Sport and Recreation Club have advised Ballina Croquet that it was not

possible to expand croquet at the current site. Ref. Submissions 2017-2019, Investigation into expansion on Hampton Park Reserve 2018. Attachment 7. The advice includes that:

a. The current situation at Cherry Street Sport and Recreation Club is untenable.b. A Native Title claim exists over the undeveloped portion of Hampton Park and may delay any work on that portion

c. A review and adoption of changes to the 2005 Plan of Management for Hampton Park' (page 49; Review of the 2005 PoM Hampton Park, Ballina Croquet 2018) would take years and in any event vacant recreation land at Hampton Park is earmarked for car parking and Tennis expansion under the PoM.

d. Ballina Croquet supports the comments on page 49 that [Ballina Croquet] "receive[s] insufficient court time at Cherry Street." and "The Plan reports that Ballina Croquet "receive[s] insufficient court time at Cherry Street." "Membership numbers, competition standard and facility constraints contribute to a case to relocate croquet to a purpose-built facility that can service the Shire's population." (page 49) This comment in the Plan is validated by the current facilities are overwhelmed by the number of current players (2 courts, 125 players, 1 toilet, no accessible toilet, poor clubhouse lighting); restrict the recruitment of new members, particularly children and working adults as well as the elderly; do not meet the female friendly facility principles.

9. Ballina Croquet supports the recommendation of a staged development within the Master Plan (Actions 2.6, page 107 high priority; 6.2 page 108 high priority), ensures the alignment of the project with the availability of funding opportunities within Council's planning and budgets. The application for grant funding to be undertaken jointly with BSC and Ballina Croquet for the Cawarra Park precinct to ensure Council and Ballina Croquet readiness, co-ordination and capacity.

10. The Plan reflects Ballina Croquet's readiness and capacity to relocate, develop and manage a regional croquet facility. (page 104) Ballina Croquet provided a 'Sports Plan/Business Plan' in submissions to Ross Planning. This feasibility study provides the rationale for relocation and establishment of a regional croquet centre. In line with recommendations at the consultation stages that "the analyses should include consideration of community benefit from the project (not just financial analysis)" Ballina Croquet submitted planning details for relocation, an operating budget and a

#### project budget.

Ballina Croquet has provided details on recurrent maintenance expenditure, fundraising efforts towards relocation and ability to project manage in consultation with council staff (Readiness to proceed, page 102)

11. Ballina Croquet submits 'Key Plan Recommendations and Action Plan' amendments are required to clarify priority and certainty

a. Ballina Croquet provided verifiable information to the consultants regarding croquet participation in Ballina and NSW. Despite current infrastructure limitations, Ballina has ~ 125 croquet players and 2 courts. Initial construction of only two new courts as recommended in the Plan (Page 49) does not address current demand, let alone cater for continued growth in the sport. One court accommodates a maximum of 8 players at any one time. 2 courts cater for 16 players. The minimum requirement for current demand is 4 courts. Demand dictates the construction of four courts from the outset. This will:

• capitalise on economies of scale

• allows each club in Ballina to recruit the optimum number of members given the increased days for choice, different focus for each club and increased capacity

• provide scope to broaden the demographic for croquet participation to juniors and working adults

• provide a facility capable of hosting regional and state events (economic benefits to the broader community and increase the profile of croquet in the region.)

b. Ballina Croquet provided verifiable information to the consultants that demonstrates the proposal of an initial 2 courts, Item 2, (page 49) is inadequate for current needs let alone future demand. Ballina Croquet has currently 49 members. The minimum requirement for current demand is 4 courts. The membership of Ballina Croquet has the skills to provide the development of a "quality sport surface to be maintained to competition standard".

c. "Relocate the Ballina Croquet Club [sic] to Cawarra Park and form a Regional Croquet Centre." (Ref. Ross Planning: Ballina Croquet Club Survey, Item 12.1 Kingsford Smith – N/A, 12.2 Cawarra Park, 12.3 Ballina Island, page 6) for Ballina as

another distinct user of Cawarra Park with boating. To allow for the staged development of a site of 1.2 hectares approximately of flat land required to build a purpose-built, multi-use club house, 4 courts initially (2 more courts to be developed as demand dictates), including "suitable change rooms, car parking facilities" irrigation, water tanks, green energy supply. Cawarra Park meets the physical and demographic requirements of the proposed croquet facility. Action Nos. 6.2, page 108 and 2.3, 2.6, page 107)

d. Ballina Croquet supports the Plan's recommendations that the development of Cawarra Park and relocation of Baseball as a high priority. However, the recommendation needs to be more explicit of Council's commitment to the apportioning of funds to Cawarra Park for the establishment of croquet. The development of Chickiba Park to accommodate the relocation of baseball/softball and the establishment of croquet are actions directly linked. Indicative cost \$500,000-\$1million. (Action 6.1, page 108)

e. Croquet is distinct from other sports in that there is no season. Games are sequential and involve a mix of members who may play consecutive games or sit a game out before playing another game. The croquet clubhouse is a cornerstone for croquet, a 'home', a meeting place providing a "sense of belonging and community connection." General community use will be facilitated. Therefore, Ballina Croquet supports a 'sport specific use' facility management model (page 96)

f. Ballina Croquet supports Recommendation 16.2 (page 110) - relocation of Ballina Croquet from Cherry Street Sports Complex, Hampton Park High as a priority. (i) Council and Ballina Croquet responsibility (ii) Cost nil at Hampton Park (iii) Benefit to Cherry Street Sports (CSS) and Cherry Street Croquet Club (CSC).

12. Item 6, (page 49) of the Plan "Cherry St Croquet to negotiate with Cherry St Sports to retain use of the 2 courts. "Alternatively encourage the Club (CS Croquet) to join the Ballina Croquet Club at Cawarra Park." Ballina Croquet submits:i. The 2005 PoM for Hampton Park provides a designated croquet area for 2 courts.

ii. CS Croquet is a sub-club of the bowling club with a constitution that aligns with policies and plans of the Bowling Club.

iii. Ballina Croquet concurs with the report that the current 2 courts are inadequate to cater for the demand of both Ballina Croquet and CS Croquet (125 players)

iv. The Plan does not explicitly acknowledge the benefit to the community of sustaining competition by retaining 2 separate clubs with different governance and focus. Attachment 8, Cherry Street Croquet support letter dated 26.11.19.

13. Ballina Croquet does not agree with the Plan's statement 'At a state level Croquet is experiencing a slight decline'. (page 46) In the past 2-3 years new croquet clubs have been established on the North Coast at Pottsville, Yamba and Iluka. These clubs have a combined membership in excess of 100, but as they are not affiliated with Croquet NSW, these membership numbers are not included in official figures. Member numbers for Croquet NSW are 2015 - 2976 and in 2019 - 3155. Croquet member numbers are being maintained in comparison with many sports where there are sharp declines in participation.

In Ballina there has been a 400% increase in player numbers since 2005 when the PoM for Hampton Park was delivered. Ballina Croquet has a growing membership. In 2015 there were 32 members, in 2019 there are 49 members. This represents a growth of approximately 10% per year. Unfortunately, opportunities to promote membership are limited by the over-subscribed facilities in Ballina. Given the evidence of recent player numbers increase it is anticipated that Ballina Croquet will have 80 members within 2 years of the new facility opening; a growth of approximately 15% per annum.

14. Ballina Croquet urges BSC councillors and staff to support the facts and points made in the submission and promote their inclusion in the adopted Ross Planning Report.

#### Introduction:

Ballina Croquet has operated as an independent community sporting club continuously since 1936. Ballina Croquet members have the skills and knowhow to provide a healthy, socially inclusive sport for the growing elderly population in Ballina. Croquet caters for all walks and stages of life: retirees, students, those still working and visitors. Croquet is a safe sport played all year round. Croquet infrastructure, equipment requirements and participation have cost benefits for community. Croquet is played throughout Australia and is an international sport It is understood to be one of the fastest growing sports in Australia.

Ballina Croquet submits that given the national and international participation in croquet and the Government and Croquet NSW policies that encourage decentralisation and development of regional facilities the Plan's actions include the provision of a regional croquet facility so regional, state and national competitions and training programs can be held in Ballina.

Part 1 of Ballina Croquet's submission sets out Ballina Croquet's support for and detail in relation to the Plan's recommendation of relocation to Cawarra Park (Item 3, page 49) and Ballina Croquet reiterates the Club's willingness and capacity to work closely with BSC to (i) provide a master plan for Cawarra Park and (ii) staged croquet development that will meet the evolving needs of the croquet community and (iii) allow BSC to take advantage of government funding opportunities and (iv) to work within BSC's planning priorities and strategic policies.

1. Users for the regional facility at Cawarra Park to ensure optimum community benefit:

• Ballina Croquet – club and membership needs, through scheduled activities, play

days and social events (Friendship days, team building, leisure activities including social Saturdays, parties, fundraising, birthdays). Club motto: All ages, all day, all year
Regional Croquet Centre – venue for competitive croquet and social events: local, regional, state level. Ballina Croquet, NRCA (clubs), Croquet NSW, Australian Croquet Association and across borders – Queensland Croquet Association.

• Boating – enhanced amenity for existing users through improved parking, toilets, change rooms and croquet clubhouse for meetings and social events

• Enhanced usability of the site (particularly for the delivery of the sport), increased participation in sport (improved capacity) – A fourth croquet code, Gateball to be investigated as court space is increased.

• Encourage community use through letting of the facility – croquet courts for corporate events (income generation). Optimal use through all year-round activities targeting new user cohorts, communication through Facebook, website, email, Team Ap and noticeboard display, publication in local papers.

• Tourists/visitors – croquet players across Australia travel domestically to play croquet – Ballina provides an attractive destination with suitable tourism infrastructure e.g. 'grey nomads.'.

• Improved use of open green space and beautification of the site ensures neighbours access to a community resource.

• Community support through improved facilities includes:

o Croquet coaching and mentoring programs for high school students and U3A, working aged.

o Community volunteers (training and meetings) provide ongoing opportunities for increased skills in coaching, officiating accreditation - refereeing, tournament management with associated IT skills, workshops; child protection, new courses and updates/CNSW and CQ officials,

o Community generally (on request) - hire/letting of facilities

2. Funding sources ensure staged developments can be undertaken in the short term and aligned with funding cycles:

• BSC's budget allocations, planning priorities and strategic policies.

• Joint funding submissions. Immediacy of accessing funding opportunities in consultation with council. e.g. Responsible Gambling Grant, \$300,000.

• Avenues for assistance. Council's donations program. Club members' donations. Sponsorship. Fundraising programs e.g. Bunnings Sausage Sizzle, Recycling.

Individual grant applications e.g. croquet equipment.

• Ballina Croquet provides all croquet equipment and internal set up of clubhouse (Ref. Asset & Equip. Register) for 4 courts and 100 members or visitors 10/12

• BC accounts (investment and ordinary)

• Income generation, setting of:

o playing fees (costs per game, per day etc.)

o clubhouse usage (costs to community for regular meetings, team building for business and functions).

• Demonstrated in-kind contributions to club/regional operation including management ability (ongoing training of current and new members ensures knowledge and skills are up to date, effective and responsive to future needs.) e.g. court set up, roles and responsibilities including sponsorship, executive, budget, games, CDBWG, maintenance and house management. Minor equipment.

• 2 Budgets provided to Ross Planning: 1. Daily operating budget, 5year period (2019-2023). Recurrent maintenance projections have been calculated. 2. An infrastructure budget for the establishment of the new croquet facility. The composition of the Croquet Development Ballina Working Group ensures successful management of the project in co-operation with BSC.

• Clubhouse open space supports income generation as a funding source (letting to community, fundraising events) to ensure long term sustainability. Supported by experienced management committees.

• Reporting and accountability: Performance measures for tasks and activities will be outlined with milestones towards project completion. Elements/activities such as resilience building programs, communications plan, workshops, increased participation in sport across the community and self-funding and operational initiatives to be outlined. A contingency category advised in-case of an escalation allowance (increased costs).

3. Infrastructure listed for the development of a new croquet facility:

The construction of a fit-for-purpose regional croquet facility at Cawarra Park.

Ballina Croquet is willing and capable of working closely with BSC to provide a staged croquet development at Cawarra Park that will meet the evolving needs of the croquet community and allow BSC to take advantage of funding opportunities and to work within BSC's planning priorities and strategic policies. The new croquet facilities

will comply with female friendly facility principles, guidelines and templates. The final development to provide:

• six croquet courts with irrigation (bore water, recycled, tanks, large catchment – roof area)

• a multi-use, fully accessible club house with direct access to the croquet courts to incorporate:

kitchen: wall mounted - oven, hotplates, microwave, cupboards and refrigerator (regulation height/ease of access safety/industrial standards);

meeting room (multi-purpose space) for croquet members;

community usage e.g. letting enables a permanent income source;

storeroom for club croquet equipment: see BC Asset and Equipment Register 2019 e.g. crockery and cutlery for 100; wall mounted honour boards; historical items; amenities (showers and toilets): disability/female/male (internal and external access – need to ensure suitable width for outside entry), change rooms x 2 with showers; lockers: provide storage for player's needs e.g. mallets and a permanent income source);

officials' room includes computer and software for management of tournaments, filing cabinet, all club records

shaded spectator area connected to main clubhouse;

storage for equipment including grounds machinery, irrigation controls

rubbish bins (fixed) x 3

water bubbler x 2

Other: mains water to clubhouse; lighting to appropriate standard; first aid kit, defibrillator, 2 types of fire extinguishers, fans, hand railings -external and internal where needed, level ground, tables and chairs (indoor and outdoor), appropriate flooring.

• shared car parking (ensure size is appropriate for all users including community, croquet and boating).

• sun shelters to each court

• court lighting (courts x 2)

• solar power to club house

• security system

• beautification and fencing

Minimal requirements per Stage 1 - clubhouse shell with core needs include car parking for site users, and Stage 2 – completion of the internal fit-out of the clubhouse

and additional courts.

See attached revised Croquet Clubhouse Plan and Layout dated 19.11.19. Note the shape has been modified to reduce costs, inform more manageable facility use including open space, ease of stage development and greater income potential. Ballina Croquet reports it has provided and met planning details, function benefits, readiness and asset management to proceed requirements for relocating to Cawarra Park and forming a regional croquet centre in Ballina (page 102).

We commend Ballina Shire Council's development of a new Sport and Recreation Facility Plan (the Plan) and submit the following comments:

The comment, "Ballina Cherry Street Croquet Club have indicated a lack of facilities to accommodate club needs.", on page 48 of the Plan is incorrect and misleading. As a sub club of the Ballina Bowling and Recreation Club (BB&RC) we enjoy the use of two superbly maintained croquet lawns, a very comfortable, serviced club house with adequate croquet equipment storage and all within close proximity to the Cherry Street Sports club. We have neither the desire nor intent to move.

Currently we share the croquet lawns and club house with Ballina Croquet Incorporated, an independent croquet club. Consequently, each croquet club has use of the lawns and club house for 3 days a week with Mondays (day 7) generally allocated for lawn maintenance by the BB&RC Greenkeeping contractor.

We recognise Ballina Croquet Incorporated's desire to relocate from the Cherry Street Sports croquet lawns and establish their own facility which could expand and develop into a regional facility.

We believe the establishment of another croquet facility in Ballina would provide not only immediate benefits to meet current needs of the combined membership of the two Ballina clubs (currently 120) but would provide increased facilities to meet anticipated future demand.

Additionally, the Northern Rivers region would benefit from healthy interclub competition and Ballina Shire would benefit from the economic opportunities

of attracting State, National and International events by having two high class facilities in Ballina.

We commend Ballina Shire Council's development of a new Sport and Recreation Facility Plan (the Plan) and submit the following comments:

The comment, "Ballina Cherry Street Croquet Club have indicated a lack of facilities to accommodate club needs.", on page 48 of the Plan is incorrect and misleading. As a sub club of the Ballina Bowling and Recreation Club (BB&RC) we enjoy the use of two superbly maintained croquet lawns, a very comfortable, serviced club house with adequate croquet equipment storage and all within close proximity to the Cherry Street Sports club. We have neither the desire nor intent to move.

Currently we share the croquet lawns and club house with Ballina Croquet Incorporated, an independent croquet club. Consequently, each croquet club has use of the lawns and club house for 3 days a week with Mondays (day 7) generally allocated for lawn maintenance by the BB&RC Greenkeeping contractor.

We recognise Ballina Croquet Incorporated's desire to relocate from the Cherry Street Sports croquet lawns and establish their own facility which could expand and develop into a regional facility.

Thank you for the opportunity to provide feedback in relation to the Sport and Recreation Facility Plan. The Draft report produced is a comprehensive one.

My comments for your consideration when finalising this report are:

**Page 6**: The sport and active recreation list could consider including the ninja warrior style sport and outdoor fitness activities. Ninja Warrior has a high profile through national TV shows in recent years. This show was very popular with the younger demographics in Ballina (teeenagers).

Linked to this is a need for outdoor fitness equipment in Ballina. This form of recreation equipment would be very beneficial to a wide variety of ages (young and old). Many LGAs in NSW and QLD has invested in outdoor fitness equipment and I know that many would enjoy this equipment. Sporting teams would use this equipment but more importantly individuals and small groups who train together would use this equipment. Tourists and visitors to the area would also benefit from this infrastructure.

I agree strongly with the plans focus on gender equity and promoting activities/facilities for girls to use. This form of outdoor fitness equipment provides opportunities for teenage, young female adults and females of all ages really to exercise individually or in small groups.

Shaws Bay precinct would be a good location (a previous Pop Denison Master Plan had included this equipment I believe) for this form of outdoor gym/fitness equipment.

**Page 28:** I did not really understand why swimming and water polo (and skateboarding) were Tier 2 sports? These are Olympic sports and I thought very popular and well established in the Ballina shire and operated within a strong State and National hierarchy. These sports are also reliant on built infrastructure.

The new Ballina pool which I have used a lot since its reopening is a great pool and I commend Council on this facility. It really is a tremendous asset for our local community!

With Council identifying that cricket may not be played at Williams Reserve (this has been identified as a High priority) this provides the opportunity for the removal of the synthetic pitch at Williams Reserve and an increase in the size of the junior playing field that is located at the northern end of Williams Reserve. The cost to remove the synthetic pitch would be minimal and now lighting is in place at Williams Reserve this would allow greater utilisation of the Reserve for winter football codes. If the entire area was grassed this would also increase the flexibility of Williams Reserve to host sporting, cultural and community events.

- Is there an opportunity to look into the World Surfing Reserve (WSR) process? World Surfing Reserves have a strong link to ecological and environmental values which are inherently shared with Coastal processes and protection. I am not sure about the application process but it appears that 1 reserve is declared each year . Lennox is a national surfing reserve so there must be a level of support for this (I am new to Ballina region so not familiar with the history of this process).

Also, I feel that water craft sports being tier 2 may not capture the volume of people that not only use Ballina's beaches, estuaries and creeks in a recreational sense, but also as a natural training ground to further sporting pursuits.

I note that the "diversification of sport" section includes non-traditional physical activities like mountain biking and eco-tourism activities. The report then goes on to acknowledge that typically non-club based activities (like surfing, mountain biking) may not have been captured in the surveys. The "general trends in sport and recreation" outlines that people are preferring passive and active recreation that suits their time.

Given the "trends" and possible gaps identified in the data, it could be interesting to identify some additional items for water sports that may help maintain these natural sports grounds (for example; fences, formalised paths, extra bins, notice boards, coastal restoration, marine clean up, education).

The Sports and Recreation Facilities Plan will be around for a decade or so. With continuing and increasing use of beaches, estuaries and creek systems, perhaps this broader action could be looked into. This may tie into some other programs that are being pursued by Ballina, like healthy waterways, Coastal management and ongoing restoration of the coastal strip.

- Is fishing within this scope? I think similar to water craft sports - it relies on a healthy system to which to participate in. Also the demographics are interesting, I have seen people enjoying fishing across Ballina, aging from 5 to over 75.

I would like to provide comment in relation to mountain biking facilities and specifically the Duck Creek Mountain Bike Park. Since opening, the facility has been very popular and attracts visitors from a broad geographic area (Brisbane, Gold Coast, Armidale, Canberra) with many coming specifically to ride the Duck Creek Mountain trail network. The Draft Sports and Recreation Facilities Strategy identifies opportunities to provide water and toilet facilities at the MTB Park. At present Beta Hire generously provides and maintains a portable toilet which seems to adequately support demand. Most mountain bikers also self cater and bring their own water and generally there is no expectation that water will be available (we are all used to riding in natural areas where these facilities are not generally available).

Based upon present visitation data (which can be obtained from NRDW MTB Club and is based upon onsite trail counters) I would estimate that the current facility has almost, if not already, reached capacity in less than 12 months of operation. I believe that the funds allocated towards water and toilet facilities could be better spent to investigate the option to expand the mountain bike park into the adjoining Stokers Quarry land (water and toilets are available here). This would enable a state of the art facility to be established with increased trail length and diversity to suit different riding genres and abilities (including skills park, downhill and possibly adaptive mtb) and would also enable school sport participation and major events to be undertaken. The NRDW events at the New Italy facility (which include national status events) typically attract about 500 people per day over multiple days and often these people stay over night or for the weekend spending money locally and contributing to the tourism economy of the locality. 212

Mountain Biking is one of the most popular trending sports in Australia at present and is rapidly growing in popularity. The Destination NSW strategy also identifies mountain biking as a key nature based tourism activity. This is an opportunity for Ballina Shire to be a key mountain biking "destination" - build it and they will come!!

RE: Formal submission to the rezoning of Geoff Watt Cricket Oval

Currently there is only one cricket field available within walking distance of the centre of town and adjoining public and catholic private schools. This field also forms a multi-purpose sport facility for athletics related events. This cricket facility is used by primary and secondary school for athletics, general sport and cricket.

Historically cricket has been played on the plateau since 1876 and a move away from such a strong spiritual ground is of significant concern to both past and current players. The Geoff watt oval venue was established with the support of the Rotary foundation along with the many volunteers who donated their time and financial contributions to develop Geoff Watt cricket oval. This wasn't achieved overnight but by hard work over many days/nights and weekends to form a community facility for all not just one sport.

Within the current player base approximately 70% of registered players live within a 5km radius of ground. This is of importance with regards to Geoff Watt Cricket Oval as a training venue. Currently the cricket nets are located next to Geoff Watt oval and form synergy with each other. Basically a ground without nets or vice versa isn't an effective resource for the towns essential training ground.

The proposal states that Pearce's Creek and Gap Rd as alternatives however this will have to be by car, private bus services or council to implement public bus services from town. This extends training time, stress on supervision and ultimately not a healthy environment for cricket. There is also an impact to the environment with more carbon emissions for travel of vehicles, additionally cost which would be born by individuals. With citizens walking the environmental impact is minimalised.

Like many sports we gain interest from children and adults seeing the grounds being used and recruit many new players as we are right in town. If facilities where elsewhere then it's an 'Out of Sight Out of Mind'. The key location of Geoff Watt Cricket Oval means community see sport (especially cricket) being played. This peaks interest, improves participation, healthy lifestyles and combats the new age of technology impacting on active life styles.

With an increasing participation in cricket this year with 7 junior teams there currently isn't sufficient space for cricket based on a Saturday or training. It would be far more effective to have two cricket grounds at Geoff watt oval, one being turf and one synthetic. This could be achieved with the redesignation of parking next to the main road and extending the ground. This effectively

would allow for cricket to build its resources and use the community facility of the Rotary club building at Geoff watt more effectively. This would be during the traditional cricket season only.

416

Cricket isn't impacting other sports by training and running formal games during traditional winter seasons. Perhaps if other sports like football (soccer) require more grounds in summer months they need to look at new grounds at Pearce's creek Wollingbar. Additionally if an all weather venue is required this could be constructed at Crawford Park next to the current clubhouse and amenities.

RE: Formal submission to the rezoning of Geoff Watt Cricket Oval

Currently there is only one cricket field available within walking distance of the centre of town and adjoining public and catholic private schools. This field also forms a multi-purpose sport facility for athletics related events. This cricket facility is used by primary and secondary school for athletics, general sport and cricket.

Historically cricket has been played on the plateau since 1876 and a move away from such a strong spiritual ground is of significant concern to both past and current players. The Geoff watt oval venue was established with the support of the Rotary foundation along with the many volunteers who donated their time and financial contributions to develop Geoff Watt cricket oval. This wasn't achieved overnight but by hard work over many days/nights and weekends to form a community facility for all not just one sport.

Within the current player base approximately 70% of registered players live within a 5km radius of ground. This is of importance with regards to Geoff Watt Cricket Oval as a training venue. Currently the cricket nets are located next to Geoff Watt oval and form synergy with each other. Basically a ground without nets or vice versa isn't an effective resource for the towns essential training ground.

The proposal states that Pearce's Creek and Gap Rd as alternatives however this will have to be by car, private bus services or council to implement public bus services from town. This extends training time, stress on supervision and ultimately not a healthy environment for cricket. There is also an impact to the environment with more carbon emissions for travel of vehicles, additionally cost which would be born by individuals. With citizens walking the environmental impact is minimalised.

Like many sports we gain interest from children and adults seeing the grounds being used and recruit many new players as we are right in town. If facilities where elsewhere then it's an 'Out of Sight Out of Mind'. The key location of Geoff Watt Cricket Oval means community see sport (especially cricket) being played. This peaks interest, improves participation, healthy lifestyles and combats the new age of technology impacting on active life styles.

With an increasing participation in cricket this year with 7 junior teams there currently isn't sufficient space for cricket based on a Saturday or training. It would be far more effective to have two cricket grounds at Geoff watt oval, one being turf and one synthetic. This could be achieved with the redesignation of parking next to the main road and extending the ground. This effectively

would allow for cricket to build its resources and use the community facility of the Rotary club building at Geoff watt more effectively. This would be during the traditional cricket season only.

Cricket isn't impacting other sports by training and running formal games during traditional winter seasons. Perhaps if other sports like football (soccer) require more grounds in summer months they need to look at new grounds at Pearce's creek Wollingbar. Additionally if an all weather venue is required this could be constructed at Crawford Park next to the current clubhouse and amenities.

#### Dear Sir

The Ballina Dragon Boat Racing Club (the Club) would like to express its collective disappointment in the recent published draft plan by Ross Planning. The Club has on several occasions written to the council as well as met with council officers and, most recently, met with the mayor to discuss its needs. At this meeting we were asked to wait for the "**Sport and Recreation Facility Plan 2019**" which would address our needs. Unfortunately, the club believes that the plan has several errors and shortcomings and consequently fundamentally fails to meet or approach the needs of the club.

Key errors of the Ross Plan:

- The plan does not show all the existing outdoor sport and recreation facilities in Ballina. Therefore, the Plan fails in its key objective of "understand sport and recreation participation and needs",
- 2. The plan misrepresents the level of organisation and professionalism of Dragon Boating in the shire
- 3. The plan demonstrates a poor understanding of existing facilities of the Ballina Dragon Boat Racing Club.
- 4. The plan misrepresents the Ballina Dragon Boat Racing Club's responses to the survey
- 5. The plans recommendations do not provide for the needs of the Ballina Dragon Boat Racing club

Specific issues:


#### 1. Existing outdoor sport and recreation facilities in Ballina

As shown on Page 24 of and Figure 1, below, the plan does not show the Ballina Angling Club and the Ballina Dragon Boat Racing Club.

## Ballina and West Ballina sport and active recreation facilities



This indicates that it is incomplete and does not represent the current clubs and facilities in use in Ballina.

#### 2. Misrepresentation of Dragon Boating as a sport.

On page 30 of the plan an analysis is presented of sports and recreation in the community.

Figure 2 (to the right) has a definition of Tier 2 sports and includes Dragon Boating. The definition states that these sports are difficult to capture. less structured, lack formal club or organisation, less reliant on built infrastructure.

This is **not** the case for Dragon Boating. All clubs are very easy to capture, there are state and national bodies that manage all memberships and accreditation, the clubs themselves are very well structured, very well organised and rely on boat ramps and boat houses. The club trains religiously three times a week and has crew list and training plans etc.

#### Tier two

Tier two sports and active recreation activities are typically difficult to capture participation and membership numbers due to the less structured nature of the activity. They often lack of a formal club or organisation. Additionally, these activities are less reliant on built infrastructure, often utilising the natural environment. They include a number of emerging sporting activities.

The tier two activities included within this Plan are:

- □ Archery
- Equestrian Sports
- Model Craft Sports
- Mountain biking
- Petangue
- Skate and BMX
- Swimming and Waterpolo
- Triathlon, running and road cycling
- Water Craft (Sailing and Rowing, Outrigger Canoe, Surfing, Dragon Boating).



## **3.** The plan demonstrates a poor understanding of existing facilities On Page 88 of the Plan a table is presented (Figure 3, below).

This table has several obvious flaws:

- It does not show that the Angling Club has a boat ramp, a key requirement of both Dragon Boating and Angling.
- It also does not show that the Ballina Dragon Boat Club has boat storage facilities.
- It locates the Angling club at Cawarra park (reference 12 on image on page 78). The Angling Club is
  on the canal at Tamarind drive, specifically NOT on Cawarra park so that they (and the Dragon
  Boats) can launch safely in most wind conditions.

4. The plan misrepresents the Ballina Dragon Boat Racing Club's responses to the survey The table provided in page 89 (Figure 4) clearly misrepresents the wishes of the Ballina Dragon Boat Racing club.

#### Key issues - Water Craft

Four Water Craft Clubs responded to the Sport and Recreation Facility Needs Plan Survey, A summary of the Club's identified issues are outlined below.

Ballina Dragon Boat Racing Club and the Rainbow Region Dragon Boat Club have indicated a lack of facilities to accommodate their needs of the clubs,



The club priorities are in fact:

Priority One: Would like tenure at its current site in order for it to invest in facilities

Priority Two: Would like permission to construct a storage shed and change facilities

**Priority Three**: Require a site protected from the Southerlies and Northerlies with storage facilities and change/toilet facilities for example at the Angling club or at the Navy Cadets

#### 5. The plans recommendations do not provide for the needs of the Ballina Dragon Boat Racing club

The table of recommendation shown on page 89 (Figure 5) are not consistent with the Ballina Dragon Boat Racing Club's needs.

Based on the facility needs assessment, the recommendations for Water Craft within the Ballina Shire are:

ltem	Recommendation		
1	Building on the Lennox Village Vision Project, undertake an analysis of public toilets at Lennox Head Main Beach (including Ross Park and Lennox Park Reserve) as part of the future master plan and design work		
2	Investigate the feasibility of installing a permanent community shade structure at Lennox Head Main Beach for use by surfing clubs		
3	Undertake a Master Plan of Cawarra Park to include suitable change rooms, storage and car parking facilities to support the local water sports clubs and other user groups at the site		
4	Include provisions for the relocation of Ballina Dragon Boat Club in the master planning of Cawarra Park		
5	Include provisions for the relocation of the Rainbow Region Dragon Boat Club in the master planning of Cawarra Park		

Specifically, recommendation 4. Cawarra park, is **not** suitable for Dragon Boating. There are several issues associated with this,

#### i) Safety -

- the club is the only dragon boat club that has used the waterways around Ballina continuously for the last 5 years and consequently we are acutely aware of the local conditions and specifically the danger associated with dragon boating in strong northerly or southerly winds (which are often the case). In these conditions Cawarra park is not safe for dragon boats, in fact the only sufficiently protected waterway is the canal. At Cawarra park we would launch much less often than we desire (an than we do now) because of the weather.
- Forcing to club to Cawarra park would significantly reduce the club's ability to launch.
- The current location of the club is very well protected, and the club can launch in almost any weather.
- ii) Congestion

The club trains on Monday and Thursday afternoons and on Saturday mornings. This would clash with other users of the Cawarra park in terms of both car-parking, change facilities, and launching.



#### Conclusion:

In conclusion, the Ballina Dragon Boat Racing Club request that the plan be corrected for the flaws outlined above and the following recommendation be included:

The council collaborate with Crown Lands in order for the Ballina Dragon Boat Racing Club to be granted permission to construct a boat shed and change facilities at its current location at Tamarind Drive (subject to development application).

The Club has been in contact with Crown Lands (Mr Endean) who are well aware of the facilities at the Angling Club, Tamarind Drive (Reserve No 57352). Crown Lands have indicated to the Club that if the council support the Club's proposed facilities at the site, then Crown Land would look on an application by the Club favourably. All Crown Lands require for this is a letter from the Council to that effect.

Consequently, Ballina Dragon Boat Racing Club feel that there are few barriers to the needs of the club being met very simply (a letter) and at no cost to council.

We look forward to your response on this issue.

#### SUBMISSIONS - BALLINA SHIRE SPORT AND RECREATION PLAN 2019

#### A. Background

This feedback and submissions to the Ballina Shire Sport and Recreation Facilities Plan 2019 is on behalf of **Northern Rivers Dirty Wheels Mountain Bike Club Inc.** (herein NRDW or the Club).

- NRDW is the largest mountain bike club in the Northern Rivers region and with about 330 members it is a relatively large mountain bike club by Australian standards.

- The Club is growing rapidly with an increase in membership of approximately 50% in the last 12 months.

- Mountain biking was the number 1 sport for participation by respondents to the BSC Sport and Recreation survey with 14.9%.

- The Club currently has 2 junior members who are Australian National Champions in at least one mountain bike discipline and one of them is also an Oceania Champion.

- The Plan identifies that mountain biking is a 'popular and rapidly growing sport'

- Mountain biking is one of the fastest growing sports in the World.

- The Plan identifies that there is a '...mismatch between supply and demand for...' mountain bike facilities in the Region and that additional facilities are required.

NRDW's Ballina Shire mountain bike facility at Duck Creek near Alstonville (herein DC) opened on Christmas eve 2018. This facility is on BSC land and the Club operates the DC under licence. The facility was built by the Club and is maintained by it. NRDW maintains a trail counter at the site to gather information as to usage numbers. In addition, usage data is obtained from the Strava App. These sources have allowed the Club to provide the following information for the period since opening DC up to early November 2019, which is a period of about 10.25 months:

a. There were approximately 23,000 rides at the park which suggests annual usage of about 27,000.

b. About 50% riders are local residents.

c. about 26% of riders came from over an hour away

d. the remaining 24% came from within the Northern Rivers Region or just outside it.

There are 3 bike shops in the Shire and mountain biking equipment is a large and growing part of their trade. They have reported a significant increase in trade since DC opened. Many other businesses benefit from mountain biking visitors including but not limited to accommodation and food and beverage providers.

#### **B. Submissions**

i. It is arguable that mountain biking should be considered a Tier 1 sport for the following reasons:

- Whilst membership of a club is not a pre-requisite for participation a large percentage of mountain bikers are members of a club affiliated with Mountain Bike Australia Inc.

- Clubs in conjunction with local councils, National Park Services in each State and State Forestry Departments provide the majority of mountain bike facilities.

- Built infrastructure in the form of mountain bike trails is a necessity for mountain biking. Such trails are labour and capital intensive to provide with the trails at the DC facility costing about \$40,000.00 per kilometre to construct. They also require regular maintenance.

ii. The Club does not agree that the provision of toilets and water is the highest priority at DC and strongly believes the money could be better spent expanding the site. A local hire company currently provides and services a portable toilet on the site at no charge and mountain bikers are used to providing their own water.

iii. The Club strongly submits expanding the DC site so it is a regional level facility is the highest priority. This could be done by providing NRDW with a licence to construct and maintain trails on the land immediately to the east of the current site which currently contains a disused quarry. This would provide the following benefits:-

a. It would allow the Club to approximately double the number of trails at the site with a corresponding ability for usage to increase.

b. a larger carpark could be provided off Gap Road.

c. It would provide a better site for future infrastructure such as toilets and possibly a club building in the future.

d. It would remove the very great difficulty of finding and obtaining usage of another suitable site within the Shire that has the necessary topography required for mountain biking.

e. BSC is required to rehabilitate the quarry and making it a mountain bike park could be an integral part of that rehabilitation.

f. With the expansion of DC it is reasonable to assume that visitor numbers to the Shire would increase further bringing corresponding additional financial benefits to local businesses.

g. An expansion of DC would bring more riders into the established trail network and discourage land use conflicts such have occurred recently on Skennar's Headland where some illegal trails have been built causing damage to local flora.

#### C. Conclusion

1. Mountain biking is a large and rapidly growing sport within BSC, Australia and World-wide.

2. There is an under-supply of mountain biking facilities in the Shire and the Region.

3. NRDW has a demonstrated track record of being able to deliver world class mountain biking facilities.

#### Dear Sir

The Ballina Dragon Boat Racing Club (the Club) would like to express its collective disappointment in the recent published draft plan by Ross Planning. The Club has on several occasions written to the council as well as met with council officers and, most recently, met with the mayor to discuss its needs. At this meeting we were asked to wait for the **"Sport and Recreation Facility Plan 2019"** which would address our needs. Unfortunately, the club believes that the plan has several errors and shortcomings and consequently fundamentally fails to meet or approach the needs of the club.

Key errors of the Ross Plan:

- The plan does not show all the existing outdoor sport and recreation facilities in Ballina. Therefore, the Plan fails in its key objective of "understand sport and recreation participation and needs",
- 2. The plan misrepresents the level of organisation and professionalism of Dragon Boating in the shire
- 3. The plan demonstrates a poor understanding of existing facilities of the Ballina Dragon Boat Racing Club.
- 4. The plan misrepresents the Ballina Dragon Boat Racing Club's responses to the survey
- 5. The plans recommendations do not provide for the needs of the Ballina Dragon Boat Racing club

Specific issues:

#### 1. Existing outdoor sport and recreation facilities in Ballina

As shown on Page 24 of and Figure 1, below, the plan does not show the Ballina Angling Club and the Ballina Dragon Boat Racing Club.

This indicates that it is incomplete and does not represent the current clubs and facilities in use in Ballina.

#### 2. Misrepresentation of Dragon Boating as a sport.

On page 30 of the plan an analysis is presented of sports and recreation in the community.

Figure 2 (to the right) has a definition of Tier 2 sports and includes Dragon Boating. The definition states that these sports are difficult to capture. less structured, lack formal club or organisation, less reliant on built infrastructure.

This is not the case for Dragon Boating. All clubs are very easy to capture, there are state and national bodies that manage all memberships and accreditation, the clubs themselves are very well structured, very well organised and rely on boat ramps and boat houses. The club trains religiously three times a week and has crew list and training plans etc.

#### Tier two

Tier two sports and active recreation activities are typically difficult to capture participation and membership numbers due to the less structured nature of the activity. They often lack of a formal club or organisation, Additionally, these activities are less reliant on built infrastructure, often utilising the natural environment, They include a number of emerging sporting activities.

The tier two activities included within this Plan are:

- Equestrian Sports
- Model Craft Sports
- Mountain biking
- Petangue
- Skate and BMX

This table has several obvious flaws:

- It does not show that the Angling Club has a boat ramp, a key requirement of both Dragon Boating and Angling.
- It also does not show that the Ballina Dragon Boat Club has boat storage facilities.
- It locates the Angling club at Cawarra park (reference 12 on image on page 78). The Angling Club is
  on the canal at Tamarind drive, specifically **NOT** on Cawarra park so that they (and the Dragon
  Boats) can launch safely in most wind conditions.

4. The plan misrepresents the Ballina Dragon Boat Racing Club's responses to the survey The table provided in page 89 (Figure 4) clearly misrepresents the wishes of the Ballina Dragon Boat Racing club.

#### 5. The plans recommendations do not provide for the needs of the Ballina Dragon Boat Racing club

The table of recommendation shown on page 89 (Figure 5) are not consistent with the Ballina Dragon Boat Racing Club's needs.

Based on the facility needs assessment, the recommendations for Water Craft within the Ballina Shire are:

ltem	Recommendation
1	Building on the Lennox Village Vision Project, undertake an analysis of public toilets at Lennox Head Main Beach (Including Ross Park and Lennox Park Reserve) as part of the future master plan and design work
2	Investigate the feasibility of installing a permanent community shade structure at Lennox Head Main Beach for use by surfing clubs
3	Undertake a Master Plan of Cawarra Park to include suitable change rooms, storage and car parking facilities to support the local water sports clubs and other user groups at the site
4	Include provisions for the relocation of Ballina Dragon Boat Club in the master planning of Cawarra Park
5	Include provisions for the relocation of the Rainbow Region Dragon Boat Club in the master planning of Cawarra Park

Specifically, recommendation 4. Cawarra park, is **not** suitable for Dragon Boating. There are several issues associated with this,

#### i) Safety –

- the club is the only dragon boat club that has used the waterways around Ballina continuously for the last 5 years and consequently we are acutely aware of the local conditions and specifically the danger associated with dragon boating in strong northerly or southerly winds (which are often the case). In these conditions Cawarra park is not safe for dragon boats, in fact the only sufficiently protected waterway is the canal. At Cawarra park we would launch much less often than we desire (an than we do now) because of the weather.
- Forcing to club to Cawarra park would significantly reduce the club's ability to launch.
- The current location of the club is very well protected, and the club can launch in almost any weather.
- ii) Congestion

The club trains on Monday and Thursday afternoons and on Saturday mornings. This would clash with other users of the Cawarra park in terms of both car-parking, change facilities, and launching.

#### **Conclusion:**

In conclusion, the Ballina Dragon Boat Racing Club request that the plan be corrected for the flaws outlined above and the following recommendation be included:

- The council collaborate with Crown Lands in order for the Ballina Dragon Boat Racing Club to be granted permission to construct a boat shed and change facilities at its current location at Tamarind Drive (subject to development application).

The Club has been in contact with Crown Lands (Mr Endean) who are well aware of the facilities at the Angling Club, Tamarind Drive (Reserve No 57352). Crown Lands have indicated to the Club that if the council support the Club's proposed facilities at the site, then Crown Land would look on an application by the Club favourably. All Crown Lands require for this is a letter from the Council to that effect.

Consequently, Ballina Dragon Boat Racing Club feel that there are few barriers to the needs of the club being met very simply (a letter) and at no cost to council.

SUBMISSIONS - BALLINA SHIRE SPORT AND RECREATION FACILITIES PLAN 2019

A. Background

This feedback and submissions to the Ballina Shire Sport and Recreation Facilities Plan 2019 is on behalf of Northern Rivers Dirty Wheels Mountain Bike Club Inc.

#### (herein NRDW or the Club).

NRDW is the largest mountain bike club in the Northern Rivers region and with about 330 members it is a relatively large mountain bike club by Australian standards.
The Club is growing rapidly with an increase in membership of approximately 50% in the last 12 months.

- Mountain biking was the number 1 sport for participation by respondents to the BSC Sport and Recreation survey with 14.9%.

- The Club currently has 2 junior members who are Australian National Champions in at least one mountain bike discipline and one of them is also an Oceania Champion.

- The Plan identifies that mountain biking is a 'popular and rapidly growing sport'

- Mountain biking is one of the fastest growing sports in the World.

- The Plan identifies that there is a '...mismatch between supply and demand for...' mountain bike facilities in the Region and that additional facilities are required. NRDW's Ballina Shire mountain bike facility at Duck Creek near Alstonville (herein DC) opened on Christmas eve 2018. This facility is on BSC land and the Club operates the DC under licence. The facility was built by the Club and is maintained by it. NRDW maintains a trail counter at the site to gather information as to usage numbers. In addition, usage data is obtained from the Strava App. These sources have allowed the Club to provide the following information for the period since opening DC up to early November 2019, which is a period of about 10.25 months:

a. There were approximately 23,000 rides at the park which suggests annual usage of about 27,000.

b. About 50% riders are local residents.

c. about 26% of riders came from over an hour away

d. the remaining 24% came from within the Northern Rivers Region or just outside it. There are 3 bike shops in the Shire and mountain biking equipment is a large and growing part of their trade. They have reported a significant increase in trade since DC opened. Many other businesses benefit from mountain biking visitors including but not limited to accommodation and food and beverage providers.

**B.** Submissions

i. It is arguable that mountain biking should be considered a Tier 1 sport for the following reasons:

- Whilst membership of a club is not a pre-requisite for participation a large percentage of mountain bikers are members of a club affiliated with Mountain Bike Australia Inc.

- Clubs in conjunction with local councils, National Park Services in each State and

State Forestry Departments provide the majority of mountain bike facilities.

- Built infrastructure in the form of mountain bike trails is a necessity for mountain biking. Such trails are labour and capital intensive to provide with the trails at the DC facility costing about \$40,000.00 per kilometre to construct. They also require regular maintenance.

ii. The Club does not agree that the provision of toilets and water is the highest priority at DC and strongly believes the money could be better spent expanding the site. A local hire company currently provides and services a portable toilet on the site at no charge and mountain bikers are used to providing their own water.

iii. The Club strongly submits expanding the DC site so it is a regional level facility is the highest priority. This could be done by providing NRDW with a licence to construct and maintain trails on the land immediately to the east of the current site which currently contains a disused quarry. This would provide the following benefits:a. It would allow the Club to approximately double the number of trails at the site with a corresponding ability for usage to increase.

b. a larger carpark could be provided off Gap Road.

c. It would provide a better site for future infrastructure such as toilets and possibly a club building in the future.

d. It would remove the very great difficulty of finding and obtaining usage of another suitable site within the Shire that has the necessary topography required for mountain biking.

e. BSC is required to rehabilitate the quarry and making it a mountain bike park could be an integral part of that rehabilitation.

I believe the other quarry section linking into the Duck Ck area would really enhance this facility for relatively small investment.To see the local economic and societal benefits from being associated with quality mtb trails one only has to look at places such as Derby in Tasmania and Queenstown in NZ.

Thankyou for the opportunity to provide comment in relation to the draft sport and recreation plan. The main comments I would like to provide are in relation to the possibility of Council spending \$150,000 to put water and toilet facilities in the existing Duck Creek Mountain Bike park. Facilities such as these are a good idea however I wonder if this money would be better spent on expanding the existing trail network of this park down into the old quarry area to the east which I understand is also owned by Council. Expansion of the trails into this area would provide a very considerable benefit. The park is extremely popular with many people from outside the Council area coming to the region to enjoy the trails. Also access into the park as it is currently is from the Bruxner Highway. This for some (particularly riders from outside

the region) can be confusing to get to. It can also be quite dangerous due to the temptation to either turn in and or exit from the park across the highway. Additionally the designated car parking area provided for within park is on many occasions proving to not be adequate. As stated the park is proving to be extremely popular as evident by the large number of cars parked outside the park entrance on both weekends and even week days. If the trails were able to be expanded down into the old quarry area to the east then the main entrance of the park could be moved to Gap Road which as per the reasons outlined above would be a much safer and practical option for car parking. The other benefit of this is that the Club which manages the park would be able to hold events. And finally providing for more professionally built mountain bike trails will benefit tourism for the region – mountain bikers love to travel to find good trails to ride!

Hello, this feedback to the Ballina Shire Sport and Recreation Facilities Plan 2019 is submitted by me in my role as Youth Development Officer for **Northern Rivers Dirty Wheels Mountain Bike Club Inc.** (herein NRDW or the Club) and as a regular participant in the sport.

This year we established a Youth Development program, and the NRDW Youth Crew. We have high school student participation from Ballina Coast School, Byron Bay High School, Alstonville High School, Emmanuel College, Woodlawn College and Evans Head High School. Members of the NRDW Youth Crew competed in the 2019 Schools National MTB Championships, as well as the Gold Coast Schools MTB event in September. We also have a skills, social, and health development program for kids 6 - 16. Our youth program is going from strength to strength. With 5 local teachers joining in to help organise, we expect it to continue to grow rapidly.

- NRDW is the largest mountain bike club in the Northern Rivers region and with about 330 members it is a relatively large mountain bike club by Australian standards.

- The Club is growing rapidly with an increase in membership of approximately 50% in the last 12 months.

- Mountain biking was the number 1 sport for participation by respondents to the BSC Sport and Recreation survey with 14.9%.

- The Club currently has 2 junior members who are Australian National Champions in at least one mountain bike discipline and one of them is also an Oceania Champion.

- The Plan identifies that mountain biking is a 'popular and rapidly growing sport'

- Mountain biking is one of the fastest growing sports in the World.

- The Plan identifies that there is a '...mismatch between supply and demand for...' mountain bike facilities in the Region and that additional facilities are required.

NRDW's Ballina Shire mountain bike facility at Duck Creek near Alstonville (herein DC) opened on Christmas eve 2018. This facility is on BSC land and the Club operates the DC under licence. The facility was built by the Club and is maintained by it. Usage data shows that for the period since opening DC up to early November 2019, which is a period of about 10.25 months:

a. There were approximately 23,000 rides at the park which suggests annual usage of about 27,000.

b. About 50% riders are local residents.

c. About 26% of riders came from over an hour away

d. The remaining 24% came from within the Northern Rivers Region or just outside it.

There are 3 bike shops in the Shire and mountain biking equipment is a large and growing part of their trade. They have reported a significant increase in trade since DC opened.

Many other businesses benefit from mountain biking visitors including but not limited to accommodation and food and beverage providers.

#### **B.** Submissions

i. It is arguable that mountain biking should be considered a Tier 1 sport for the following reasons:

- Whilst membership of a club is not a pre-requisite for participation a large percentage of mountain bikers are members of a club affiliated with Mountain Bike Australia Inc.

- Clubs in conjunction with local councils, National Park Services in each State and State Forestry Departments provide the majority of mountain bike facilities.

- Built infrastructure in the form of mountain bike trails is a necessity for mountain biking. Such trails are labour and capital intensive to provide with the trails at the DC facility costing about \$40,000.00 per kilometre to construct. They also require regular maintenance.

ii. The provision of toilets and water is not the highest priority at DC. The money could be better spent expanding the site. A local hire company currently provides and services a portable toilet on the site at no charge and mountain bikers are used to providing their own water.

iii. Expanding the DC site so it is a regional level facility is the highest priority. This could be done by providing NRDW with a licence to construct and maintain trails on the land immediately to the east of the current site which currently contains a disused quarry. This would provide the following benefits:-

a. It would allow the Club to approximately double the number of trails at the site with a corresponding ability for usage to increase.

b. A larger carpark could be provided off Gap Road.

c. It would provide a better site for future infrastructure such as toilets and possibly a club building in the future.

d. It would remove the very great difficulty of finding and obtaining usage of another suitable site within the Shire that has the necessary topography required for mountain biking.

e. BSC is required to rehabilitate the quarry and making it a mountain bike park could be an integral part of that rehabilitation.

f. With the expansion of DC it is reasonable to assume that visitor numbers to the Shire would increase further bringing corresponding additional financial benefits to local businesses.

g. An expansion of DC would bring more riders into the established trail network and discourage land use conflicts such have occurred recently on Skennar's Headland where some illegal trails have been built causing damage to local flora.

#### C. Conclusion

1. Mountain biking is a large and rapidly growing sport within Ballina Shire, Australia and Worldwide.

2. There is an under-supply of mountain biking facilities in the Shire and the Region.

3. NRDW has a demonstrated track record of being able to deliver world class mountain biking facilities.

4. The best use of the land making up the old quarry to the east of the DC facility would be to allow expansion of the DC facility on it.

6. This would reduce land use conflicts; provide additional facilities to Shire residents and visitors and bring additional substantial economic, social, and health benefits to the Shire.

On behalf of the Lennox Head Rugby Union Club I commend Council on the production of the Draft Sport and Recreation Facility Plan and thank Council for the opportunity to provide feedback on this Draft plan. The report is a comprehensive and detailed one and provides a good overview of the sporting facilities in our LGA.

We note with interest the section on Williams Reserve and rugby union. As can be seen from the report rugby union is a popular sport within the Ballina LGA (particularly at a junior level) and we are confident our numbers will continue to grow as the population of Lennox Head and Skennars Head continues to expand.

With the lighting upgrade at Williams Reserve largely complete Rugby Union is poised to take advantage of this growth. One of the limiting factors we have faced as a club is having enough playing fields to support the large numbers of juniors we have. The lighting upgrade at Williams Reserve now allows us to now play many more local junior games week to week and increases our space available for training.

As Council has identified that cricket will not be played at Williams Reserve there is an opportunity to remove the cricket pitch at Williams Reserve, re-grass this area and provide further space for the second rugby field. This extra space will also allow for other field configurations (e.g. two smaller fields) as the need arises (gala days etc).

The report states that Lyle Park and Quays Reserve are the home of rugby union in the Ballina Shire with Williams Reserve as a local facility? We think that with the lighting upgrade and the continued strong growth of player numbers the Trojans are on at least equal pegging with the other local rugby union clubs within the shire.

We would like Council to note that the Trojans, like many other clubs, have a need for enhanced and upgraded facilities. Consistent with many other clubs we need:

- female friendly change facilities
- better storage
- disability access to the clubhouse (with toilet upstairs)
- canteen upgrade



We also have been seeking an upgrade to the playing surface for some time and believe that this is a priority for us and other users (formal and informal) of Williams Reserve.

We again thank Council for the opportunity to provide feedback to the Draft Sports Facility and Management Plan and look forward to working with Council into the future to assist in providing the residents of the Ballina Shire with opportunities to participate in and enjoy sport.

Dear Ballina Shire Council, thankyou for the opportunity to provide some comments in relation to the draft sport and recreation plan. On a personal level I own and operate a bike shop in Lismore (Harris Cycles). I sell both road and mountain bikes. Since the expansion of mountain biking in recent years in the Northern Rivers and particularly so since the opening of the Duck Creek Mountain Bike park at Alstonville I personally have noticed a major increase in interest from people wanting to get into the sport of mountain biking. Obviously this has provided benefit to me personally and my shop but there are many follow on benefits – increased tourism into the region, increased general health and fitness of more and more people. In relation to the draft sport and recreation plan I note that there is the possibility that Council may spend \$150,000 on

water and toilet facilities at the Duck Creek mountain bike facility. This is a good idea however I wonder if in the short term this money would be better spent expanding the existing trails of that park onto the Council owned land directly to the east (the old quarry area). If this was allowed than it would be possible to move the existing car park down to this area. This would be a much safer entrance for riders as it is off Gap Road as opposed to the current entrance from the Bruxner Highway (which can be both confusing and dangerous for people coming into and leaving the park). Having the main entrance and car park at Gap Road would also presumably provide a larger car park than the current one which based on the amount of cars I see outside the main entrance of the park (particularly on the weekends) is clearly not large enough to cope with the popularity of the mountain bike park. Installing toilet and water facilities would presumably take up more room within the existing car park? which is already not capable of supporting the current demand. Ultimately it would be my recommendation to allocate this money available to more trails now and later as the park becomes larger to expand the support facilities such as toilets etc. Again, thankyou again for providing people with the opportunity to provide comment in relation to this.

#### **Re Draft Sport and Recreation Facility Plan**

The Ballina District Cricket Association (BDCA) administers and conducts senior cricket competitions for Cricket Clubs based in Ballina and Byronm Shire Council areas.

The BDCA has reviewed the above document, and is most concerned regarding the future proposals for cricket facilities in Ballina Shire.

There are 4 Ballina Shire-based cricket Clubs affiliated with the BDCA -Alstonville, Ballina Bears, Tintenbar-East Ballina and Lennox Head. Alstonville, Tintenbar-East Ballina and Lennox Head have 4 senior teams and Ballina Bears 3, and all clubs have a varying number of junior teams (Alstonville and Lennox Head with the most). Ballina Bears and their use of Fripp Oval and Saunders Ovals did not even rate a mention in the document.

Both the BDCA and the Balllina District Junior Cricket Association are working closely with Cricket NSW to grow the game in this region. Whilst we greatly appreciate the efforts of your Council to provide new facilities for cricket (Wollongbar sporting fields, and Epic sportsfields in Lennox Head), this should not be aligned with the removal of other grounds from cricket activities (Geoff Watt Oval, Skennars Head and Williams Reserve).

Geoff Watt Oval has a long history of cricket for both the Alstonville Club and the BDCA – all cricketers enjoy playing on this ground due to its location and amenity. Without full knowledge of the proposed upgrade to the Gap Road fields, it is difficult to accept the removal of cricket activity from Geoff Watt.

The Gap Road fields are not currently of good standard for cricket – rabbit holes on fields, bottom field is not level, field surrounds result in many lost balls due to dense vegetation on some boundaries, and facilities are very poor.

The new fields at Epic are a great addition, however the provision of facilities is urgently needed.

The BDCA request that Council undertake extensive consultation with us and our affiliated Clubs as this Plan is further developed.

Ballina Netball Association, in reference to the above membership is capturing an extended distribution due to the success and engagement of our association. Our focus for 2020 is to grow the membership base and engage the extended community through existing and new initiatives, including walking netball, mixed competitions and all abilities inclusion and growth. Our recent success in State Titles competitions (2 teams placing 1<sup>st</sup> in their respective divisions) and our Regional State Cup success (Opens team placed 4<sup>th</sup>) are testament to the added exposure we will receive in 2020.

## **Functional Requirements**

Based on Netball Australia national facilities policy functional requirements for the proposed facility should include but not be limited to:

- Change rooms
- Umpires change rooms
- Public toilets (including appropriate accessibility)
- Competition/Administration office /Meeting room
- First Aid room
- Kiosk/Canteen
- Kitchen
- Social area
- Storage
- Spectator seating and shade
- Warm up areas

## Green Systems Considerations

Considering the life expectancy of the building would be 50+ years, the opportunity to incorporate green systems into this development would be highly regarded by netball members and supporters alike.

For example the inclusion of:

•Water refill stations to eliminate single use plastic bottles;

Solar panels;

•Led lighting and movement sensors for energy consumption;

•Grey water reuse and water tanks capturing roof water;

•Sustainable building materials.

After close discussion with Netball NSW they have advised that Netball Victoria has specific guidelines for essential and desirable components and sizes of specs to sharpen the focus and relevance which could help the facility proposed, house a successful operating environment.

## **Key Issues**

The Ballina Netball Association lacks of facilities to accommodate the current and growing needs of the community. Our priorities have changed since the completion of the survey, due to the fire which destroyed our clubhouse.

See below current issues on behalf of all affiliated clubs:

Association priority 1: A facility/clubhouse to operate out of - currently non existent due to fire. Associations priority 2: Lighting-currently not suitable. Glass fragments are often falling onto courts and lights turn off for periods of time leaving players in complete darkness. Association's priority 3: No electricity. Toilets - none. Road access - general safety. Foot access - safety for all abilities. Safety/security – location is close to bushland often occupied by the homeless. Ashpalt playing courts - lacking in number of. Condition of current playing courts - cracked with grass protruding which poses a danger to players. Change facilities - none. Canteen facilities - none. Storage - temporary container that leaks. Car parking – none. Spectators area - none. Seating/shade - no seating, extremely limited shade/shelter. Water access – 1 tap.

Maintenance standard – poor.

Also of note. The report includes the mention of fifteen grass netball courts. This area has no goal posts, no court markings and has not been used by Ballina Netball for over 10 years. It is our understanding that this area is Crown land that has been allocated for caravan park development and is not available for netball redevelopment. Netball is not played on grass, however the extension of the asphalt courts should be considered.

## **Future Facilities Direction**

The needs of Basketball to Netball are vastly different. However, they have been but have been grouped similarly in the draft report in the recommendations section. Further advice why this is the case would be appreciated.

Low participation rates outside of Ballina are reflective of the lack of facilities in these areas. Ballina and Lennox head attract the highest numbers of participants as courts are located close to schools and bus interchange. Apart from new Wollongbar courts, all participants of netball in Ballina shire must train and play on the same 6 courts at Kingsford Smith. Consideration should be given to either expanding the current facility in Ballina and/or providing training courts in other areas. The Ballina Netball Association is unsure if sporting facilities planned for the EPIC development at Hutley Drive include netball courts. Any advice regarding this would also be appreciated.

The courts are used by many schools, private and public within Councils jurisdiction. These events run all day and the lack of amenities threatens the future utilisation of the facility not only for our association but for school sporting programs due to the lack of facilities since the fire.

We are very keen to be an active participant in the development of a sporting precinct in partnership with our neighbours, hockey, cricket and football. Our concerns at present however are around how we will continue to operate our successful competitions and continue our development pathways for young athletes be it netball players, coaches or umpires.

#### Lennox Head Cricket Club – Submission to the draft document as it relates to cricket

17<sup>th</sup> December, 2019

#### Player numbers (LHCC)

The assumption that cricket participation is in decline should be made very carefully and considered:

Lennox Head Club player numbers have remained fairly stable over the past 5 years. The assumption that cricket participation should be made very carefully and considered. However, recent junior participation in the age group of 4 to 10 years of age has increased significantly. To our knowledge Lennox Head has far more cricketers in this age group than any other club. This increase is expected to continue and also carry through to the older junior and more competitive grades in years. It is important that we can cater for the training and playing needs of these players. This season 2019-20 we have had to restructure our training schedule to accommodate the extra players and a lack of suitable training facilities that need to be shared between senior and junior cricket.

#### Local training and playing facilities (LHCC)

The removal of cricket from Williams Reserve is one of the recommendations in the plan: Removal of cricket from Williams Reserve would be an extremely undesirable outcome for Lennox Head Cricket Club. Williams Reserve is a very important cricket facility for junior cricketers of Lennox Head Cricket Club. Its proximity to Lennox Head Public School makes it valuable in terms of ease of access after school hours for junior training. It cuts down on transport and parking problems in the community and assists with participation and volunteer involvement. Junior cricket eg. On a Saturday morning at Williams Reserve is also a vital part of the community where juniors love to play in front of their home-town supporters. I am sure other winter codes feel the same way. It also plays a role in supporting local business and commerce in the Lennox Village. Williams reserve has a sand base which makes it perfect for cricket when summer rains arrive, which can impact other field significantly. We believe Williams Reserve should be retained for junior cricket. This would allow for separation of juniors and seniors at training sessions, with the hopefull installation of cricket nets at Hutley Drive. This is important, as there is currently some safety risk concerns in sharing nets between juniors and seniors when player / team numbers are high and overcrowding of the facility can bring on more safety issues.

#### **Megan Crescent irrigation**

#### The recommendation to install irrigation at Megan Crescent:

This recommendation is very welcome. The field is currently used for Junior Cricket on Tuesday afternoons (under 11s), Friday evenings (under 10s), Saturday mornings (Under 14's and Under 16's) and Saturday afternoons (senior cricket). Additionally, the field is used for a range of non-organised and organised sports including touch football, althletics training, school cross country events, winter football codes training (especially when other fields are too wet to train on). The field surface needs rehabilitating including major relevelling and significant reestablishment of the turf itself after what has been two years of drought. The field surface is currently dangerous. Any improvement works will need to be supported by irrigation, and ongoing management through irrigation and turf nutrition and maintenance will be critical.

#### **Final summary**

The assertion that player participation in cricket is declining should be investigated. Lennox Head is experiencing significant population increase, especially those with families. Player numbers for our youngest cricketers continue to be at record highs and will no doubt rise. We need to support these cricketers by retaining the important facilities in the Lennox Head village. The new fields will be very welcome to our senior cricketers. We hope to make the Hutley Drive field a home for senior cricket in the long-term, and we hopeful of constructing a turf wicket, along with the proposed training nets to support our grade seniors in the near future. We envisage we will need the following:

- Megan Crescent Oval for juniors and senior cricket
- Williams Reserve for junior cricket including training
- Hutley Drive for senior and junior cricket (including training)

We welcome this draft plan but hope to be involved in further consultation as a final plan and significant improvements to local sport and recreation in the shire are implemented. Thank you.

# **Ballina Touch Association**

Submission to Ballina Council Draft Sport and Recreation Plan December 2019

# Introduction

Thank you for the opportunity to comment on the Draft Sport and Recreation Plan.

Ballina Touch endorses the concept of a Sport and Recreation Plan to assist in determining priorities for funding and development of sporting facilities within the Ballina Shire.

Ballina Touch was formed in 1978 and is one of the oldest Touch Football Associations in Australia. It was also one of the first associations to offer a dedicated women's competition and has a proud history of providing representative players to Regional, State and National teams.

The sport of Touch is growing and this is reflected locally with our number of teams growing each year. In particular our junior competition has experienced significant growth over the last 5 years increasing from 138 teams to 181 teams for the current season. Our representative program is also growing with the number of teams attending representative events growing from 6 teams (across junior and senior events) 7 years ago to 17 for the 2019 calendar year.

Our home is Saunders Oval – a facility that the association has put considerable cash and volunteer resources into developing and operating. We share the facility with the Ballina Soccer Club. Our clubs get on well and work cooperatively to manage the facility for the benefit of both sports and the wider community. The Ballina Sports Club is the vehicle which formalises our joint contribution and management of the existing clubhouse.

Examples of our commitment and investment into this facility include:

- The clubhouse being built with volunteer labour from both Touch Football and the Soccer Club.
- The club being part of the Ballina Sports Club, jointly with Ballina Soccer, to operate and maintain the clubhouse meeting all operational, maintenance and capital replacement costs since it was first built.
- Making the clubhouse available, via the Ballina Sports Club, to other community groups for use at minimal rental e.g. Ballina Pipe Band rehearsals every Monday night.
- The club, through the Ballina Sports Club, paying all electricity costs for our use of the lighting at Saunders Oval, including any costs for non-Touch/Soccer users on the odd occasion that others use the facility e.g. AFL.
- Meeting the cost of a new PA system for Saunders Oval in 2017.
- Recently contributing \$35,000 towards the upgrade and installation of additional flood lighting at Saunders Oval.
- Undertaking all of our own line marking of fields at Saunders Oval.

# Consultation

It is unfortunate that the consultant did not contact Ballina Touch for direct feedback or input to the draft plan. Our club was not afforded the opportunity to complete the survey that many other clubs

appear to have completed and that fed into the draft document. Our club would appreciate the opportunity of a meeting and discussion with the consultant to discuss our sport in general and the contents of this submission prior to finalisation of the plan.

# Touch and OZTAG

Categorisation of Touch as a Tier 1 sport is supported given our membership and participation levels. We are one of the few sports offered within the shire, if not the only sport, that caters equally for adults, children, male and female and all abilities participants.

We do not agree with the sport of OZTAG being grouped with Touch Football. There are a number of significant differences between these sports and we therefore request that OZTAG be removed to its own listing in the appropriate category – we do not believe it would meet the criteria for a Tier One classification. The reasons for this are:

- OZTAG is a completely different sport played under different rules and has a different governance model to Touch. Grouping Touch and OZTAG would be like grouping Rugby League and Rugby Union together.
- OZTAG as a sport is run on a franchise model whereby individuals that own the franchises run the competitions as an income generator. Touch is run as a not for profit association of volunteers and governed by state and national bodies.
- OZTAG is played at a completely different venue to Touch.
- OZTAG has a vastly lower participation rate than Touch and by grouping it with Touch is being elevated in importance via the strength of our numbers and participation.

# **Maintenance Issues at Saunders Oval**

The plan states in the key issues for OZTAG/Touch section that Saunders Oval is over-used and therefore has high maintenance costs. The high maintenance costs are associated with repairs needed to the ground surface after the completion of the winter season. The vast majority of these repairs are a result of the high use of particular areas of the soccer fields.

This is not to blame soccer for the damage but is a function of the nature of the game and that it is played in winter when grass is not growing and does not recover form the wear and tear:

- In front of goals,
- In the 18 yard goal area in general,
- Along the sideline where sideline officials walk up and down in only half of the field creating a goat track of no grass.

Touch football as a game does not have these concentrated areas of activity on the field of play and cannot be held responsible for general damage to the playing surface, and especially the damage caused by the sideline officials.

The area of the sub box in a game of Touch, which is off the field of play, is an area of concentrated activity and coincides with the area in front of goals on the soccer field. However this is simply people milling around waiting to enter the field of play when a substitution is required. It is acknowledged however that this would be exacerbating the damage in those areas during winter seasons.

To address this issue the draft plan recommends specific fields be allocated for each sport at Saunders Oval. We would require further information on what this means for our sport and field

allocations. Ballina Touch will not support any proposal that reduces our access to the facilities we need to run our growing competition.

#### **Club Priorities**

The priorities for our club are:

- Major renovation and upgrade/extension of the clubhouse. The facility is quite old and does not meet current standards in relation to building code, accessibility, canteen and toilet facilities. It is also too small for us in regard to our activities and has no reasonable sized under cover area for protection from the weather, rain etc. Whilst the draft plan reflects some of these issues a complete description of what is required is as follows:
  - a. Extension of the upstairs area of the clubhouse to the north to the edge of the embankment/tree area. The space to be roofed and the existing indoor upstairs toilets to be relocated and rebuilt on the western side of this extension. This would increase the indoor space in the clubhouse, provide a larger undercover outdoor viewing area (upstairs) and provide an undercover area at ground level for users of the facility. The current configuration and roofline of the building readily lends itself to this type of extension.
  - b. Extending in this direction would allow use of the embankment to facilitate construction of an access ramp to improve accessibility to the upstairs area and remove the existing internal staircase at the northern end of the building. This space could then be used to extend the canteen downstairs, and along with the relocation of the upstairs toilets, create additional indoor space upstairs.
  - c. Complete refurbishment and upgrade of the existing downstairs male and female toilets in the building.
  - d. Extension and upgrade of the canteen to meet current standards.
  - e. Construction of a four bay shed for storage. We currently have a significant challenge with storage to the extent that some club equipment is stored in a trailer at a member's home.
  - f. Bitumen sealing of the car park immediately to the rear of the clubhouse.
  - g. Ground renovations to level the area we know as fields 8 and 9.
  - h. Sub-soil drainage across the entire Saunders Oval area to address drainage issues during extended periods of wet weather.

# **A Bigger Picture**

Whilst the draft plan sates that Saunders Oval is a local facility meeting the needs of local clubs, it needs to be recognised that it hosts regional events for the Sport of Touch. In recent years the venue has regularly hosted these types of events including:

- 2017 NSW Touch Junior Regional Championships involving 36 teams from the 6 NSW regions. This brought approx. 600 people to Ballina for the 2 day event and injected approx. \$1.2 million into the local economy.
- Annual Catholic Schools Polding Diocese Touch Carnival and Representative Selection tournament. The full venue at Saunders Oval is used for this event with schools attending from Port Macquarie in the south through to the Qld border. U15 and open age division representative sides for boys and girls are selected from the event to represent Polding at the relevant state carnival.
- Annual NSW Touch All Schools events Primary Schools, Year 7 and 8; and Year 9 and 10 events (all separate) with teams participating from across the region.

 Ballina Touch annual; junior galas day held in early February each year as a warm up event for representative teams across the region for the NSW Junior State Cup held in Port Macquarie in mid-February. We typically get 35 - 40 teams attending this one day event.

It is expected that the venue will continue to host these events into the foreseeable future.

#### **Prioritisation Model**

The proposed prioritisation model is noted, however there are aspects of it which are unclear. There are a number of the criteria which require plans, studies, analysis and modelling as inputs to decision making. Who is to prepare these documents? Many will require significant funds to address and this is a financial burden that many clubs, all of which are run by volunteers, would struggle to meet the cost of.

It is suggested that further discussion is needed with all clubs around how this system would work, and in particular, what clubs are responsible to provide and what the Council will provide as inputs to decision making.

Once again thank you for the opportunity to comment and we look forward to hearing from Council and the consultant to discuss the plan and our submission further.

Dear Sir/Madam,

After reading the draft plan compiled by Ross Planning Pty Ltd, I have grave concerns and fears over the future usage & development of Geoff Watt Oval (GWO) in Alstonville.

As a former Alstonville Primary School sports organizer for 16 years, Life Member of both the local junior & senior cricket clubs and resident of Alstonville for 33 years where I experienced great co-operation between council, community groups, schools and sporting organisations to enable safe, well planned recreational & sporting events to occur at GWO – an open recreational space in the centre of the village, I must object to the proposal in this plan to solely give GWO to the local Football (soccer) club as stated on page 45 of the Ballina Shire Sport & Recreation Facility Plan.

If this idea became reality it would cause great dissatisfaction and anger amongst the local residents and ratepayers of the Ballina Shire Council. Junior & Senior cricket has been the major sport user of this particular oval for over 140 years and has a close liaison with council, schools, community groups and the local Football (soccer) club.

Page 27 of the draft states: "councils and state government like to encourage shared use of sport facilities.....a number of Ballina sporting clubs share facilities."

This is certainly the case with GWO. Back in the early 90s the local Rotary Club designed and arranged for a new facility to be built for community use. The facility included a canteen, toilets and storage rooms. The major stakeholders, the cricket club and Football (soccer) club, still continue to collaborate with each other and co-operate with any local community group who wishes to use the facility. This sharing process has been successfully occurring ever-since the new facility was built. 'The wheel is not broken, why change the process now?'

I understand the theory behind the draft plan, where sporting <u>hubs</u> may work well in towns or cities; but in small villages, like Alstonville/Wollongbar there are certain historical & logistical components to consider:

- The first recorded cricket matches in which Alstonville Club (one of the oldest cricket clubs on the Richmond River and Far North Coast area) participated was in 1876 on a small field south of the current building (Thomas Freeborn's paddock portion 2).
- Once Parklands subdivision was constructed and open space provided in early 70s, the cricket club constructed with volunteer labour from members, a small canteen and toilet facilities and a concrete pitch at the new oval (eventually named Geoff Watt Oval).
- From my understanding and knowledge, the local Football (soccer) club members haven't been actively engaged in developing new facilities for themselves. They rely on the council or in this instance the local Rotary Club to help them out, not like the local Cricket club which constructed the old canteen and toilet facilities, concrete wicket and practice nets area at GWO in the early 70s and participated in the planning and construction of the new Rotary building in the early 90s, constructed a turf wicket and sheltered spectator viewing area at Hill Park, Wollongbar in 1988/89, all through member volunteer labour and generosity of local businesses for materials after consultation procedures were completed with Ballina Shire Council staff.

- Major parking problems only occur at GWO in winter months when Football (soccer) is played and when local schools host their annual athletic carnivals.
- The local Hockey Club had their own ground at Crawford Park until they were pressured to move to new ground facilities at Gap Road for the sake of accommodating a rapid popularity growth nationally and locally in Football (soccer).
- The cricket club has had a long history with GWO and doesn't want to relinquish their community right to GWO. The soccer club have used this ground only since playing numbers increased and the new facility was built in 1994. Which cricket club in the Ballina Shire or Northern Rivers can claim that they are still playing on the same ground, some 140 + years later? None.
- The cricket club continues to be a force in the development of cricket in the Ballina Shire with 7 junior teams participating in the Ballina District Cricket Association and four senior teams. On page 45 of the document it states that the "Alstonville & District Cricket Club are experiencing a lack of female participation, competition from other sports and declining volunteers." One can say that most other sports mentioned in Tier One category (page 28) are experiencing the same problem. The Alstonville & District Cricket Club was and still does foster and encourages female participation by running Gala Days before and after each season.

In the cricket recommendations mentioned in the draft plan on page 45, No. 3 states that "cricket is proposed to cease use of Geoff Watt Oval" and No. 5 suggests "an upgrade of Gap Road field surface" would occur. No mention of any upgrades of player shelter, toilet/canteen facilities and additional practice nets. One can only assume from these statements, the Consultants – Ross Planning Pty Ltd are recommending that junior cricket in particular move to Gap Road.

Currently school teachers can walk students down to GWO for school sport, carnivals or recreational activities and children still walk down to the oval for sport training after school hours with parents knowing that their child/ren would be safe at that venue. Can you imagine junior cricketers walking the long distance on unsafe roads to Gap Road for training? Issues of shelter and child safety after training would become a huge concern. Local schools would have to use bus transport for sports such as cricket because a pitch at GWO would not be available, as mentioned on page 53 Football (soccer) recommendations: No.12 "Investigate the feasibility of a synthetic Football field at Geoff Watt Oval and Crawford Park."

In conclusion the feasibility of removing the Alstonville & District Cricket Club from the community facility at Geoff Watt Oval is like tearing the sporting fabric out of the heart and soul of the village and a huge mistake.
