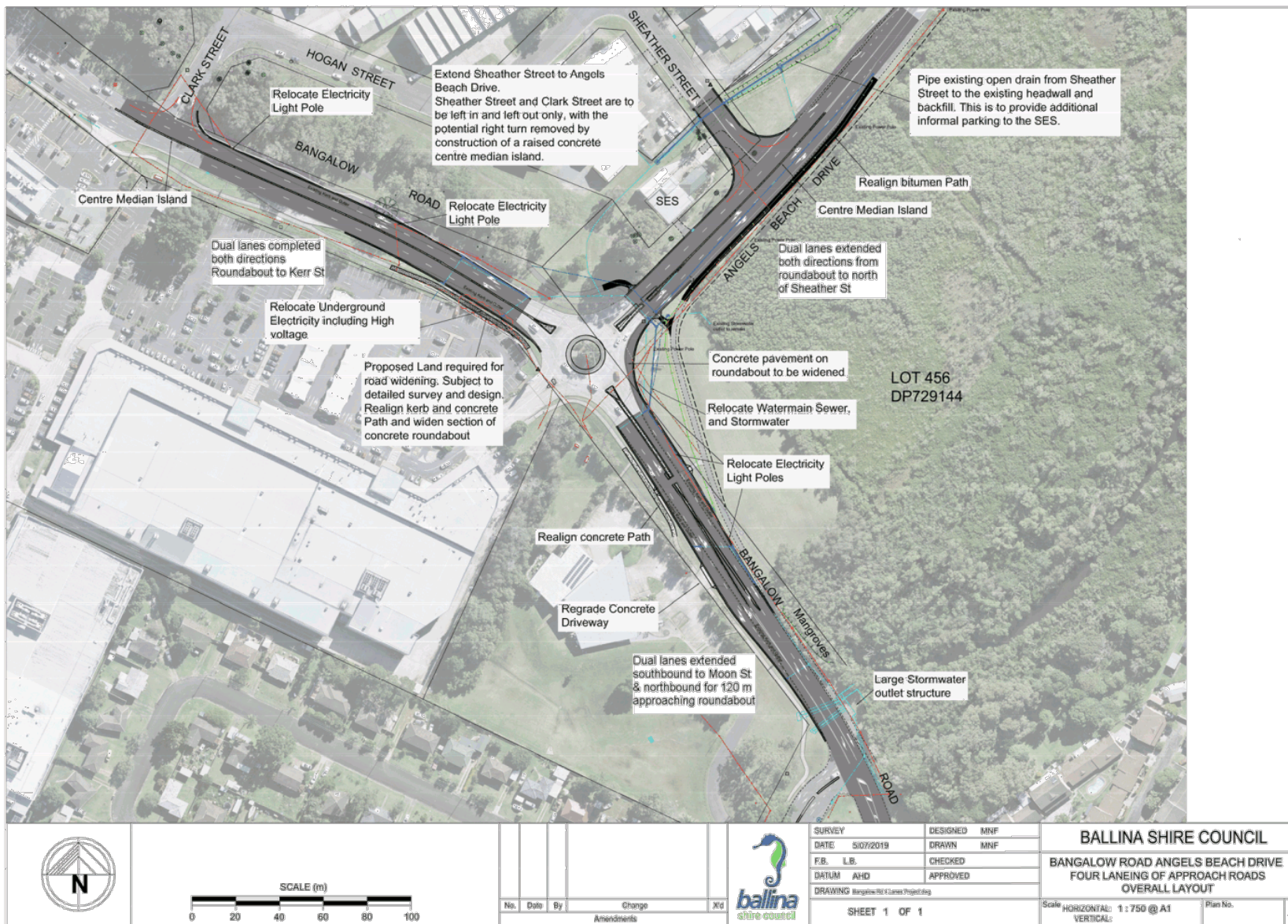

In regards to the proposed changes to the Bangalow Rd/Angels Beach Dr roundabout, I think any improvements need also to take into account some modifications to the existing parking arrangements within the adjacent shopping centre (as per attached photo). There are 5 or 6 "nose-in" parking bays outside the IGA Supermarket that need to be either eliminated or modified as they cause traffic entering the car-park to back up in busy times (and the back-up of traffic often blocks off the movement of traffic on the roundabout).

(1) Have council consulted with businesses in the general Sheather street area as surely they will be impacted by vehicles not being able to turn right into Clark street and when they find they cannot they may continue along Tamarind street and find an alternate business as they cannot turn around and have to go to the roundabout at Aldi to turn around? Surely a U turn allowance at the Kerr street intersection would alleviate this?

(2) Does council propose to place a zebra pedestrian crossing on Tamarind street opposite the community centre ? This is where there is a pathway leading to breaks in the kerb and also where residents from the many retirement homes along cherry street cross either as pedestrians or in their electric vehicles. They are at great risk crossing there as many are very slow pedestrians. If a crossing cannot be installed one is needed somewhere in this vicinity as a matter of urgency.

(3) I have noticed that council does not rate pedestrians very highly as there is a great lack of concrete footpaths in town , a large number of vehicles parked on footpaths and council does not ensure that landscaping does not protrude onto footpaths. A classic example is the Bangalow road frontage of the motel on the corner of Moon street where approx 60% of the footpath is blocked by hedging. Surely this is illegal as it forces pedestrians to walk onto the roadway to pass other pedestrians. Check it out!! See photos attached.

While not part of this project, I also believe the nearby intersection into the Council depot and Fishermans Club should also be left turn in and out as well

My only suggestion for the new roundabout design would be to ensure that the median strip in Angels Beach Drive is widened so bicycles can be safely parked there when crossing on the bike path. The current median strip is not wide enough and with the upgrade to four lanes, the median strip needs to be wider so bike riders, wheelchairs, mothers with strollers etc can temporarily park there when crossing the intersection from one bike path to the other

I note that Bangalow Road is proposed to have a right turn trap lane east of Angels Beach Drive into Moon Street. With the lane designations on Bangalow Road eastbound (at the roundabout) allowing for through movements in both lanes this will encourage the majority of traffic intending to travel on Cherry Street past Moon Street to utilise the left through lane. The left lane will already be very busy with very heavy left turn movement creating an imbalance of use with the right lane used minimally by vehicles accessing Moon Street and Ballina Central. It is suggested that instead of having the dual through lane arrangement that the left lane be designated as a left only lane and the right lane as a through / right lane be investigated. This will balance the queues in both lanes and reduce the likelihood of people being caught in the right turn trap lane further along Bangalow Road.

The current lane designation on Angels Beach Drive is not ideal. Considering the large queues that can be experienced on Angels Beach Drive in the peak periods it is suggested that the lane designation be changed with the right lane designated as a right only lane and the left lane as a right / through / left lane. This will help reduce the queue lengths by removing the through vehicles from the right lane and allowing vehicles to turn right using this lane will reduce the reliance on the right lane solely potentially balancing the queues. Should this not be supported, at least designating the right lane as right only will help with this queue length.

Pedestrian access across Angels Beach Drive at the roundabout crossing is currently quite

difficult to use in the peak periods due to queuing vehicles and the exit speed of vehicles travelling on Angels Beach Drive. It is suggested improvements are made to this crossing in addition to what is already proposed.

The arrangement to access the Clark Street industrial estate is not ideal with the requirement of vehicles entering / exiting the estate to complete U-turns at the roundabout. Considering the small radius of the roundabout already this movement is likely not suitable for larger vehicles / would be difficult. However, I acknowledge should an all movement access be retained at Clark Street, or provided at Sheather Street it will most likely require some form of intersection control as a priority intersection will not operate satisfactorily (as is currently the case turning right from Clark Street at some times).

Put this money towards upgrading the bridges (north Ballina & west Ballina) to dual lanes firstly. Get the main arterial road through Ballina (Tamarind drive, Kerr st & River St) flowing properly with Dual lanes. The traffic build up from the roundabout at aldi coming into town of a morning is ridiculous. Likewise the same happens on the other side of town from the roundabout at Bunnings coming into town in the morning. With the incredible amount of housing development going on, all outside of town , surely getting into, through & out of the township smoothly should be a priority.

If however this project is destined to go ahead. Perhaps thought could be put into making the Angels Beach Drive Entry Left In / Right In i.e entry from both lanes (removing median island as its unnecessary & costly) and making the first section of Sheather St 'One Way' traffic (maybe one way traffic around the estate). Traffic in the estate already exits through Bangalow road & mostly turns left to go to the roundabout already. (again, I dont see the need for a centre island the whole way along Bangalow road)

Has any consideration of the business traffic that use this estate been considered in this planning and how it will effect the traffic outside of the estate while the vehicles are entering/exiting? You have Two Freight / Truck Businesses, One Bus line Business, One Hardware Store Business and many other manufacturing & industrial businesses that require Heavy Articulated Trucks to deliver materials & supplies. There is also a bowling alley which has an influx in customers every school holiday, and that's not all of them.

The Left In/Left Out at 2 intersections approach does not work & will cause a higher chance of accident and injury to road users & pedestrians. ALL traffic coming out of Clark st will be pushed up to the roundabout to do a 180 to head to North or West Ballina, Traffic from the Coast road coming fro East Ballina, Skennars Head, Lennox Head, Byron Bay etc will need to perform a 180 at the roundabout to enter into the industrial estate.

This Roundabout is also the main crossing for many pedesrian and cyclists (old & young) coming from North Ballina & Cumbalum and heading to the River, Beach, Schools, Going to work or just exercising.

In response to your invitation for submissions regarding this planning proposal, we support this important traffic safety proposal as an effective way to improve flow and reduce traffic jams at nearby intersections, roundabouts, traffic lights and shopping centres.

Having owned businesses and buildings in this industrial estate since 1980, we have seen extensive growth in population and increased traffic flows as Ballina Shire has grown. The proposed works will assist to separate and spread traffic more evenly in this particularly busy part of Ballina. As well as contributing to better traffic efficiency, this should also help to reduce delays, accidents and associated impacts.
