My name is Kerren Kernaghan and I own and run a small dance school in Lennox Head and have done for 5 years. Heart of Dance itself has been operational in Lennox Head for over 15 years. We provide a valuable recreational, social and sporting activity for the children of Lennox Head and the surrounds.

Like many business we have had to shut our doors due to COVID-19, but we are hopeful in the not too distant future we will be able to resume our day to day activities.

While in operation at the beginning of the year we hired the meeting rooms at the Lennox Head Community Centre on 2 evenings to hold some of our dance classes.

I noticed while looking through the new fees and charges set to come into effect for the 2020/2021 financial year, the cost to hire these meeting rooms is to increase by 40% from \$37.50/hr to \$52.50/hr (Regular Community Based Activities). A 40% increase in one go is far too much especially in light of what we have just been through with the COVID-19 situation.

I was hoping to be able to hire the meeting rooms again once we are able to resume our activities but will now have to rethink due to the price you are proposing to set.

I ask, that if you could please look at keeping the fees the same price they are for the 2019/2020 financial year for the next financial year (2020/2021) to help not just me, but all the users that normally hire the spaces, that have, through no fault of our own, been unable to operate for many months, a chance to get back on our feet and still be able to provide the affordable activities we all do for so many in the local community.

Re Proposed rent increases for use of Council facilities.

As a user of the CWA Hall in Lennox Head for nearly 8 years I am opposed to any increase in the rent of this small space.

For 8 years I have provided 3 yoga classes per week, to many community members/ rate payers. The majority of my students are aged, on pensions, unemployed and / or with health problems. I have provided profit and loss statements to Council proving that I make no money from these classes. I consider them a service to the community. Something I thought Council would support. For many students the classes are essential for maintaining physical and mental health.

The desire to increase the rent after a period of what could end up to be 3 months or more of closure due to Covid 9 is exceptionally unreasonable. All facilitators have lost income during this period and I for one paid rent in advance.

Once the facilities are open it is likely that it will take some time before students feel comfortable in returning, yet we will be required to pay rent. I will be required to spend money on additional advertising.

It is also expected that the potential for numbers in classes will be greatly reduced due to distancing expectations. Please note that the dimensions of the CWA include a large kitchen space, unused by yoga classes and causing a reduction in space for students.

To cover additional costs I would be required to increase fees, which has created hardship for some students in the past.

I wish to firmly state that any increase in facility fees for this year are unreasonable and unjustified and believe that service users would be best supported in providing services and support to our community members by providing a reduction in fees.

My name is George Moschoudis. I'm the head coach and proprietor of Elevate Jiu Jitsu. We provide classes in both the self-defence and the sport aspect of Jiu Jitsu.

I have been renting space at the Lennox Head Community since July of 2018 although we have been temporarily moved to the Ballina Surf Club until construction at Lennox Head has finished. Classes run 4 days a week and are available to any member of our community.

I shut down on March 26th 2020 due to the current Covid-19 pandemic. I have read Ballina Council's draft fees and charges for 2020/21 (General: Current \$50 to New \$70 or 25%: \$37.50 to New \$52) and I'm concerned that I will not be able to afford the proposed rental increase on our return and will be forced to cease providing this service and ultimately be forced to shut down Elevate Jiu Jitsu if the rent is increased.

On average it currently costs me between \$1200-\$1500 a month in rent to Ballina Shire Council, depending on how many weeks and public holidays are in the month. I currently break even each week and in the event that an approximate 40% increase in rent is put in place there is no way that the business will be viable as we are just a small club.

I request that the proposed fee increase be abandoned.

I would like to recommend Council review the increase in charges for commercial hire of Community Spaces .

I am a clinical psychologist providing services to local clients for approximately 2.5

years using the Health Care Office at the Lennox Head . I believe therapy should be available for all in need not just those that can afford to pay, as such I provide bulk billing for a significant proportion of my Lennox/Ballina clients. Bulk billing is the exception for psychologists, the vast majority do not bulk bill services.. To maintain this free service for my bulk billed clients I must be careful with business decisions to maintain affordable overheads for ongoing business viability. I have been able to to do this to date through community based room at Lennox Community and Cultural Centre. If the rent increases are as large as proposed I will be forced to cease practice in the Lennox Community Centre Health Care Office, meaning I will no longer be able to provide bulk billing and affordable psychology services for Lennox Head and Ballina clients. Most of these clients cannot afford to pay the gap fee, and as such they will most likely discontinue. The Black Dog Foundation has recently conducted research into the affects of COVID 19 and have predicted a large increase in suicides as a result of the stress of the pandemic. They predict more people will die by suicide due to the emotional and financial distress fo the pandemic than the deaths caused by the virus itself. We need to continue to provide support and services for our community. Raising commercial rents for Community space seems exceptionally ill timed, and will reduce important services for the local community.

The proposed increase is over 100 % for full day hire of the Health Care Office from \$115 to \$234. There is inconsistency across the increase which seems inequitable e.g. the hourly commercial hire for the same space is \$5, an increase of 12% (approx). Other rooms for commercial hire have not had such a massive increase but the increase are still very high.

The decision for such exorbitant increases seems in total contradiction with the support both federal and state government are providing for businesses such as rent relief and support. If this was a commercial hire these increases could be successfully challenged in the Small Business Commissioner.

I would like to ask the council to reconsider these increases and apply an increase are consistent with previous increases. Or alternatively put these increases on hold for the coming financial year and reconsider and review at that time.

Dear Ballina Shire Council

I am writing to you concerning the impending increase in the fees for hiring the meeting rooms at the Lennox Head Community Centre to ask you if you could please consider leaving the rental fees where they are for our Tuesday evening dancing group for a while to come.

My partner and I organise and run a dance-exercise class once a week that mainly attracts mums and women between 35 and 60. We turn down the lights and just turn off our frenetic lives and dance however we want in the semi-darkness, to the best dance songs of the last 50 or 60 years . All of the ladies that come to "Dancing in the Dark", we all feel that this one hour of letting loose each week is a wonderful release and great exercise - it's as though we are meditating and exercising all at once, to music that we love. We all look forward to Tuesday night at Lennox Community Centre and are eagerly awaiting the lifting of coronavirus restrictions so that we can do it again. My physiotherapist says the long-term benefits for my health and body are many and varied and we keep running into research that suggests that dancing regularly has many long-term benefits. The social benefits in our community are important too and it is a great antidote for loneliness and depression.

We feel that we are assisting part of the local community, that can be forgotten, and in a very positive way.

We put in quite a few hours to organise this each week and last figures suggested that we make an average of \$10 profit per weekly session, for maybe 5 or more hours work each week, which is better than a loss, but an increase of \$14 in the rent per week is really significant and whenever we take a break over the summer holidays the numbers go down a little and slowly recover. So we expect that this will happen when we start up again after coronavirus restrictions are eased; that the numbers will be down and slowly recover. We seem to get between 6 and say 16 dancers each week and five of our regulars have been coming for around four years.

So you see the rental increase is quite significant and is the difference between us covering expenses or not .

We intend to use the Lennox Head community centre rooms for a long time into the future if all goes well and we are using it at a time that is not popular, namely 7.15 to 8.15 pm; in fact, we have squeezed our time back so that another dancing class for children can use the rooms as well.

We humbly ask that you leave the rental for our community-minded and community-supporting initiative at the same level and not raise it come July.

We even feel that perhaps we would be warranted in asking for financial assistance to run this. Would there be any grants available or extra support available from council?

We feel our plight really deserves councils consideration.

Re: 23 Newrybar Swamp Road Flood Assessment and Drainage Works

Further to our discussions in February 2020, follow-up actions have been undertaken to clarify queries about the flood assessment which considers possible works on Newrybar Swamp Road. This included contacting nearby landowners and confirming what information had been included in the flood modelling assessment.

A discussion and subsequent email from Alan Anderson (12/3/2020) confirmed the Andersons are sceptical with the modelling results, and more generally, consider the flood modelling in this area to be inaccurate. In 2018, the Andersons engaged consultants WRM (Greg Roads) to review regional flood modelling undertaken by Council's consultant BMT, and to provide comment on the drainage issues affecting their property at 38 Newrybar Swamp Road. This review included recently surveyed levels along drains within their property undertaken by Northern Rivers Surveying.

In 2019, Council engaged BMT to assess options for possible Newrybar Swamp Road drainage works. This assessment included the information from the WRM report and the survey information provided by the Andersons to Council. The report prepared by BMT "Newrybar Swamp Road Regrading Flood Assessment and Culvert Upgrade (Sept 2019)" considered two possible drainage design options. Council staff now consider the possible design options and flood modelling investigations, as previously discussed, to be complete.

As mentioned previously, any road or culvert works on Newrybar Swamp Road adjacent to your property is unfunded and not included in the current delivery program. It is now a matter for the Council to decide if funding is to be allocated to this project to enable any works to be undertaken.

With the preliminary design and investigation work completed, it is suggested that now is the appropriate time to make a written submission to Council on the public exhibition of the 'Delivery Program and Operational Plan'. The closing date for receipt of submissions is 5 June 2020. Your submission requesting road drainage works be done to alleviate flooding issues would be included in the budget report to the Council in June 2020. The matter of funding your request could then be determined.


