Staff Comment

Council has contacted the developer for an update. Council have not been provided with a commencement date, but have been advised the construction is anticipated to be completed by April 2021.

(c) Lake Ainsworth Planting

Action: Shaun Eastment enquired about landscaping to be undertaken Lake Ainsworth. Landcare are currently propagating plants and has concerns that local plants won't be used. Shaun asked to be involved in the planting decision and discuss the matter further with Cheyne.

Staff Comment

Meeting held on-site with Council staff and Ms Eastment on 28 September 2020.

6. <u>Business with Notice from Members</u>

(a) Vandalism at Lake Ainsworth

Crs Wright and Cadwallader have requested that vandalism at the northern end of Lake Ainsworth be discussed.

Staff Comment

Cheyne Willebrands, Manager Open Spaces will be attending the meeting to discuss the matter.

(b) Unauthorised Camping

Cathy Byrne raised concerns about the increase in unauthorised camping (including homeless and backpackers) between Black Head, Flat Rock, Shelly and Angels Beach.

- Would Council consider revisiting a free camping site at Bicentennial Park or another site?
- What are the enforcement regimes?
- Requested additional signage in these areas.


Staff Comment

Council is aware of the increased numbers in unauthorised car and tent camping in our shire. Whilst Council has regulatory signage in a number of locations, Council Rangers also monitor and undertake compliance at various sites on a regular basis.

Bicentennial Park has historically been a rest area, not a free camping area therefore overnight rest stops have been permitted when Tamarind Drive was the highway. Future management of this area will be guided by the preparation of a Master Plan. This process will commence in 2021/22, and is in Council's Delivery Program.

(c) Coastal Signage

Cathy Byrne has requested and update on the progress of Coastcare signage.





Staff Comment

Council is awaiting confirmation from JALI for the correct Bundjalung wording on the signage. Council is working towards preparing the signage.

With regards to the "Walker signage", Council has undertaken track modification and fencing to discourage bike access and assist walkers in lieu of further signage.

(d) Plant Identification Training

Cathy Byrne has requested plant identification training and strategies for weed management of specific species for Coastcare members, particularly for new members. Requested Council consider assisting by enabling Council nursery staff meet with Coastcare members regularly at different sites for an hour for a sustained period of several months in 2021.

Staff Comment

Cheyne Willebrands, Manager Open Spaces is preparing a response to be discussed at the meeting.

(e) Green Waste Service for Businesses in Lennox Head

Brad Pollard raised concerns as a cafe business in Lennox recently described an experience they had with regards to councils green waste service. The business arranged for 2 green waste bins as they wanted to divert food waste away from landfill and enjoy a reliable scheduled pickup service. At a cost of approximately \$400 per bin, this is unaffordable for most other cafes therefore food waste is being thrown into general waste and ending up in landfill. Additionally, the bins have regularly not been picked up because they were too heavy.

Brad would like to know if anything can be done to reduce the cost to businesses that wish to do the right thing environmentally and why is a weight restriction being applied to the service? A further hurdle for businesses to make when they just want to do the right thing environmentally.

Action: Referred to Civil Services.

(f) Roundabout Landscaping/Maintenance

Brad Pollard requested Council maintain the landscaping on the roundabout on Byron Bay Road/North Creek Road as it is currently looking tired and covered with dirt. As this roundabout is one of two entrances to the village and town centre Brad has requested the roundabout is maintained on a regular basis.

Staff Comment

Cheyne Willebrands, Manager Open Spaces is preparing a response to be discussed at the meeting.

(g) Concrete Barriers and Wire Fencing – Ballina Street, Lennox Head

Brad Pollard raised the unattractive appearance of the concrete barriers topped with wire fencing that were installed along Ballina Street, Lennox Head (between Byron Bay Road/North Creek Road roundabout and Allens Parade), possibly to retain the soil, rock and vegetation behind it. To improve the entrance to town Brad requested Council extend and continue the existing black rock wall retainer to the roundabout. This is a beautiful strip and entrance to town.

Action: Referred to Civil Services.

(h) Declaration of Climate Change Emergency / Investment Policy

Claudia Caliarli from the Ballina Environment Society submitted further enquiries relating to climate change and Council's Investment Policy. A copy of Claudia's detailed request for information is included in *Attachment 2*.

Staff Comment

Council's Manager, Financial Services provided the following information in response to the various matters raised:

It is agreed that the ability to place an investment with a non-fossil fuel aligned institution with a return of within 0.05% of the highest available return has had little bearing on the resulting investment holdings.

Council staff are required to comply with the parameters set out in the adopted Investment Policy.

Council's investments comply with the adopted Investment Policy. That is, "Where possible (and subject to obtaining a comparable return and compliance with other investment policy parameters), the investing officer will place the investment with an institution which has been classified as non-fossil fuel aligned" and "In placing the investment the investing officer will take every reasonable effort to maximise the percentage of the total portfolio held with non-fossil fuel aligned institutions".

The Investment Policy parameters must be complied with and the monthly Investments Report to Council makes a statement of compliance.

The Investment Policy parameters have precedence over the Climate Change Emergency.

A change in practice would require a change in the Investment Policy parameters. This Policy is reviewed annually and is due for renewal in February 2021. Management propose that comment in relation to the level of holdings of the non-fossil fuel aligned investments be noted in the report for consideration by Council.

Ballina Council Declaration of Climate Emergency – where is it going with Investments?

Council has shown that it has a resolute intention to take account of Climate Change in all of its activities with two resolutions, namely;

"that Council declares we are in a state of Climate Emergency that requires urgent action by all levels of government " (Nov 2019)

And Climate Change mitigation and adaptation has been put as a requirement in all Councils endeavours into the overarching strategically dominant position of Engaged Leadership in Ballina Shire Local Strategic Planning Statement 2020-2040 on 28/05/2020.

Council's Investment policy demands the same commitment by requiring its investments to move, albeit slowly, towards predominantly favouring non fossil fuel supporting investments. (Relevant extractions below)

BES looked at the investments since Nov 2019 and found that there is no trend in practice towards this policy determination.

When it comes to investments the balance remains about 60% for fossil fuel aligned and 30% non fossil fuel aligned across twelve months. Staff have argued to The B Ward Committee that day to day variations plus External requirements from the NSW Government and Council's internal requirements are to blame for this. Put bluntly is Council's argument for non compliance that its too hard?

BES therefore posed this question for Council

1. When there is a clash between investment policy and climate change emergency what has precedence?

A second reply from Council to the B Ward ignores the question and instead argues that in addition to too many variables (too hard) investments are not relevant to Council's Climate change response—relevance is solar panels, appropriate street lighting, trees etc. Not relevant seems a poor excuse.

Council's own policy states "10." Investments obtained are to be considered in light of the following key criteria [one of which is] Reputational and Environmental Risk — the risk of damage to Council's image and/or risk to the environment resulting from Council taking out investments with institutions who are known to fund fossil fuel activities.

and

13. REPUTATIONAL AND ENVIRONMENTAL CONSIDERATIONS

13.1 Where possible (and subject to obtaining a comparable return and compliance with other investment policy parameters), the investing officer will place the investment with an institution which has been classified as non-fossil fuel aligned. This classification shall be determined based on publicly available information, such as from Market Forces www.marketforces.org.au).

13.2 In placing the investment the investing officer will: Take every reasonable effort to maximise the percentage of the total portfolio held with non-fossil fuel aligned institutions.

Be mindful of maximising the credit rating parameter that is aligned with nonfossil fuel aligned institutions (typically the B category).

Also consider the reputation of the institution with respect to ethical behaviour, with Council's preference being for investments to be held with institutions that display the highest standards of ethical behaviour" (p5, Policy no 101 (Feb 2017 confirmed Jan 2020) (BES emphasis)

BES believes that there is no necessary clash between policy and action but this appears to be Council's argument –too hard and not relevant.

We suggest that there is a need to encourage more effort to change behaviours and Council needs a clear strategy with clear goals and targets.

BES suggests that Council could appoint a senior person to oversee the development of a detailed plan and to oversee that the CED is embedded in investment decisions and all future Council actions within the overall plan.

Some other local Governments are already showing the way trying to do the right thing.
