



Submission on the Kingsford Smith Reserve Master Plan document on public exhibition.

Ballina Environment Society congratulates Ballina Shire Councils attempt to create an interesting gathering space for community recreation and sports. However, the draft of the Kingsford Smith Reserve Master Plan lack in some strategic structural values. It represents the "park" area but seems to ignore that it is also an estuary Riparian Zone within the Richmond River catchment with its own needs and special contribution. These needs and special contribution are made even more important by the advance of climate change, and the way that Council deal with such an essential resource is echoed by all dwellers till the source of the river. There are three distinct areas in the masterplan:

a) Commemoration Park

This area fronts the North Creek estuary on its northern side and is primarily used for walking, running, cycling and general recreation and the eastern part for a Sunday morning Farmers market. The western side is bordered by an important connector road, Bentinck St. A 3m wide concrete shared path runs from east to west close to the beach.

The primary needs of this parkland, is for open space for recreation and market, access to the estuary beach/water with cooling surfaces and natural shelter from the blazing heat in summer. BES is concerned about the lack of integration of riparian as an ecological community with the "waterfront" concept which is fundamental to waterway health within the plan. There should not be a conflict.

b) Kingsford Smith Park

This area has a number of different sports grounds with more space required, particularly in the women's netball court area. It needs larger club and storage facilities and improved access to cars and parking. It is bordered by urban roads on the north and western sides both of which are used for street parking. Bentinck St parking on the sports field side can become dangerous when the market is on. There are protected wetlands on the eastern side extending south beyond Bentinck St and the designated sports fields. If it is to continue as a sports field, during the day as climate change advances, then cooling and permeable surfaces are vital. Protection of the wetlands will aid these needs.

c) Missingham Park

This is a large grassed area with a waterfront view. Where trees are not the best option as a shelter (skate area), climate friendly shelter should be used - such as green roof and others - due to the overwhelming temperatures on summer, and also some natural grassed patches near the skate park such as lomandras could aid cooling. To the south is a large parking area.

BES believes that this masterplan is an opportunity to show leadership in awareness in natural resource planning to maintain and improve landscape and seascape health, increasing interest and engagement.

The "Riparian Zone Management", "Vegetation Management" and the "Education Program" are 3 of 9 priorities strategies of the Richmond River Coastal Zone Management Plani (RRCZMP) that should be strategically integrated when planning riparian/wetland areas such as these. Riparian forests also have an essential role in other priority strategies of the Richmond River CZMP such as waterways



usage, urban runoff, cultural heritage, fishery management, soil biodiversity and permeability, carbon sequestration and the list go on.

BES urges that decision makers review decisions that superficially indicate conflict between social, environmental, and economic outcomes because they come along together enhancing our community connections and mental health. Often where "conflict" is seen, the health of the natural systems generally suffers. BES suggest:

- The adoption of the right terminology for the waterfront ecological areas, using Riparian Zone instead of waterfront showing that Council is aligned with the (RRCZMP) making community more aware of those concepts.
- 2. Trees in clumps at regular intervals along the shared path of Commemoration Park so that there is a proper tree cover reducing hot summer temperature, improving soil and runoff. Trees in clumps at appropriate distance from the skate park are also possible. At the Missingham Park (P58) item 12 suggests a waterfront lawn, an area that is extremely hot on summer. BES would like to suggest more natural shade cover.
- 3. In particular parking lots should follow best water sensitive urban design.
- Hard surface areas should be as permeable as possible, using open-celled paving grids, pervious asphalt/concrete or other alternative.
- New amenities should be built using environmentally friendly construction material, locally sourced, thereby reducing carbon footprint.
- The use of educational signs along the walkways reflecting the need of appropriate vegetation and surfacing given the importance of riparian zone.
- 7. Before applying online surveys related to essential ecosystems, Council could provide brief background information so community make decisions based in appropriate knowledge. BES does not agree with Council offering "waterfront open lawn area" as an option for the survey (online survey at Council website) when applied to Riparian/estuary areas and the lack of a proper information can mislead decisions. With clumps of trees and some native grassed areas there will still be a large area of grass but it will be more attractive and more usable between 8am and 5pm in summer than a large bare grassed area.

Ballina has experienced a sharp increase in population and presents the worst rate in residual vegetation in Northern Rivers along with a very poor effective habitat area and connectivityⁱⁱ. Restoring Riparian areas is an excellent opportunity for education shire wide and for improving those indicators. In summary, BES argues that such a strategic area for the whole shire and region should be a showcase and an example of sustainable land-use management, maximising environmental protection while promoting community connections and social health.

To the strategic planning team:-

Thank you for the opportunity to give feedback on the draft masterplan for the Commemoration Park site.

It is wonderful that Ballina council has the opportunity to plan for the future and the park design has some wonderful elements. Congratulation on all the planning work. However, in relation to accommodating the Farmers Market there are some issues that I hope will be considered.

The plan does not seem to be able to accommodate the current footprint, let alone the footprint of a future expanded Farmers Market.

Commemoration Park is a wonderful site, but it is not a large site. Setting up the Farmers Market requires a large level greenspace or any level space where stalls can set up in a unified configuration.

Mounded lawns and breakout spaces for social gatherings seem to indicate actively created pockets and individualise islands of grassy hills connected by widened walkways all which are not suitable for a Market. Seating and shelters and a widened promenade that cuts into the parkland to create further pockets of lawn shrink any possible space that can be usable for our Farmers Market, not to mention the additional sculptures, sculptural play pieces, BBQs and shaded areas plus planting of native vegetation that will fill up any remaining space. The small 'market' lawn surrounding the exercise equipment seems to be the only open area allocated in the park and clearly too small for a market if that was the intended purpose.

The additional car park across Commemoration Park will be a great addition for Farmers Market customers as well as sport attendees.

I would like to point out that the pedestrian crossing is planned to be on the far side of the park, that is the northern end, whereby the Farmers Market, is located on the southern end of Commemoration Park. People will still cross the road from the carpark on the southern side of the Commemoration Park, since it is the shortest distance. I believe relocating the crossing should be considered.

Bentinck street is a long straight road which often results in cars being driven too fast or drivers not paying sufficient attention to their surroundings. I believe there is a need to slow traffic down. More people visiting the precinct in general and the Farmers Market in particular means that traffic calming measures would be a safer option for people visiting the area.

For the Farmers Market to operate effectively the park needs improved drainage as currently the middle of the market acts like a cauldron which creates a lake in very wet weather. A much-appreciated addition would be electric power- points in the form of power bollards strategically placed at various points in the park. A storage space equal to one the Ballina mariners have on their site would be invaluable and could be in cooperated into an improved amenity block.

Commemoration Park is a wonderful site and much appreciated by community members every Sunday during the Farmers Market.

Dear Sir/Madam,

Please accept the following as my submission with respect to the above mentioned draft plan.

I commend Council for initiating this project and the engagement of key stakeholders and the community in identifying and considering a range of matters, preparing options and presenting the draft plan for public exhibition and feedback.

It is also appropriate to acknowledge the extensive support of Mr Ben Franklin in securing funding to enable the preparation of the draft plan, more detailed design elements and potentially for implementation of key infrastructure components of the adopted plan.

In general terms I support the draft plan, as presented. The key attributes, user patterns and existing infrastructure and improvements have been identified within each of the three discrete park areas. These form the basis of what essentially will be a continuation of current usage of the respective areas into the future, albeit with the delivery of staged improvements and enhancements as funding and other resources permit.

Respectfully, I do feel that some of the imagery and conceptual design elements in the draft plan are exaggerated and unrealistic, and could create community expectations which cannot be met. I understand this "artistic license" is intended to evoke excitement and enthusiasm for what our community might see and experience in the future, but needs to be tempered by what is practicably deliverable in a budget context.

Following, I have made a number of comments and/or suggestions which I invite Council to consider in its deliberations concerning the draft plan. I am not a member of any key user group operating within the reserve. I respond only as an interested community member. If my submission is determined as having relevance, or is otherwise seen as being beneficial, modifications would not be required to the exhibited draft plan. Rather, these thoughts and ideas might be considered in the context of Council's broader current or future work programs, or in future more detailed design phases of the adopted master plan.

1. The lake (or pond) located within the reserve adjacent to Kingsford Smith Drive is a very valuable social, environmental and recreational feature, despite it being artificially created. It is identified as a critical element and key attractor within the draft plan. I suggest it is

important to gain a clear understanding of the respective sources and conveyance of the water (estuarine, ground and surface) which enters the pond to ensure its quality (and quantity) can be effectively managed and improved over time. Having this knowledge "up front" will be beneficial in the detailed design phases for improvements in this area of the reserve, and may prevent the need for expensive remediation work in the future.

- 2. It is regrettable that the land on the south-eastern and southern sides of Kingsford Smith Reserve has not been included in the draft plan. This land includes Kingsford Smith Drive (the road pavement and the adjoining vegetated areas either side) as well as the accreted beach/tidal areas of the river, generally referred to as The Spit. I acknowledge there may be sound reasons why these areas have been omitted in the preparation of the draft plan. However, their inclusion could have helped to "complete the picture" as it were, for the future management and enhancement of this valuable part of Ballina Island and the shire. Casual usage of the spit for a range of recreational purposes is increasing, from my observation, and I suggest this is to be encouraged. If agreed by Council, how will this be facilitated and managed?
- What enhancements (if any) within and to the beach area will be provided?
- Should "calming" of traffic and/or other means be employed within Kingsford Smith Drive to facilitate safe movement of park users between the main reserve area and the beach area?
- Is improved or modified car parking along Kingsford Smith Drive necessary or desirable?
- Can/should existing vegetation on either side of the road, and within the spit area, be better managed to improve the ecological, aesthetic and general amenity values of this important area?
- 3. I suggest it may be appropriate for Council to determine whether it wishes to make allowance in the draft master plan for appropriate commercial activities to be conducted within parts of the reserve/s. Making some type of statement or other acknowledgement regarding commercial usage (eg mobile refreshment vendors or health/fitness training), or not permitting such usage, and the reasons why, would then provide an important "line of sight" and consistency through Council's master plan documents, plans of management for public land and other related policy documents.
- 4. Funding for the implementation of the adopted master plan (and other similar plans) will be allocated on a staged basis, through provision in Council's operation plans/delivery programs, as well as possibly through external grants. Perhaps it could be timely for Council to consider an alternative contributing funding mechanism for this plan, as well as others (eg Pop Denison Park) in order that they can be delivered more expeditiously, given the high value of these open spaces to the shire's citizens and visitors. One option could be for Council to establish a program to methodically assess, in environmental, social and economic terms, the value of its community and operational land holdings. It is conceivable that some of these land holdings/parcels (eg certain "pocket parks" or under-utilised/obsolete road reserves) might emerge as being available for disposal, or for different usage. This rationalisation could see existing maintenance burdens reduced, as well as funds generated to be dedicated or quarantined for master plan implementation. Such a program may require a commitment of additional resources, and would need community input. Reclassification and/or rezoning of certain land holdings may also be required. However, land identified as surplus to Council's operational needs through this comprehensive and transparent process could be adapted for alternative uses (eg housing), undertaken either by Council or others.





Q1 Please tick your age group:





Q2 If you have children, please indicate what age bracket/s they belong to.





Q3 What is your connection to Ballina? (please tick all that apply)





Q4 Which parks do you most commonly use? (please tick all that apply)






Q6 Park Concept Area: Kingsford Smith Park - Please select your five most desired elements of the Kingsford Smith Park draft concept plan from the options listed below.



Dogs are a big part of our culture. In fact, they are the most common pet, however, 60 % of Australian homes don't have dogs [1]. Many people don't feel comfortable expressing that they don't feel comfortable around dogs. Specific phobia affects over 9% of the population [2] with cynophobia (a fear of dogs) being a common type. cynophobia (a fear of dogs) being a common type. It is believed that 1 in 20 people in the general community have a fear of dogs [3]. Specific phobias are even more common in people with autism spectrum disorders (ASD). In a study of lifetime prevalence, Leyfer et al.

(2006) [4] found that about half of children and young people with ASD were found to meet criteria for a specific phobia. Dog phobias represent a significant part of those specific phobias and because so many dogs are kept as pets, dogs are often encountered taking part in everyday activities, particularly leisure activities in the community. As a result, dogs being present in places would be a significant barrier for many children and young people with ASD and may impede their access to the wider community [5]. The problem with dogs at sport is choice. When people exercise or socialise their dogs in parks for example, a person who feels uncomfortable or a family with a child who is frightened can choose to move away from the dog. At sport there is no choice to move, as the game is happening on that court or field, at that time. You must choose to not participate in order to move away from the dog. It shouldn't be a requirement of children choosing to participate in sport that they are comfortable with dogs. But this is how it currently is. Many children cannot access sport because there are so many dogs present. If you were swimming in the ocean and there was a shark in the water with you, how far away would the shark need to be to stop looking at it or looking for it? For a child with a dog phobia, they need to know where all the dogs are, they keep looking for them. It's not enough to just move a bit away from the court, there is no distance that feels safe. They must keep checking, just as you would for the shark in the ocean. If the child is looking at the dog, they are not looking at the game and therefore are at great risk of being injured. It is distressing for all of our team having a teammate distressed and fearful on the court. No one believes that she should have to be removed from the court because she is afraid and distracted. It should be the right of all children to feel safe on the court. Many dog owners believe they have a right to be there. When asked to move further away from the court they get cranky and so many argue about it and some even refuse. On one occasion a parent with a dog sitting just only a meter from the sideline was asked to move back because a child on the court has a dog phobia, they flatly refused and said "I've come to watch the game and you can't make me". He would have been able to move back onto a grassed area and still have had an unobstructed view of the court. The ACT have a great policy. People are not permitted to take a dog onto a field or playing area where authorised sport or training is being played or conducted on that field or area. This still allows people and dogs to use the area for exercise and recreation outside of times the space is being used for sport. When sport such as soccer or netball are on it is not the only opportunity a dog owner has to exercise their pet, but that is the only time a child has to participate in that sport. Having dogs at sport excludes some children's participation. It particularly impacts children with ASD who already have enough barriers to accessing sport. The other point is about the difference in this childs game. Last year she was an asset to the team. She may play the game a little differently having ASD but 9 times out of 10 she was free and ready to get the ball. Last year because of COVID restrictions, (only one parent in attendance, distance from court, leave straight after the game) there were no dogs at netball. This year there are always a number of dogs around the courts and this child spends most of her time on court looking at them.
