3. <u>Deputations</u>

4. <u>Confirmation of the Minutes of the Previous Meeting</u>

The Minutes of the previous meeting held on 13 September 2011 were accepted as a true and correct record.

5. <u>Business Arising from the Previous Minutes</u>

Indian Myna Bird Traps

The response from staff was noted with a further inquiry regarding whether those registered for trapping are required to hold any qualifications, training or conditions of use.

John Truman advised he would include a further note in the minutes and if questions were still outstanding a staff member could attend the next meeting.

Note from Staff

Ballina Council has recently had constructed 65 extra Indian Myna Traps for the public to use as a part of its Indian Myna Community Trapping Program. The traps were built by the Yamba Mens Shed. Traps are currently being handed out to residents who register themselves with Council to trap on private property. Council provides information to those joining the register regarding the use of the traps and the euthanism of the birds.

Whilst the RSPCA prefers that all trappers are suitably qualified for euthanising the pest species birds once caught, no resources for suitably qualified personnel for euthanising birds was made available as a part of the program. Therefore community trappers are expected to euthanise the birds using the information supplied with the trap or source a qualified euthanasia source.

6. <u>Items raised by Members of the Committee</u>

Andrew Playford

NSW Awards for Regional Events

Andrew reported that the East Ballina Lions Club was awarded third place in the NSW Awards for Regional Events.

• Summer Markets

Andrew expressed concerns that the Thursday evening market was additional competition to existing markets and queried about the profits.

In response the Committee was advised that:

- The purpose of the markets was to promote economic development in the Ballina CBD.
- The risks and profit were for Council.
- The summer period is a trial

It was agreed to report the outcomes of the trial to the Committee for feedback. A suggestion was noted that any profits could be used to support the Ballina Community Garden.

• Australia Day Breakfast

Andrew requested that the East Ballina Lions Club be approved to host an Australia Day Breakfast in Ballina now that the main event was being held in Lennox Head for 2012.

Council did not raise objection to this proposal.

Roller Door

Andrew requested Council provide a roller door to support East Ballina Lions Club.

Council advised that it did not hold anything suitable and the club should seek confirmation of costs and could apply to Council for a donation.

Sheila Aveling noted that Paradise FM could ask its audience for donations of a roller door.

Youth of the Year

• Junior Chamber of Commerce

Relay for Life

Code of Conduct

To ensure all members are familiar with the requirements of the Council's Code of Conduct the following information was presented to the Committee.

Code of Conduct and Community Representatives on Committees

All community members of Council's Ward Committees are being reminded that they need to comply with Council's Cod of Conduct. A copy of this Code is on our web site at the following link.

www.ballina.nsw.gov/Your Council/Policy Documents

The core principles of the Code are to ensure that members treat each other with respect and act in an ethical manner.

The Code also asks members to declare to the meeting when they have a conflict of interest. If a Committee is "wholly advisory" (has no delegated authority) then members are exempt from the pecuniary interest provisions of the Act (section 446). This means that there is no automatic requirement for members to leave the meeting when a matter is being discussed that may have a direct financial benefit to the member, or a relative or friend of that member. The Ward Committees are "wholly advisory".

However even if a matter could have been a pecuniary interest, or if a nonpecuniary conflict of interest arises due to a community member having a private interest in a specific item of the committee's business, community representatives will be expected to comply with the conflict of interest provisions of the Code of Conduct. This requires that, as a minimum, community representatives disclose the nature of any conflict. For example, this may be an item that specifically relates only to the street where they live or a business they are involved in and not to a broader issue.

This update has been provided for the information of members.

In addition to this a copy of the Code was included in the agenda. Copies are also available from the Council's website.




