#### RE: MATTERS CONCERNING ROUS MILL RATEPAYERS ASSOCIATION

I have recently become the representative of the Rous Mill Ratepayers Association on the "C" Ward Committee of the Ballina Shire Council

After some discussions with Councillor David Wright I provide the following submissions in regard to matters raised by citizens of the Rous Community.

### 1. Line marking at Rous

I raised the above matter with Council in 2004 and I **enclose** a copy of a letter I submitted on 18<sup>th</sup> May of that year. I did not receive a response. Apart from the obvious discrepancies with the timeline, the request contained therein stands. The situation has not changed and other Rous residents have suggested that provided the road is of the required width then some form of line marking in the centre of the road may be a valuable safety feature. As indicated in my letter, the site is approximately 900 metres to a kilometre east of the Dalwood Road intersection with Rous Road.

## 2. Road condition at 532 Dalwood Road

At approximately 800 metres north along Dalwood Road from the intersection with Rous Road there is severe road deterioration on the southern boundary of Youngman's Creek. Recently some white lines have been placed there by the Council that may indicate that work is to be done. The condition of this section of road was raised by attendees at our recent meeting and also from three other parties who have telephoned me with concern about the dangers that the road poses in its present state. The visibility on that corner has been poor ever since residents planted shrubs on the roadside of their fence and, due to seasons of heavy rain and flooding, it would appear that the road has subsided on the eastern side to

a considerable degree. It would seem that this section of road damage would constitute a need for urgent repair.

## 3. Repair to Rous Mill Road near Youngmans' Creek

After severe flooding of Youngman's Creek in May 2010 the gutter on the northern side of Rous Mill Road 700 metres west of Dalwood Road was severely eroded. Council did dump truckloads of jagged rock into the culvert to stop further erosion but nothing else has been done to date. In its present state the edge of the road constitutes a danger to vehicles and passengers therein. I say that because weeds have grown through the rocks and they are not clearly visible to a driver, particularly someone who is not familiar with the conditions. Should a driver leave the edge of the bitumen due to oncoming traffic that vehicle would most likely suffer damage to the tyres and wheels. It would appear that encroachment of the bitumen is continuing and it is of serious concern to residents in the near vicinity who claim the road is extremely dangerous.

#### 4. Rous Mill Signage

At the southern approach to the village of Rous Mill, which is on Rous Mill Road before it joins Marom Creek Road, there is a wooden sign positioned on top of two upright beams indicating the village of Rous Mill. The sign has come undone at one end and the poles are unstable. It is submitted that this constitutes a danger and in effect negates the effectiveness of the sign in any case. It is requested that the sign either be removed or, preferably, be replaced with something safer and more practical.

#### 5. Exemption from Rate Fees

The Rous Mill Hall Committee has planned a number of working bees where the tasks would include removing rubbish from under and behind the hall. It is requested that the Hall Committee be exempt from tip fees for approximately 3 ute loads of rubbish. They understand that at the moment each ute could attract a fee in the vicinity of \$150.

## 6. Increase in Capacity of Rous Mill Hall

The Rous Mill Hall Committee understands that the maximum number of persons allowed into Rous Mill Hall at any one time is 160. They are not sure how long that quota has been in effect but it would appear that the hall has the capacity to house many more than that number. It is requested that the capacity be amended to allow 220 persons in the hall at any one time. If this request is not within your regulatory framework please indicate who the committee should approach in this regard.

This is not a request but simply for your information. The Rous Mill Hall Committee at the last meeting agreed to approach the Alstonville Historical Society with a view to archiving a number of trunks of historical documents. The Alstonville Historical Society has agreed to do this provided that we sort out the material and send only items of significance. This is a pleasing arrangement

as I am aware that the Council assisted and contributed to the construction of the hall behind Crawford House over recent years.

#### **RE: LINE MARKING AT ROUS**

I have lived at 369 Rous Road Rous Mill for 28 years. The improvements that have been done to the road are much appreciated as is the recent adjustment to the intersection with Dalwood Road.

Line marking has been carried out in relation to that intersection and double lines have been marked from approximately 100 metres in an easterly direction from Dalwood Road. That line does not proceed to include the first small hill in the road and I simply request that the Council consider extending the marking for another 100 metres.

If it is within your budget to do so I would suggest that the next hill approximately 1km from Dalwood Road should also be subject of line marking. This site has been the scene of a number of accidents over the years and in December 2002 two people died as a result of a head on collision on the eastern side of that hill.

It has been my observation that some vehicles travel at high speed along this roadway and the drivers do not pay due regard to the obvious dangers of approaching such hills without the required caution.

I have canvassed a number of local residents and they agree with my suggestion. Please consider this request as I feel that the effort and expense would considerably improve the safety of all road users.
