#### 4. Business arising from Minutes –10 November 2011

#### (a) Alstonville Community Preschool Update

Since the last meeting of the Committee, the Council at its December Ordinary meeting passed the following resolution:

- 1. That Council authorises the General Manager to conduct a community consultation process, as required by the Local Government Act, in respect to a proposal to alter that part of Crawford Park that would be required for the Alstonville Pre-school from sports ground to general community use.
- 2. This consultation is to be conducted following discussions with the proponents of the pre-school and the sporting clubs currently utilising Crawford Park to determine the appropriate size and location of the area for the pre-school.
- 3. That Cooke Park be removed from the list of potential sites for the proposed Alstonville Preschool.

### (b) <u>Disabled Parking</u>

At the last meeting, Paul Busmanis provided advice and relevant standards and the options for disabled parking in Alstonville. The handouts were distributed and the Committee was asked to provide feedback at the next meeting after consultation with their associations.

# 5. <u>Alstonville Main Street Upgrade - Update</u>

Underground power installation is to be completed on 18/19 March (planned outage for works). Old existing overhead powerlines and poles to also be removed.

Installation of new street lights and complete paving in areas of the decommissioned overhead power poles - end of March.

It is planned to install the information board in Freeborn Park at the roundabout end, in the garden bed, with the information facing inwards - the tree will block the view of the board from the roundabout so it is not as though you will be looking at the back of the sign from the road

Staff have identified this as the preferred location in the park to ensure maximum accessibility to the information.

Feedback is sought from the Committee on the location of the information board.
