The Ballina Junior Rugby Union Club will be hosting the above state wide rugby championships in May at Quays Reserve, West Ballina.

The event will attract five hundred players and team officials and a further estimated seven to fifteen hundred visitors to Ballina over the weekend.

Part of the host club's responsibilities is to provide shade structures for all of the players and their team officials as well as additional shade for match officials and medical staff.

We are looking for some assistance from Ballina Shire Council to meet this particular requirement and therefore request that Council consider hiring, at no cost, the eighteen three metre by three metre portable shade structures that Council owns.

This is a significant state wide tournament that receives considerable media coverage. As part of our promotion of the event, we have distributed nearly five hundred tourist information packs across the state excluding the Sydney metropolitan area.

We have a team of volunteers who can arrange to collect and return the shade structures to Council to minimise Council staff involvement.
