"Vegas Enterprises" trading as "Rusty" and their local representative event director Max Perrot wish to object to the proposed changes to the Special Event Policy. Our recommendation is to not change the policy and keep the current year by year event application process.

The following submission was the best we could do at such short notice (four working days) and in no way reflects what could have been presented if we were given a reasonable length of time. *See attachment 1

The details of the criteria Ballina Shire Council staff has requested is yet to decided until we have finished our process of planning the revamped event, the plans should be finalised later this year as stated below in the 2013 plans section.

Reasons for objection

We feel that the "Skullcandy Oz Grom Open" is unproven and cannot be compared to the success of the "Rusty Gromfest" until after the 2012 event is completed and analysed. While using the same days as a long term proven event is definitely an advantage to this new event, it does not necessary follow that local businesses will gain the same benefits that the "Rusty Gromfest" provided for the past 16 years. There are many junior surfing events now in Australia and they are all competing for the same market of junior competitors and their families. The number of competitors entering events has been dropping around Australia over the past three years, with only the best and most popular events maintaining numbers.

If council change the event policy this would effectively prevent "Rusty" from applying to run an event for the next few years and the Ballina Shire would have no backup plan if the new "Skullcandy Oz Grom Open" or their sponsors run into difficultles during that time. The Bailina Shire has seen a lot of events start up and run for a few years and then fold. The "Rusty Gromfest" has one of the best records of any event in the shire having run continuously for 16 years. The company has spent over 1.5 million dollars over that time to hold the event in the Ballina Shire and they would love the opportunity to return in following years if the council and community want them to.

The national governing body of surfing, "Surfing Australia" have provided a letter of support for the "Rusty Gromfest" to return in 2013. *See attachment 4

Relevant background information

The "Rusty Gromfest" referred to by council as Lennox Head junior surfing competition was the first annual junior surfing event to be held in the Ballina Shire. Max Perrot who at the time was the President of the Lennox-Ballina Boardriders (Le-Ba) was a co-founder of the "Gromfest" in 1996 with the late David Sandercock. David was a Le-Ba member along with all of his sons. When we started the event we approached "Rusty" and "The Northern Star" to come up with the \$50,000 required to fund the competition. At the time no businesses in the local surfing industry were in a position to come up with the large funds needed to put on such a huge event. Both sponsors agreed to the offer and the "Gromfest" as it was known then was born. There were 400 entrants in the first "Gromfest" competition instantly making it the biggest in the world. Over the years that original \$50,000 budget grew to \$100,000, which has the budget for the last 5 years.

Le-Ba members were recruited and paid wages to help judge, beach marshal, commentate and are part of the event staff. Local contractors and businesses were used for all materials and services required by the event. Local community organisations were offered the opportunity to raise funds for themselves to run water security, food outlets and setting up the contest infrastructure. These groups included: Lennox –Ballina Boardriders, Lennox Head Rural Fire Brigade, Lennox Head Scouts, Ballina Naval Cadets, Lennox Head-Alstonville Surf Lifesaving Club and Lennox Longboarders. Other local groups and individuals were offered the chance to run raffles at the event and promoted over the PA system to raise funds for all types of things including children's cancer, Le-Ba raising funds to assist their junior surfers to attend major events, volunteer Fire Brigade, Lennox Head pre-school and many others.

Some people within the local surfing community objected to any competitions being held in those times so as to show all the local free surfers some respect the decision was made that the event would never be held at Lennox Point or Boulders and that the two competition venues would be Lennox beachies and North Wall Ballina. These venues would also accommodate the double bank format and enabled 400 entrants in the first "Gromfest" competition. Over the years this number was reduced gradually with changes to heat durations, waiting periods, single bank finals and the addition of the Kerrazy Air Invitational, the last few years there has been 248 competitors.

Innovations to the sport of surfing were introduced at the first event and the following were firsts in Australia: 12 & under boys division, 12 & under girls division, double bank format, double bank commentary. Over the years further firsts included: a father and son contest, Kerrazy Air Invitational (aerial surfing contest), entertainment and fun competitions on the beach for the younger kids, live music concert courtesy of sponsor Sony Music with "Something for Kate" on the Megan Crescent oval, surf film and BBQ nights at the Lake Ainsworth Sport & Rec Centre, live art creations at the beachfront by professional artists.

2013 Plans

Rusty announced they are taking a break from their prestigious Gromfest event in 2012. The event, normally held at Lennox Head in New South Wales, has been running for the past 16 years and has become Australia's premier 'Grommet' Under 16 surfing event over that time.

Rusty Marketing Manager, Damon Hayes said that while decision wasn't taken lightly, it was one that had to be made to ensure a long and bright future for the event. "We love the Rusty Gromfest, it's a part of the company's heart. However, the format is starting to feel somewhat dated. We really want to make sure we're presenting something special for the kid's that captures their youthful spirit. So, we're taking some time to give us a chance to talk with the competitors and come back with something exciting to breathe renewed life into the grommet scene."

Rusty at this stage is still planning to revamp the concept and make it bigger than ever for 2013 and need time to plan a fresh concept.

We would like the opportunity to put forward a proposal for 2013 and will present a firm offer and final event plan and proposal after the current financial year.

We plan to run the competition over the 5^{th} to the 9^{th} of July period in 2013.

The company has spent over 1.5 million dollars over 16 years to hold the event in the Ballina Shire and they would love the opportunity to return next year if the council and community want them to.

The deadline for handing the submission in was the 23rd of April. I refer to recent communications in respect of the subject matter and in particular to the following:

- meeting with Council Officers Jillian Pratten, Holly Archibald and Caroline Klose and Le-Ba Committee members Tony O'Brien and Paul Snellgrove on the 16th April 2012
- Council's letter to Mr O'Brien dated 17 April 2012

As you are aware, the Lennox-Ballina Boardriders Club (Le-Ba – ABN: 18678004353) has, in association with a major and large number of secondary sponsors, has organised and is committed to conducting the subject surfing competition for a 3 year period.

As will be articulated in this submission, it is proposed to hold this event for the next three years (2012-2014) and a commitment to such period is extremely important to facilitate the planned growth and development of the event

If the event is as successful as contemplated, it would be the intention to hold it in perpetuity, whilstever sponsorship and funding was available. At this stage, funding is available for three annual events.

It must be stressed that the idea to hold this competition was formulated as a direct consequence and immediately upon the broadcasting by Rusty/Mr Max Perrott of the cancellation of the 2012 Rusty event. If Rusty was not cancelled, this event would not have been contemplated.

Le-Ba is a local, not-for-profit surfboard riding club that has been in existence for in excess of 25 years. The club has a solid local membership base of some 200 people and has a very strong youth and family orientation and involvement.

Le-Ba is one of the pre-eminent surfboard riders clubs in Australia and under the President-ship of Mr Jonathon Hewitt has an extremely bright and prosperous future. Some of the recent achievements and current members of the club include:

- winner of the 2011 Straddie Assault (National event)
- winner of the 2012 Jim Beam Tag Teams Event (National event)
- winner of the 2011 Ransom NSW Junior Tag Team Event (State event)
- winner of the 2011 Ransom National Junior Tag Team Event (National event)
- 2nd place in the 2011 Kirra Junior Teams Challenge (National event)
- club members include two WCT surfers, NSW and Australian Under 16 Champion, NSW 14 State Champion
- commencement of weekly junior training squads at Lake Ainsworth Sport and Recreation Centre – this was a club initiative that was originally formed to support junior competitive club surfers – the program has since been expanded to serve the broader community and other sports now include rugby union, rugby league, athletics and soccer – the training squads comprises some 30 youth under the age of 18

The main objectives of this event are to:

- provide a very high quality, interesting and exciting junior surfing event, the type and format of which does not currently exist
- fill the void that was left by the cancellation of the Rusty event
- have a very high local community involvement (particularly youth and families of the surfing fraternity and local business houses)
- stimulate the local economy by utilising and involving local business houses in the event which will provide significant social and economic benefits for the local community
- provide an on-going fund raising mechanism for the continued operation of Le-Ba
- provide an on-going fund raising mechanism for particular charities/local organisations – for 2012 the proposed beneficiaries are the Lennox Head Surf Club, Lennox Head Public School and Cystic Fibrosis Foundation
- provide for the continued development and growth of the local junior surfing population

Since the inception of the idea and promotion of the Skullcandy event, there has been overwhelming support from the local community (particularly from Lennox Head, Ballina and Byron Bay) for the event. Provided herewith are letters of support for the event.

The event is tailored expressly at youth (16 years of age and below) with a major family involvement/component.

As requested in your 17 April letter, the following comprises the event proposal which is provided for Council's consideration. It should be noted that the following has been provided in good faith as the current strategy and event planning for the operation of the event.

Council should be mindful of the fact that changing circumstances could result in slight changes to the detail provided with this application.

Innovation

- an exciting and innovative judging criteria has been developed exclusively for the event by Mr Pritamo Andreht [current Australian Surfing Professional (ASP) Head Judge] - this criteria has not been used in any junior surfing event anywhere in the world
- the majority of the judging panel is to comprise current ASP judges a first for any junior surfing event
- jet ski assist for finals of the under 16 boys age division
- high level of competition infrastructure comprising:
 - o three level scaffold structure for judges, media and marshals
 - o grandstand/bleacher seating for spectators
 - o competitor's area (lounge, food, music, heat preparation)
 - on-site large video screen for replays and highlights
- each competitor will be provided with a photo ID which will provide access to competition areas
- revolutionary new computerised scoring and reporting system ("Compusurf")
- provision of daily highlight package for website and press
- live web streaming of event through Skullcandy TV
- interactive experience audio and visual tents will be set up by Skullcandy to enable competitors and spectators to test Skullcandy products
- · direct involvement of Lennox Head business houses into the event
- discussions have been held with organisers of the Billabong Occy Grom Comp (which is held the week prior to this event) with the intention of holding a series challenge (NB: this is not able to held this year and is planned for the subsequent 2 years) – Billabong is very interested in this concept and have requested further discussions
- this is integral to and will form an on-going component of Le-Ba's Junior Development program which is being conducted in partnership with the Lake Ainsworth Sport and Recreation Centre

Format

- four (4) day event to be held within a five (5) day period (to provide a contingency for adverse surf/weather conditions)
- · divisions:
 - o boys 12, ,14 and 16 age divisions
 - o girls under 16 division
- primarily single bank competition with only 4 surfers in the water at any one time (double banking is proposed for the repercharge/2nd chance round)

- second chance qualifier (repechage round) enables every competitor to surf at least twice
- 'man-on-man' final series for 16 boys from quarter finals on, heats will be two person only

Event dates

- 6th 10th July for 2012
- 2013-2014 second week of the July NSW school holidays
- event to be conducted during the hours of 7.00am to 5.30pm

Capacity to deliver event

- a financial commitment has been provided from a major international Byron Bay based company (Skullcandy) for a three (3) year period – refer attached
- commitment by Le-Ba Committee and members (both financial and operationally) – Le-Ba has a membership of 200 people who will provide assistance during the event – this voluntary assistance significantly reduces the operational costs of the event
- financial commitment from a significant number of major and secondary event sponsors – refer below
- Le-Ba Committee and members have experience and qualifications in the surfing industry and with surfing competitions/events (ie business directors, senior marketing managers with surf companies, senior government and non-government strategists, business operators, qualified judges etc)
- Le-Ba in partnership with Quiksilver Australia run a national fundraising competition in the local area for the 'Movember Foundation'
- Le-Ba has been established for in excess of 25 years and holds a monthly local surfing competition in the Shire


