6. Outstanding Business

a. Tintenbar School of Arts Drainage and Run-Off

An inspection of the problem has been carried out with Council staff and options discussed. The Hall Committee will now seek funding to address the works required.

b. Flooding of Coast Road at Boulder Beach and Ross Lane

Action: That Council prioritise improvements to Ross Lane to reduce its susceptibility to flooding. The work is requested because of the regional status of the road and the current inconvenience and risk to motorists regularly using the road in times of heavy rainfall.

8. Williams Reserve – Damage to Vegetation

Received and noted.

Concern was raised that inadequate Council resources are being applied to regularly monitor sensitive vegetation areas in Lennox Head that are vulnerable to vandalism.

A secondary concern expressed was that the remediation work recently undertaken by Council in the western part of Williams Reserve has been poorly implemented.

9. <u>Business with Notice from Members</u>

Malcolm Milner - Lennox Head Landcare

a. What is the status of the Geolink Lennox Headland Master Plan as a Council planning document? One page is displayed on line giving it an "official" standing to the public. Can it be updated with community input?

A full copy of the Lennox Headland Master Plan is available on Council's website. A development application was submitted and the master plan was approved by Council.

The meeting was advised that as most of the actions set out in the master plan have been implemented there is no plan to review the master plan.

Malcolm Milner advised that he did not think that the stairs that have been installed are consistent with the master plan and also voiced concern over the location of the public amenities currently being installed.

Advice was provided that the stairs were constructed with materials that consist of recycled plastic and composite fibre which provide an extended life expectancy in this harsh environment. The (then) Department of Lands also advised that it would not support the use of timber in the construction of the stairs.

The option to use natural materials such as rocks was explored however it was externely difficult to construct stairs on the slope that would comply with the require standards.

The master plan is a concept plan only and the finer details of elements of the plan are subject to design and change at the time of implementation. The public amenities could not be located in the preferred location as this would have involved an unacceptable impact to an area of native vegetation.

b. What is the possible timing for construction of further sections of Lennox Head to Ballina Cycleway and also what is state of progress with Coastal Pathway planning?

John Truman advised that staff anticipate the finalisation and lodgement of the pathway development application in coming weeks. If approved, detailed design and staging will follow, with construction dependent upon the allocation of Council and external funds.

c. Is it planned to have the existing section of Hutley Drive extended southward before or in conjunction with development of the Petrac (Bank of Scotland) site?

The information supplied was received and noted.

11. <u>Business Without Notice</u>

Fran Byrne:

- a. There is a street sign down at the end of Banksia Street, East Ballina.
- b. Asked about disposal of old Analog TVs and was advised that Council would be providing free disposal until Christmas.
- c. Requested information concerning a draft management plan recently prepared by Far North Coast Weeds. Ms Byrne was advised the information is available on that council's website.

Paul Button:

Advised that the *Carols in the Park* are on in Lennox Head on 2 December 2012.

- a. Asked when the service club signs with their meeting dates were going to be replaced. Advice was provided that Council had resolved not to replace the signs and the new signs provide Council's web address that has the information.
- b. - a. Requested a report at the next meeting on the status of the Lennox Head Surf Club redevelopment.
- b. Advised that the area surrounding the Lennox Head Cultural and Community Centre is poorly maintained. Mr Shaw was advised that Council's Open Spaces and Reserves' staff clean the skatepark and around the community centre every morning. The advice on the courtyard will be forwarded to the Centre Manager.
