North Creek Dredging (Update from Crown Lands Division

Extensive discussion with Crown Lands representatives with key points of interest including:

- Dredging for public benefit (positive environmental outcomes) no need for Crown to follow expression of interest (EOI) process
- Dredging for resource must follow EOI process classified as extractive industry
- Preference from Crown is to follow EOI process, even when there is public benefit
 as this then removes any uncertainty about how any extracted resource can be
 managed
- For the EOI process respondents will need to submit their proposed royalty along with demonstrating their expertise, resources and ability to manage dredging
- Once EOI awarded the successful applicant must then obtain all approvals
- Estimated cost considered to be in the vicinity of \$150,000 remains uncertain
 unless work commences on the approval process and the area in question is
 thoroughly assessed
- Crown recommend that the proposal be for a larger area which would then allow a methodical dredging program to be implemented (i.e. Missingham to north of Prospect Bridge)
- Lease could be a preferred option as a lease can be transferred licences cannot be transferred
- · Any agreement would be for a defined term
- Any agreement would most likely be renewed after the term subject to the licensee complying with their operating conditions
- To commence the EOI process Council would need to write to Crown Lands

Ballina Bar Update

Paul Hickey referred to an email received from Crown Lands this morning – latest hydrographical survey indicates a general deepening of the bar (copy of most recent emails received are attached)

Garry Joblin supported this comment, although indicated that it was only minimal.

Further surveys are planned for August 2013 by Crown Lands to continue to monitor the bar.

Trawler Harbour Update

Phil Hilliard confirmed recent discussions with Crown Lands where contaminant testing of this location had provided positive results (i.e. minimal contamination). Strong likelihood dredging of this location will proceed with funding included in the 2013/14 NSW State budget.

Regatta Avenue Precinct Update

Paul Hickey confirmed that Council would be applying for a Better Boating Program (BBP) grant to undertake a master plan for this precinct.

This was based on advice from Crown Lands and BBP that a master plan would then allow Council to seek further grant funding to implement the works identified in the master plan over the life of the plan.

North Wall

The Mayor confirmed his most recent discussions with Minister Don Page where indications are that the State Government may take responsibility for rectifying the loss of views that resulted from the recent reinforcement works undertaken at North Wall.

Brett Phillips agreed he would raise this issue with Steve Willis who is a new officer in Crown Lands responsible for this type of infrastructure.

Please find attached the most recent hydrographic survey (2013) for Ballina bar. This recent survey complements the 2010, 2011 and 2012 surveys and the report "Feasibility Study into dredging Ballina Bar" which have been previously provided to key stakeholders.

Crown Lands is currently organising supplementary survey drawings to highlight depths in the navigation channel for easier for interpretation. These drawings should be available later today.

The hydrographic surveys undertaken over the last 3 years (2011, 2012, and 2013) highlight the dynamic nature of the Richmond River Entrance Bar. These surveys provide only a snapshot of bed levels at that time, and that entrance bars are highly dynamic areas subject to complex interactions of coastal, estuarine and climatic processes.

At the time of the 2011 survey, significant shoaling was evident with navigation depths of around 3.6m AHD recorded across the entrance bar. However, across subsequent years to 2013 a general deepening of the bar has occurred in comparison to August 2011 conditions, most likely in response to the effects of flood events and/or ocean swell regime.

The Office of Environment and Heritage (OEH) is currently finalising a detailed review of the bed level surveys and linkage to flood events, ocean wave direction and magnitude and regional climatic conditions. When available, the outcome of this review will be made available to key stakeholders, including:

- NSW Office Environment & Heritage

Crown Lands is currently organising a new survey of the bar to be undertaken in August 2013 subject to availability of a suitable surveyor and favourable weather and ocean conditions. The results of the new survey will be made available to key stakeholders once the survey is complete.



Please find attached supplementary survey drawings that highlight depths in the navigation channel. The depths shown on the attached drawings are in Australian Height Datum (AHD). This means that the depths shown are below, approximately, mean sea level.

At the time of the 2011 survey, significant shoaling was evident with navigation depths of around 3.6m AHD recorded across the entrance bar. However, across subsequent years to 2013 a general deepening of the bar has occurred in comparison to August 2011 conditions.

The 2013 survey indicates depths of greater than 5.0 metres AHD generally along the navigation leads leading into the entrance.

Nevertheless, these surveys provide only a snapshot of bed levels at that time, and that entrance bars are highly dynamic areas subject to change.




