1 Introduction

Sumbiosis Pty Ltd was commissioned by Ballina Council in June 2013 to design and facilitate a community consultation process with the residents immediately adjacent to Porter Park to allow them to contribute their ideas and input to the proposed embellishment of the Park. The decision to improve the Park follows the recent decision to allow the construction of an Aboriginal Childcare and Family Centre within the Park. This decision was unpopular with many residents who believed that the Park was donated on the condition that it remained as a large open space to allow for cricket games which have been played and enjoyed by the residents for many years.

This report outlines the key issues raised by community members who attended two consultation events in the Park on Saturday 7 and Wednesday 11 September 2013, as well as two written submissions.

The results from this first stage of consultation will form the key input to a series of landscape designs options that will be taken back to the community for a final round of consultation before Council considers and decides on the final outcome.

2 Objectives

The objectives for this community consultation were to:

- Design and facilitate a process with the residents immediately adjacent to Porter Park to allow them to contribute their ideas and input on the embellishment of the Park following the decision to construct a new Aboriginal Childcare and Family Centre within the Park.
- Where possible, build relationships and communication between Council, local residents and the Aboriginal Childcare Centre.

3 Method

Approximately 400 invitations were letter box dropped to residents who live in close proximity of Porter Park, being the square block around Boatharbour Road, Kalinga Street, Waterview Court and Riverview Avenue. The flyer provided them with the following opportunities to participate in the consultation process:

 A community event in the Park on Saturday 7 September including a free barbecue and activities for children. During this event structured discussions and questionnaires were used to collect resident's views and ideas on the Park.

- Another smaller consultation event (without the children's activities) was offered as an alternative on Wednesday 11 September in the Park.
- The letter also advised that residents could provide written feedback about possible improvements to Porter Park directly to Council or arrange for the consultants to meet with them separately to hear their views.

The letter forwarded to residents is included as Appendix 1.

During the two community consultation forums in the Park a photo montage of possible improvements including playground equipment, landscaping, seats and covered barbecues was displayed at both consultation forums to give residents some inspiration and ideas for what may be possible in their Park.

Door to door interviews were conducted with some residents on Saturday 7 September.

Several attempts were made to contact the Aboriginal Child Care Centre to canvass their views and opinions about the improvement of Porter Park. Unfortunately at the time of writing this report we had not managed to schedule a meeting to receive their input.

The questioning route used for the interviews and consultation events was as follows:

- 1. What do you like about Porter Park?
- 2. What don't you like about Porter Park?
- 3. What do you use the Park for?
- 4. How could Porter Park be improved?
- 5. What would need to change for you to use Porter Park more?

In total, 51 residents participated in the consultation, as follows:

- 30 residents attended and participated in discussions at the community event on Saturday 7 September.
- Seven residents attended the consultation forum on Wednesday 11 September.
- 12 residents completed questionnaires led by the consultant during a door knock of local houses on Saturday 7 September.
- Three written submissions were emailed/mailed to Council



4 Results

As all of the consultation methods utilised the same questioning route, the results have been collated together and summarised below. Please note that responses to questions 4 and 5 have been merged due to the similarity of themes

4.1 What residents like about Porter Park


The Chart below shows what people like about Porter Park in order of frequency:



There were a few people who indicated that they were happy with the Park the way it was and stressed the need to retain the large open space without the addition of more buildings that would further reduce the available area.

4.2 What residents don't like about Porter Park


The Chart below shows the things people said they do not like about Porter Park in order of frequency.

4.3 How residents use Porter Park


The Chart below gives an idea of the sort of uses the community have for Porter Park in its current form.



Many parents and grandparents who attended to the consultation indicated that their houses were located on very small blocks of land and that Porter Park was used as their "backyard" where children can run around and play games.

4.4 Ideas for improving Porter Park / Possible changes to increase resident usage

The chart below shows the relative frequencies for the improvements and things that would need to change for people to use Porter Park more often.

Most residents would like the Park to have some more trees and native plants to provide shade and attract more birds. There were numerous requests to plant a row of trees to screen off the Child Care Centre from view. However many people requested that any plantings be kept around the perimeter of the Park to preserve the large open space currently provided by the Park.

There was a preference for the children's playground to cater for 5-12 year olds and the rope equipment shown in the photo montage was a popular choice. Again, residents requested that the playground be located to the side of the large open area rather than taking up space in the middle of the Park.

There were many residents who own dogs in the area and a popular suggestion was to install a fenced off leash dog area including water troughs and dog waste disposal bags and bins.

Two residents in wheelchairs and parents with toddlers complained about the state of the pathway along the edge of the Park. It was too windy and covered with grass to allow easy access for wheelchairs and bikes or scooters for small children. There were requests made for the footpath to be reconstructed in a straight line and for any new infrastructure to have disabled access.

Given the many complaints about vehicles gaining access to the Park and tearing up the surface, people suggested bollards be erected around the outside of the Park to prevent vehicular access.

Some residents thought that some robust, vandal-proof gym equipment would be well utilised if placed around the perimeter of the park with a path between each station.

Some residents indicated they would like to see some covered barbecues installed in the Park. There were a couple of people who said they did not thing these would be used and may be vandalised and encourage more drinking and anti-social behaviour.

Given the loss of the cricket matches residents were keen to see some sport played at the Park again. Some suggested an asphalt area off to one side with a basketball ring to enable half-court basketball and netball to be played.

4.5 Other comments

It's important to note that many residents used the consultation as an opportunity to raise concerns about the perceived loss of amenity resulting from the construction of the Aboriginal Child Care Centre in the Park. Many residents expressed anger that the Centre proceeded despite their objections. The majority of these residents spoke about how they used to watch cricket being played in the Park, but have now lost access to this important recreational and social activity. Some residents also had concerns that the Centre would lead to an increase in undesirable social issues in and around the Park.

Several residents spoke about the 'divide' that has been created in the local area as a result of the Centre. One resident said that she needed to be very quiet in naming her lack of objections to the Centre as this stance isn't congruent with the feelings of the more vocal residents who strongly opposed it. The same resident spoke about a series of informal 'street meetings' that occurred during and after construction where residents gathered to name their opposition.

There is likely to be ongoing underlying conflict within the community as a result of the Aboriginal Child Care Centre. Council could assist to facilitate a passive conflict resolution process through opportunities like a community art projects or a series of ongoing events that bring people from the Aboriginal Child Care Centre together with local residents to improve mutual understanding and therefore to reduce the conflict in the medium term. This has been included in the recommendations section of this report.

There were a significant number of people who raised concerns about vandalism and so stressed the importance of durability for any new park infrastructure. Some people even recommended against using wood for fear that this may be burned.

For a full overview of responses from the community events are shown in Appendix 2.

4.6 Written submissions

As noted above, three written submissions were received by email/mail and these are shown in Appendix 2.

One of these submissions outlines the dissatisfaction with the outcome of the consultation process for the Aboriginal Child Care Centre. Mr Williams explains that the Park was donated on the basis that the area would be used as a cricket ground and that he would like this restored in some capacity.

Another submission provides a detailed list of suggestions and a mud map of the suggested design. Many of these suggestions are consistent with resident's views heard during the community consultation events in particular, retaining a large amount of open space, accommodating multiple uses and providing a children's playground.

The third submission from the Balllina and District Citizens and Ratepayers Association highlights the need to keep the Park as open space with only minimal plantings and bollards around the outside. The Association does not favour installation of picnic tables or a playground due to concerns about vandalism.

However, there were a significant proportion of stakeholders who attended the consultation forums who would like to see the inclusion of covered picnic areas, seating and a children's playground all constructed out of vandal-resistant materials. With the slightly higher proportion of babies and pre-schoolers in West Ballina compared with the whole shire, and the relatively small block sizes for the homes surrounding Porter Park it would be important to provide some stimulation and activities for your children at the Park.

5 Recommendations

1. Prepare no more than two options for the redesign of the Park which can then be taken back out to the community for a final round of consultation before recommendations are made back to Council.

Include in the design options:

- Ensure that improvements to Porter Park allow for multiple uses to accommodate children's play, relaxation, walking (including dog walking) and informal recreation.
- Maintain the majority of the Park as open space. The provision of any additional amenities and/or landscaping should be focused on the perimeter of the Park to allow users to continue accessing it for ball games and to maintain the feel of the Park as a 'big backyard'. If landscaping is to be incorporated, ensure that it doesn't block sight lines in to the Park to maintain passive surveillance.
- Plant more trees and native plantings around the outside of the Park to increase the amount of shade and attract birdlife. Consider planting a line of trees along the side of the Childcare Centre to screen it from the view of the Park.
- Install a playground area for children, preferably under the cover of trees on the Daydream Road perimeter of the Park. The equipment will need to be robust and vandal-resistant.
- Include a fenced off-leash dog area with water troughs and dog waste disposal bags and bins
- In acknowledging the disappointment of some locals in loosing regular cricket matches at the Park, it's recommended that Council consider an exploration of the following:
 - Installing a mesh cricket net around the northern end of the existing cricket pitch to enable safe cricket practice.

- Exploring half-sized fields for other junior sport e.g. soccer or football. Note: Many of the residents who expressed anger at loosing regular cricket matches named a disappointment at loosing organised sport in the Park. i.e. It would be feasible to offer alternative sporting facilities.
- Include an area of asphalt with a basketball ring and area for hopscotch
- Improve the direct access to the park via footpaths/cycleways suitable for use by wheelchairs and young children on bikes and scooters.
- Include robust vandal-resistant gym equipment around the outside of the Park with a footpath between each station.
- Include a variety of seating and covered areas around the edge of the Park.
- 2. Explore options (using a community development framework) to deal with the residual anger that exists in the local area due to the construction of the Aboriginal Child Care Centre in the Park. One option would be to create an opportunity for residents to come together with families that use the Centre to create a functional community artwork such as a large scale game board for children to play on (as part of the proposed playground). This could be designed and created by the community over two or three low cost events in the Park. Further, it's recommended that the Centre hold one or two 'open days' (possibly as part of the proposed art events) to build relationships and dispel myths about 'what happens within the walls of the Centre'.

PORTER PARK

Improvement of the usability and amenity of Porter Park is important as it is well documented that access to open space is important for better general health, reducing stress levels, improving mental health and, in turn, lowering health costs. It is important that the sense of open space is not lost.

Some suggestions for consideration


- 1. Ensure that the improvements provide for **multiple uses** to accommodate children's play, relaxation, walking and informal recreation and that they are **pleasant and welcoming** to all age groups
- Ensure that activities can be viewed from adjoining houses and streets and ensure that landscaping does not block sight lines onto the park for the safety of park users.
- 3. Retain easy access onto the current turfed/grassed areas.
- 4. Retain the **large open space** to enable people to kick a football or hit a cricket ball without interfering with other users or neighbouring houses and the Child Centre.
- 5. Provision of a fenced, shaded playground area with a variety of play activities (similar to Fawcett Park)
- 6. Provision of **mesh cricket net** around the northern end of the existing cricket pitch to enable safe cricket practice.
- 7. Provision of a **basketball hoop and backboard** with a concrete pad, possibly at the back of the cricket net.
- 8. Provision of one set of **football goal posts** to enable goal kicking practice.
- Provision of low maintenance seating around the perimeter of the turfed/grassed areas with low level shrubs and easily maintained landscaped garden beds.
- 10. Provision of either a low maintenance and sustainable gravel pathway or concrete pathway around the perimeter of the park for use by children on bikes and scooters, walkers, people pushing prams and wheelchairs, people on wheelie walkers and walking sticks, gophers and joggers a shared footpath
- 11. Retain the covered awning on the western side of the park, add **table and benches** and plant low level easily maintained gardens around the awning.
- 12. Plant three or four shade trees on the eastern boundary alongside Hayman Street
- 13. Open the toilet block during daylight hours, say, 8am until 5.00 pm daily

14. Add **lighting** to the east west footpath to improve safety. Lighting is available which will not impact on adjoining homes.

following our last monthly meeting, held Saturday 21 September, where the question was put to members regarding their ideas for the beautification/alteration of Porter Park, and subsequently the many phone calls we received on the same subject, it was unanimously agreed that Council should take a "minimalist" approach to any changes to the existing green space.

Many said that they don't want anything done to the Park, whilst the majority was agreeable to the following:-

- [1] That Bollards should be placed around the park to keep "hoons" in motor vehicles off the grass.
- [2] that native trees be planted in a line along the side of the Family Centre, to disguise its stark appearance.
- [3] That a drinking fountain [bubbler] be installed for the use of park patrons wherever convenient to do so.

Because of the incidence of vandalism, and hooliganism in the area, it is felt that the installation of picnic tables would be foolhardy, and an expensive option for Council to maintain.

For the same reasons we do not ask for children's playground equipment to be installed. West Ballina is [as Council would be all too aware] already under size in open greenspace, and the vast majority of locals would like The Park to stay as it is.
