Membership of Ward Committees

As part of our on-going consultation with the residents of Ballina Shire, Council has in place community based committees for each of the shire wards (i.e. A, B and C).

The purpose of these three committees, referred to as Ward Committees, is to provide Council feedback on matters referred to the committees by Council and/or matters raised by committee members on behalf of their community.

Membership of the Ward Committees is limited to representatives from locally based not for profit community groups, with one member representing each group. The committees meet bi-monthly (on odd numbered months) as follows:

A Ward – on the second Tuesday at 4.00 pm at the Ballina Shire Council Chambers

B Ward – on the third Monday at 4.30 pm at the Ballina Shire Council Chambers

C Ward – on the second Thursday at 5.00 pm at Crawford House Alstonville

The Ward Committees play an important role in Council's interaction with the community and Council is now seeking further expressions of interest for membership. Not for profit organisations interested in joining should forward a written submission to the General Manager by Friday 25 November 2016. Submissions must include, as a minimum, the following information:

- Name of organisation
- Brief overview of charter of organisation
- Ward committee for which membership is being sought (i.e. A, B or C)
- Organisation's representative and contact details of who will attend meetings

Existing members need not re-apply.
