Part E: Banner Design

Dimensions: 2360mm high x 850mm wide. This includes a triple sewn 105mm wide hem tube at both ends. The hem tube is to be open at both ends (so that it can slide over the horizontal arms). Therefore, when creating artwork, the canvas should be 2150mm high x 850mm (see style sheet for instructions).

The banner material used must be "breeze through material (mesh type)" or heavy gauge sign vinyl, available from professional sign writers. Banners made from vinyl material must have 4 semi-circle flaps cut through the centre of the banner, with a minimum 200mm radius.

- Design templates and/or existing banners must be reviewed and approved by Council prior to installation. An image of the proposed banner is to be lodged with this application.

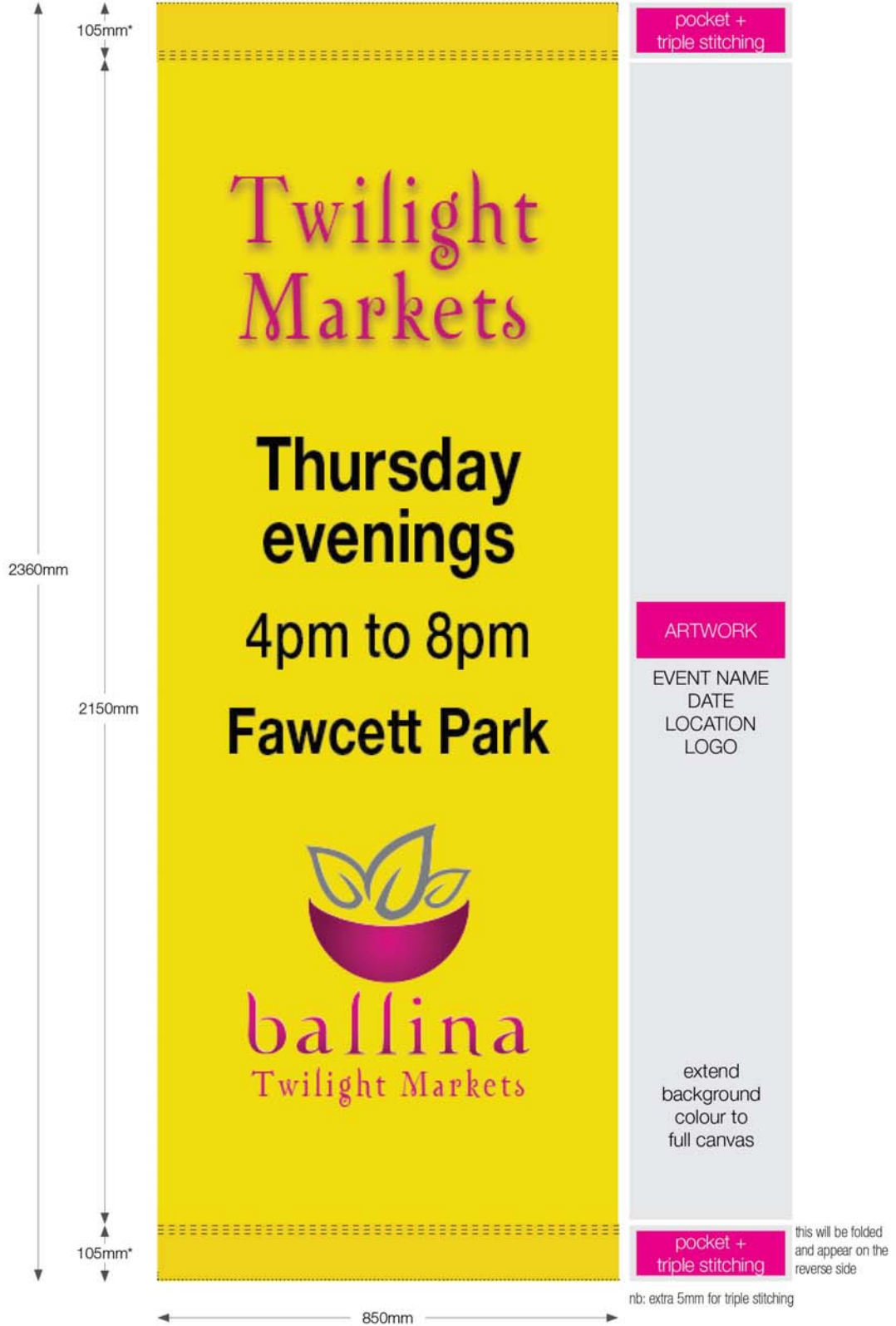
