Lake Ainsworth - Changes for Dog Owners

Lake Ainsworth is an important recreational area situated in a sensitive ecological location. For this reason, Ballina Shire Council has resolved to prohibit dogs from the eastern side of Lake Ainsworth.

These changes also include the extension of the off-leash dog area north of the Lennox Head-Alstonville Surf Life Saving Club. Dog walkers can now let their dogs off the lead just north of the Surf Club.

Council rangers have been in the local area speaking to dog owners over the past few weeks to help explain and educate the community about these changes. After this community education is completed and the new signage is installed dog owners doing the wrong thing may be fined.

There are still plenty of off-leash dog areas across Ballina Shire, including:

- Bicentennial Gardens, the northern area of the reserve, Ballina
- Compton Drive, East Ballina
- Gap Road, Alstonville
- Seven Mile Beach, north of Lennox Head – Alstonville Surf Life Saving Club
- Ballina Heights Estate, eastern reserve area, Ballina Heights
- Headlands Drive Drainage Reserve, Skennars Head
- The Spit, Ballina
