Proposed Road Closing

Under Section 35 of the Roads Act 1993, the Minister for Lands and Forestry will consider the following road closing proposal from Ballina Shire Council.

Section of River Drive adjacent to 3 River Drive, East Wardell

The section of road under consideration comprises Council public road adjacent to Lot 20 Sec 2 DP 996, Lot 9 DP 234385 and Lot 224 DP 47452 at East Wardell. This area of land is not required by Council for road purposes. Upon closing the road, Council intends to sell the land to the adjoining landowner of 3 River Drive, East Wardell.

Submissions

Council, acting on behalf of the Minister, will receive submissions regarding the proposal.

All submissions will be referred to the Minister's delegate for a decision regarding the proposed road closing.

Road Works - River and Brunswick Streets, Ballina

Road and footpath construction works for the new Metro Service Station at 323 River Street (DA 2016/25) are commencing in late June 2019. The Brunswick Street intersection (northern side of River Street) will be closed for approximately two weeks during the construction period.
