Road Works – Changed Traffic Conditions River Street (Moon Street to Grant Street) Ballina

Council has commenced works on stage 4 of the Ballina Town Centre Upgrade. The beautification works include road reconstruction, widening and paving of footpaths, new landscaping, street lighting and improved footpath accessibility.

The project is divided into four zones to minimise the impact to motorists, pedestrians and businesses.

There will be a combination of night and day works to ensure pedestrian access is maintained. To complete these works, Council will close one lane of River Street one section at a time. This means motorists may be detoured via Tamar Street, depending on the project stage and direction of travel.
