OBJECTIVE

To provide policy guidelines to assist shire residents who represent Australia.

POLICY

Council will provide assistance for travelling and accommodation expenses incurred by Ballina shire residents being who are selected to represent Australia as an individual or as a member of a national team.

Guidelines for Selection:

1. The individual recipient must be chosen in a team or event that is part of a nationally recognised federation
2. The recipient must demonstrate they are a resident of the shire
3. The recipient is only entitled to one donation each financial year
4. The selection of an entire team will only result in one donation
5. The assistance must be provided for expenses that are to be incurred by the recipient as part of their role in representing Australia.

Strategies

The level of assistance to be provided ~~\$431 (this figure is indexed by CPI each year)~~ for applicants representing Australia overseas and ~~\$225 (also subject to CPI)~~ for applicants representing Australia within Australia, but outside the local government area is provided in the table below (with forecast CPI). Applications will be ~~determined by~~ reported to the Council when required.

BACKGROUND

In accordance with Section 356 of the Local Government Act a Council Resolution is required for each and every donation each year. This policy provides a framework to assist Council when considering donations of Council fees for Community Groups.
