i) West End Hall

Cr Meehan advised the Committee that the Council property, West End Hall sold at auction for \$270,000 minus auction costs.

ii) Solar Light Deadmans Creek Road

Cr Meehan asked for an update on the installation of the solar light.

John Truman advised that the road safety and risk assessments have been completed, the light has been procured and the installation contractor has been engaged. The contractor will finalise installation shortly.

iii) Clement Park Sign

Andrew Playford advised that the Clement Park sign has been reinstated on Cherry Street next to the new carpark.

iv) McDonald Park

Andrew Playford advised that the McDonald Park sign was currently being held by the Ballina High School Heritage Committee who are hopeful the sign can be reinstated.

v) Shared Pathway

Andrew Playford thanked Council for the work so far on the shared path and asked why work had stopped.

John Truman advised that during work our contractor had discovered items that are potentially Aboriginal artefacts. This means work was stopped to enable OEH and our Cultural Heritage Advisor to assess the site. We now have approval to recommence work on a portion of the site. Work on some sections will be delayed while we prepare an Aboriginal Heritage Impact Permit Application.

vi) Airport Upgrade – Security Entrance

Andrew Playford asked why the entrance to the security area and the corridor to the facilities was so narrow.

vii) Canal Road Footpath

Our current focus however is a project to assess an overland flow model for Ballina Island and West Ballina so that the mitigation options for this part of the floodplain can be reviewed.

John Truman advised the appropriate response to these concerns is for a meeting to be arranged with the Manager Environmental Health and David to discuss this matter.
