6. Items Referred to General Manager's Delegate

6.1 Proposed Timed Parking Zone - Ballina Library, River Street, Ballina

RECOMMENDATION

The Committee supports provision of a 2H PARKING Zone (Business Hours 8:30 am to 5:00 pm Monday - Friday and 8:30 am - 12:30 pm Saturday) consisting of four spaces on the south side of River Street from the existing Disabled Parking space in front of the Library towards the corner of Las Balsas Plaza and the four spaces are to be line marked.

6.2 Access - 1029 Tamarind Drive, Tintenbar

RECOMMENDATION

Subject to the driveway having a compliant sight distance for a private driveway in a 80kmh speed zone, the Committee supports removal of the No Right Turn Signage at the access to 1029 Tamarind Drive, Tintenbar and support the associated amendment to Condition 2.4(a) of the consent of DA 2004/658

6.3 Reconstruction - Martin Street, Ballina

RECOMMENDATION

The Committee supports the proposed reconfiguration of Martin Street, Ballina and associated regulatory signage and markings as shown in the attachment to this report including the addition of a NO STOPPING Zone indicated by a yellow line on the western side of Martin Street, south of Fawcett Lane.

6.4 Proposed Additional Disabled Parking Space - Off Isabella Drive, Skennars Head

RECOMMENDATION

6.5 Proposed NO STOPPING Zone Extension - Redford Drive, Skennars Head

RECOMMENDATION

The Committee supports a NO STOPPING zone indicated by yellow lines between the two driveways of No.1 and No.3 Redford Drive, Skennars Head and extension of the existing NO STOPPING yellow line from the Headlands Drive corner to within 6.5m of the No.1 Redford Drive driveway (to accommodate one car parking space) and that a transverse white line be provided at the eastern end of No.1 driveway to indicate the end of the parking bay.

6.6 Proposed Roundabout, Fox and Cherry Streets, Ballina

RECOMMENDATION

That the Committee supports the regulatory signs and markings at the proposed Fox Street/Cherry Street, Ballina roundabout as designated on the attachment to this report.

6.7 Proposed NO STOPPING Zone - Pine Avenue East Ballina

The Committee supports the provision of a NO STOPPING Zone indicated by yellow line on the north side of the grassed area at the south end of Pine Avenue, East Ballina.
