

## 6.1 <u>Business Arising from Minutes of 8 November 2023 - The Ballina</u> <u>Peninsular Residents Association - Clearing Vegetation near Burns Point</u> <u>Ferry</u>

#### Item 6.4 Clearing Vegetation near Burns Point Ferry

At the meeting Ros Felsch advised that the mangrove clearing hasn't yet commenced. Concerns were also raised in relation to the safety of the approaches and waiting areas for cyclists.

**Action:** Review of waiting areas and approach to Ferry from South Ballina to be referred to engineering Works Section for review.

#### Staff Comment

Roadside clearing/slashing has been completed on the approach to Burns Point Ferry at South Ballina. The limit of maintenance work is confined to the road shoulder along this stretch of road, and there was small vegetation growth removed from this area. The roadside clearing does not extend beyond the line of established taller vegetation beyond the edge of the road shoulder. The maintenance of this stretch of road has previously been documented with correspondence dated October 2020 with a local resident (also a previous member of the A Ward committee) as follows:

"Sight Distance - across corner of first left hand bend leaving the ferry (southbound), southern approach. As discussed at the site meeting the sight distance provided across the corner of the first left hand bend (southbound leaving the ferry) appeared to be maintained to a historic cleared line of existing taller vegetation. A check has been made of the road alignment (radius) and the distance (clearance) to the edge of the taller vegetation, and the minimum sight distance required for drivers is being achieved. Therefore there is no further requirement for removal of vegetation in this "sensitive environment.". A suggested waiting area for cyclists has been reviewed by our Road Safety Officer and ferry staff and it is considered to be a beneficial improvement. Dependent on final design, it is likely this project will require regulatory approval including a Fisheries Permit. Significant resources are required to prepare the required documentation to support the design and application for these approvals. To allocate the resources required, the works need to be included in Council's adopted program of prioritised work. To enable further consideration of the cost and priority, we have added this proposal to our works for consideration list. This means our design team will endeavour to develop some indicative design and cost options so that Council can be informed about the project.

## Item 8.7 Aboriginal Museum at Ballina Surf Life Saving Club – Room Name Meanings

The committee discussed the surf club in relation to cultural heritage and there were suggestions about improving recognition of cultural heritage within the building (e.g. display of information, explaining meaning of room names).

Matt Wood advised that separate to the surf club a keeping place for Aboriginal history has been considered by Council and a cultural facility is now identified in Council's community facilities developer contributions plan. This type of facility will be further considered as part of a partnership agreement with the Aboriginal community.

**Action:** Information to explain room name meanings at the Ballina Surf Life Surfing Club to be referred to Community Facilities Section for review.

#### Staff comment

Community facilities team will investigate available options and resourcing to accommodate this request.

#### Item 9.1 Request for Council to Remove Cut Vegetation

Michael Albany requested Council remove cut vegetation after maintenance along the roadside and open spaces. The concern is that cut vegetation is left on the ground which then flows into the drainage system when it rains.

**Action:** Concern regarding cut vegetation to be referred to Council's Open Spaces Section for review.

#### Staff comment

Given the significant scale of park and roadside vegetation management undertaken throughout the Shire, it is not practical or sustainable to collect cut material for disposal. Consistent with the practices other councils and land managers, regular mowing and frequent maintenance assists in reducing the accumulation of residual organic material.

Therese Crollick raised the need for extra security lanes due to the lengthy waiting times at Ballina Byron Gateway Airport with security screening.

#### Staff Comment

Council are not considering adding additional security lanes due to additional costs of security equipment, ongoing maintenance and additional labour costs.

Waiting times have been monitored and the peak periods are limited during the day. Council has been allocating additional staff during busy periods to the single lane and this is providing better security outcomes and reduced waiting times.

Any ongoing costs are passed on to the airlines, which potentially results in the airlines recovering costs in the ticket pricing. Any increase in the airline pricing may reduce passengers using our airport.

#### 8.5 <u>Business With Notice - Dementia Inclusive Ballina Alliance – McDonald</u> Park Signage Request

Meg Pickup requested if Council would consider "McDonald Park" be added to the Ballina Coast High School sign on the corner of Bentinck and Martin Streets Ballina? Clement Park is still identified, but since the new High School was built McDonald Park has not been identified. This is another part of Ballina's history lost.

#### Staff Comment

There aren't any name plates for Clement Park in the road reserves surrounding the park. Clement Park is signed on the boundary fence between the park and the BISC car park.

The remaining school gate post on the corner of Cherry and Bentinck Streets is a historical memorial to McDonald Park and the Clement Park gate restoration. It includes plates with detail about the people the parks were named after (refer to photographs below). As such, a request for a separate historical sign for McDonald Park wouldn't be supported or recommended by PIST.

PIST is Council's Promotional and Interpretative Signage Taskforce. PIST is responsible for assessing signage requests under relevant standards, TfNSW guidelines and Council policy or strategy.



#### Staff Comment

The pontoon at Keith Hall boat ramp had components damaged as a result of the 2022 flood, and the entire pontoon was removed for safety. Early advice was sought from the original pontoon supplier and installer, and a reconfiguration was suggested for any future replacement. The proposed reconfiguration is below and feedback is welcome.

With the above information an application for a replacement pontoon was made with TfNSW Maritime 'Boating Infrastructure Emergency Repair Pool' program. Council was notified late March 2023 of a successful grant and now has a six month period under the grant to procure and install a replacement.
