

Burns Point Ferry - Annual Slipway Maintenance

The Burns Point Ferry will be put into dry dock for major maintenance from Saturday 15 February to Friday 6 March 2020. The final ferry will run Friday night 14 February 2020, and will return to service 8am Saturday 7 March 2020.

It is necessary to put the ferry into slip to carry out major mechanical and structural repairs and give the ferry hull a sandblast and repaint. Slip dates are prearranged to coincide with suitable tides around the Wardell Bridge.

Council apologises for any inconvenience this will cause and advises road users to use the alternate route of the Pacific Highway and River Drive, Wardell.

Draft Voluntary Planning Agreement for DA 2019/123 Proposed Mixed Use Development Lot 24 Section 2 DP 11687, 74 Ballina Street, Lennox Head

Council is currently assessing Development Application 2019/123 for the construction of a mixed use development at Lot 24 DP 11687, No. 74 Ballina Street Lennox Head. Prior to the application being considered by the Council, consideration is required of a draft Voluntary Planning Agreement (VPA) proposed between the owners of the land and Council.

The draft VPA that has been prepared by the proponent who proposes the payment to Council of a monetary contribution for the deficiency of 1.43 car parking spaces (plus CPI at the date of payment when the development may take place on the land), which is not provided on the subject land for DA 2019/123.
