It is necessary to put the ferry into slip to carry out major mechanical and structural repairs and give the ferry hull a sandblast and repaint.

Slip dates are prearranged to coincide with suitable tides around the Wardell Bridge.

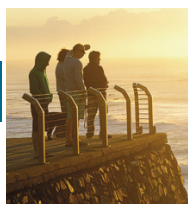
