REASONS FOR THE DECISION

- The development is permissible in the zone and the provisions of State Environmental Planning Policy 33 Hazardous and Offensive Development were comprehensively addressed.
- The Council assessment report comprehensively addressed issues identified in the Secretary's Environmental Assessment Requirements, particularly acoustic and air quality impacts.
- The Environment Protection Authority has issued General Terms of Approval.
- Amendments to conditions clarify the scope of the consent in relation to the previous consent and the required air quality monitoring.

The Northern Regional Planning Panel (NRPP) considered that the concerns raised by the community were adequately addressed in the assessment report and that no new issues requiring assessment were raised during the public meeting. The NRPP noted that in addressing these issues, amended conditions have clarified the operating requirements for the development and facilitate ongoing monitoring of the development.

Ballina Shire Development Control Plan 2012 Community Participation Plan Amendment

Council adopted the Ballina Shire Community Participation Plan (CPP) at its Ordinary Meeting on 28 November 2019. CPP associated amendments to the Ballina Shire Development Control Plan 2012 (the DCP) were also adopted at this meeting. These CPP associated amendments to the DCP take effect from 4 December 2019.

The CPP associated amendments to the DCP include the deletion of public notification and exhibition requirements of development proposals and submissions contained in sections 3.2.4 and 3.2.5 of Chapter 1 of the DCP.
