

Burns Point Ferry - Annual Slipway Maintenance

The Burns Point Ferry will be put into dry dock for its major maintenance program from Saturday 15 February to Friday 6 March 2020.

The last ferry will run Friday night 14 February 2020. The first ferry back in operation will be 8am Saturday 7 March 2020.

It is necessary to put the ferry into slip to carry out major mechanical and structural repairs, plus sandblast and repaint the hull.

The slip dates are prearranged to coincide with suitable tides around the Wardell Bridge.

The ferry will be closed to traffic during these works. Council apologises for any inconvenience this will cause. Road users are advised to use the alternate route of the Pacific Highway and River Drive, Wardell.
