Burns Point Ferry - Annual Slipway Maintenance

The Burns Point Ferry will be put into dry dock for major maintenance from **Saturday 15 February to Friday 6 March 2020**. The final ferry will run Friday night 14 February 2020, and will return to service 8am Saturday 7 March 2020.

It is necessary to put the ferry into slip to carry out major mechanical and structural repairs and give the ferry hull a sandblast and repaint. Slip dates are prearranged to coincide with suitable tides around the Wardell Bridge.

Council apologises for any inconvenience this will cause and advises road users to use the alternate route of the Pacific Highway and River Drive, Wardell.

Planned Water Outage - East Ballina

As part of a capital works program for water supply infrastructure, Council is constructing a new booster pump station at East Ballina Reservoir on Lookout Road.

As the water infrastructure from this new pump station is connected to the Shaws Bay water supply it is necessary to install isolation valves, and protect the water pipes from the effects of high water pressure in the Shaws Bay area.

The work will be carried out Thursday 30 January between 9pm and 12am.

During construction, nearby residents may be impacted by:

- no water supply
- construction related noise.

Council will make every effort to minimise disruptions. This upgrade is essential to provide a better level of water service and increase the reliability of the water supply system.

Ballina Shire Level 2 Water Restrictions

Level 2 water restrictions were introduced to Ballina Shire on 20 January and are now in place across the shire. A poor rainfall outlook coupled with high water demand over the holiday period has prompted our region's bulk water supplier, Rous County Council, to introduce level 2 water restrictions.

Level 2 water saving measures for residential urban and rural premises include:

- no watering of established lawns
- no water play tools, toys and slides
- fitting all hand-held hoses with on/off trigger nozzles
- watering established gardens is permitted with hand-held hoses for 30 minutes every second day, before 9am or after 4pm on
 odd or even days of the month to match the house numbering system. For example if you live at 11 Smith Drive, you can water
 on 1st, 3rd, 5th day of the month etc. No watering on the 31st of the month.
- topping up swimming pools is permitted before 9am or after 4pm, using a hand-held hose
- washing cars with hand-held hoses is permitted before 9am or after 4pm, on odd or even days of the month to match the house numbering system. For example if you live at 11 Smith Drive, you can water on 1st, 3rd, 5th day of the month etc. No watering on the 31st of the month.

Recycled water

Ballina Shire Council would like to remind recycled water users that water restrictions **do not** apply to your recycled water service. However, council encourages the community to still use their recycled water wisely as all water is precious. Recycled water is supplied to newer residential estates in Ballina and Lennox Head and is used to irrigate nurseries, golf courses, agriculture, parks and sporting grounds across the shire.

Ballina Local Environmental Plan 1987 Planning Proposal BSCPP 19/005 - Rural Industry Definition Change

Council has prepared a planning proposal to amend the Ballina Local Environmental Plan 1987.

The planning proposal seeks to substitute the definition of rural industry applicable to Ballina LEP 1987 with the definition of rural industry contained within the Standard Instrument – Principal Local Environmental Plan.

The planning proposal (BSCPP 19/005) will be on public exhibition between Wednesday 22 January 2020 and Friday 21 February 2020 at:

- Council's Customer Service Centre between 8.30am and 4.30pm Monday to Friday (excluding public holidays).
- Community Access Points and on Council's website (ballina.nsw.gov.au search Documents on Exhibition').

Council has been authorised as the local plan-making authority and has been given delegation by the Department of Planning, Industry and Environment to make or not make the local environmental plan (s3.36(2) of the *Environmental Planning and Assessment Act*).
