Bangalow Road/Angels Beach Drive Roundabout - Proposed Works

Ballina Shire Council is inviting community feedback on the proposed improvement works surrounding the Bangalow Road/Angels Beach roundabout, Ballina.

The proposed works include:

- Construction of dual lanes on Bangalow Road between Kerr Street and Angels Beach Drive (separated by a central concrete median).
- A new central median on Bangalow Road will mean the Bangalow Road/Clark Street intersection will become left in/left out only (no right turn).
- Providing extended, median separated, dual lead in/lead out lanes for the Bangalow Road/Angels Beach Drive roundabout northwards on Angels Beach Drive (past Sheather Street) and eastwards on Bangalow Road (to near Moon Street).
- Extending Sheather Street to intersect with Angels Beach Drive to provide a left in/left out intersection.

Following feedback from the community, Council will start on the final design and seek the relevant approvals. The timing of construction is not confirmed, but Council anticipates it will begin in the 2021/2022 or 2022/2023 financial years.
